

4	Subject: Elections; miscellaneous changes
5	Statement of purpose of bill as introduced: This bill proposes to prohibit
6	losing primary candidates from running in the general election, permit political
7	parties to accept not more than \$100,000.00 in contributions from candidates,
8	require the reporting of town and county committee members after the biennial
9	reorganization of the State committee of a party, set the order of nominee
10	parties printed on ballots, permit candidates to file demographic information,
11	require write-in candidates to meet a minimum threshold to win primary
12	elections, and to enable electronic ballot returns to be made via online portal.

14	It is hereby enacted by the General Assembly of the State of Vermont:

17	(c) In no event shall a candidate who loses a major party primary be

2	appeared on the primary ballot.

5	(a) A person may be nominated and have his or her the person's name
6	printed on the general election ballot for any office by filing a consent similar
7	in form to the consent prescribed by section 2361 of this title and a statement
8	of nomination with the Secretary of State. In the case of a nomination for
9	justice of the peace, the consent form and statement of nomination shall be
10	filed with the town clerk.
11	(b) A candidate who loses a major party primary for any office shall not
12	appear on the general election ballot as an independent candidate for the same
13	office for which the candidate lost in the primary election.

(A)(i) \$10,000.00 from a single source;

(B)(ii) \$10,000.00 from a political committee; or

(*C*)(*iii*) \$60,000.00 from a political party.

(B) Notwithstanding subdivision (A) of this subdivision (5), a political party may accept not more than \$60,000.00 from a candidate for State office.

14	be a candidate. The nominee shall notify in writing the Secretary of State or
15	town clerk, as the case may be, of such choice by that deadline, and only the
16	party or parties that the nominee so elects shall be printed next to the
17	nominee's name on the ballot.

19	clerk of his or her choice of party a nominee is nominated by more than one
20	party, the Secretary of State shall print on the ballot those parties next to the

13	(b)(1) A candidate for State office who is the nominee of two or more
14	political parties shall file with the Secretary of State, not ater than 5:00 p.m.
15	the tenth 10th day following the primary election, a statement designating for
16	which party the votes cast for him or her the candidate shall be counted for the
17	purposes of determining whether his or her the candidate's designated party
18	shall be a major political party. The party so designated shall be the first party
19	to be primed immediately after the candidate's name on the ballot.

(2) If a condidate does not file the statement by that deadline, the
Secretary of State shall designate the party for which the votes cast shall be
counted as provided in subdivision $(a)(2)$ of this section.

§ 2359. NOTIFICATION TO SECRETARY OF STATE
(a) Within three days after the last day for filing petitions, all town and
county clerks who have received petitions shall notify file with the Secretary
of State of the names of all candidates, a list containing the name, gender, age,
race or ethnicity, mailing address, and e-mail address of all candidates, to the
extent this information is provided by candidates; the offices for which they
the candidates have filed; and whether each candidate has submitted a
sufficient number of valid signatures to comply with the requirements of
section 2355 of this title. Town and county clerks shall also notify the
Secretary of State of any petitions found not to conform to the requirements of
this chapter and returned to a candidate under section 2358 of this title, and
shall notify the Secretary of State of the status of such petition petitions not
later than two days after the last day for filing supplementary petitions.
(b) In any listing of candidate information collected pursuant to subsection
(a) of this section, the Secretary of State shall not publish information

4	(b)(1) The consent shall set forth the name of the candidate, candidate's
5	name as the candidate wishes to have it printed on the ballot, the candidate's
6	gender, age, or race or ethnicity, town of residence, and correct mailing
7	address, and e-mail address. A candidate who does not provide information
8	pertaining to gender, age, or race or ethnicity may still appear on the ballot if
9	all other requirements are met.

4	(a) A write-in candidate shall not qualify as a primary winner unless he or
5	she the candidate receives at least one-half the higher of:

7	(2) the same number of votes as the number of signatures required for
8	his or her the candidate's office on a primary petition, except that if a write-in
9	candidate receives more votes than a candidate whose name is printed on the
10	ballot, he or she may the write-in candidate shall qualify as a primary winner.
11	(b) The write-in candidate who qualifies as a primary winner under this
12	section must still be determined a winner under section 2369 of this chapter

18	(a) There shall be printed on the face of the envelope provided for use in
19	returning early voter absentee ballots, or provided in an electronic format if a
20	ballot is electronically delivered pursuant to subsection 2539(b) or (c) of this
21	title, a certificate in substantially the following form:

1	"Early or Absentee Voter Ballots of"
2	(print your name)
3	I,, solemnly swear or affirm that I am a resident of the town
4	(city) of, State of Vermont, and that I am a legal voter in this town
5	(city).

8	(b) The early or absentee voter, except a voter receiving a ballot
9	electronically delivered pursuant to subsection 2539(b) or (c) of this title,
10	must sign the certificate on the outside of the envelope in order for the ballot
11	to be valid. When an early or absentee voter is physically unable to sign his or
12	her the voter's name, he or she the voter may mark an "X" or take an oath
13	swearing or affirming to the statement on the certificate. The officers who
14	deliver the ballots shall witness the mark or oath and sign their names with a
15	statement attesting to this fact on the envelope.

19	(d)(1) All early voter absentee ballots returned as follows shall be counted:
20	(A) by any means, to the town clerk's office before the close of

2	which the voter is registered pursuant to section 2543a of this subchapter
3	before the close of business on the day before the election;
4	(C) by mail to the town clerk's office before the close of the polls on

8	(2)(A) All ballots electronically delivered pursuant to subsection

11	by the Secretary of State, directly to the clerk before the close of business on
12	the last day the clerk's office is open prior to the election; and
13	(ii) with electronic signature on the certificate required pursuant to
14	section 2542 of this title prior to submitting the ballot to the clerk.
15	(B) A ballot electronically delivered pursuant to subsection 2539(b)
16	or (c) of this title and then returned pursuant to subdivision (A) of this
17	subdivision (d)(2) shall be printed by the clerk and processed in the same
18	manner as all other early or absentee ballots and in accordance with the
19	procedures prescribed by this subchapter.
20	(C) The voter shall be notified when a ballot electronically delivered
21	pursuant to subsection 2539(b) or (c) of this title and then returned pursuant to

8	This act shall take effect on July 1, 2023.
