7	(a) The board may abate in whole or part taxes, water charges, sewer
8	charges, interest, or collection fees, or any other municipal charges or fees for
9	utilities or services, or any combination of those, other than those arising out of
10	a corrected classification of homestead or nonhomestead property, accruing to
11	the town in the following cases:
12	(1) taxes or charges of persons who have died insolvent;
13	(2) taxes or charges of persons who have moved from the State;
14	(3) taxes or charges of persons who are unable to pay their taxes or
15	charges, interest, and collection fees;
16	(4) taxes in which there is manifest a clear or obvious error or a mistake
17	of the listers;
18	(5) taxes or charges upon real or personal property lost or destroyed
19	during the tax year;
20	(6) the exemption amount available under 32 V.S.A. § 3802(11) to
21	persons otherwise eligible for exemption who file a claim on or after May 1

15	or collection fees accruing to the town or denies an application for abatement,
16	state in detail in writing the reasons for its decision. The written decision shall
17	provide sufficient explanation to indicate to the parties what was considered
18	and what was decided. The decision shall address the arguments raised by the
19	applicant. Prior to issuing a written decision, the board may request additional
20	relevant information or documentation related to the case.

1	(d)(1) The board may order that any abatement as to an amount or amounts
2	already paid be in the form of a refund or in the form of a credit against the tax
3	or charge for the next ensuing tax year or charge billing cycle and for
4	succeeding tax years or billing cycles if required to use up the amount of the
5	credit.
6	(2) Whenever a municipality votes to collect interest on overdue taxes
7	pursuant to 32 V.S.A. § 5136, interest in a like amount shall be paid by the
8	municipality to any person for whom an abatement has been ordered.
9	(3) Interest on taxes or charges paid and subsequently abated shall
10	accrue from the date payment was due or made, whichever is later. However,
11	abatements issued pursuant to subdivision (a)(5) of this section need not
12	include the payment of interest.
13	(4) When a refund has been ordered, the board shall draw an order on
14	the town treasurer for payment of the refund.
15	(e)(1) The board may hear a group of similar requests for abatement as a
16	class, provided that:
17	(A) the board has first met and established a class in accordance with
18	this subsection (e);
19	(B) the requests shall arise from the same cause or event;
20	(C) the requests relate to the bases for abatement in subdivision
21	(a)(4), (5), or (9) of this section;

1	(D) the board shall group requests based on property classification;
2	(E) the board shall provide notice to each taxpayer of the taxpayer's
3	status as a member of the class; and
4	(F) a taxpayer shall have the right to decline the taxpayer's status as a
5	member of the class and pursue the taxpayer's request as a separate action
6	before the board.
7	(2) The board shall provide notice to each taxpayer at minimum 21 days
8	before the scheduled hearing for the class. The notice shall include a
9	description of the class and the board's reasons for grouping the requests, an
10	explanation of the taxpayer's status as a member of the class, the procedure for
11	appealing a board decision, the taxpayer's right to decline class membership
12	and pursue a separate action, and any deadlines that the taxpayer must meet in
13	order to participate as a member of the class or pursue a separate action.
14	(3) A taxpayer shall notify the board of the taxpayer's intent to pursue a
15	separate action, pursuant to subdivision (1)(F) of this subsection, a minimum
16	of seven days before the board's hearing to consider a class request.
17	(4) A board may preserve and take notice of any evidence supporting
18	the basis for abatement for a class and use that evidence for purposes of a later,
19	separate action pursued by an individual taxpayer.

1	(5) In instances where a board abates in part taxes, charges, interest, or
2	collection fees for a class, the board shall not render a decision that results in
3	disproportionate rates of abatement for taxpayers within the class.
4	(f) A municipality shall provide clear notice to a taxpayer of the ability to
5	request tax abatement, and how to request abatement, at the same time as a
6	municipality attempts to collect a municipal fee or interest for delinquent taxes,
7	water charges, sewer charges, or tax collection.
8	(g) The legislative body of a municipality by a majority vote may abate de
9	minimis amounts of taxes for purposes of reconciling municipal accounts
10	according to generally accepted accounting principles.

- (a) When the owner, lien holder, or mortgagee of lands sold for taxes, his or her the owner's, lien holder's, or mortgagee's representatives or assigns, within one year from the day of sale, pays or tenders to the collector who made the sale or in the case of his or her the collector's death or removal from the town where the land lies, to the town clerk of such town, the sum for which the land was sold with interest thereon calculated at a rate of one percent per month or fraction thereof from the day of sale to the day of payment, a deed of the land shall not be made to the purchaser, but the money paid or tendered by the owner, lien holder, or mortgagee or his or her the owner's, lien holder's, or mortgagee's representatives or assigns to the collector or town clerk shall be paid over to such purchaser on demand. 6	(a) Creation. There is created the Working Group on Vermont's
7	Abatement and Tax Sale Processes to assess how Vermont may balance
8	fairness for delinquent taxpayers with the needs of municipalities.
9	(b) Membership. The Working Group shall be composed of the following
10	members:
11	(1) a representative, appointed by Vermont Legal Aid;
12	(2) a representative, appointed by the Vermont League of Cities and
13	Towns;
14	(3) a representative, appointed by the Vermont Banker's Association;
15	(4) a representative, appointed by the Vermont Housing Finance
16	Agency:
17	(5) a representative, appointed by the Vermont Municipal Clerk's and
18	Treasurer's Associations;
19	(6) a representative, appointed by the Neighborworks Alliance of
20	Vermont;

1	(7) a representative, appointed by the Champlain Valley Office of
2	Economic Opportunity Mobile Home Project;
3	(8) a representative, appointed by the Vermont Assessors and Listers
4	Association; and
5	(9) a representative, appointed by the Vermont Bar Association, with
6	experience practicing real estate law.
7	(c) Powers and duties. The Working Group shall offer recommendations
8	relating to the following:
9	(1) whether the State should change the law to allow a delinquent
10	taxpayer whose property is transferred by a tax collector's deed, or a tax-lien
11	foreclosure sale, to recoup all or part of the equity in the taxpayer's property in
12	excess of the tax debt, fees, and interest for which the taxpayer's property is
13	sold;
14	(2) whether further changes are needed to standardize the abatement
15	process across Vermont municipalities;
16	(3) whether the State should require a minimum amount of tax debt
17	before a tax sale can be initiated;
18	(4) whether the State should allow a tax sale to be initiated for blighted
19	or dilapidated real estate that has been abandoned when taxes are delinquent
20	for less than one year;

1	(5) a reasonable percent rate of monthly interest paid by delinquent
2	taxpayers during the redemption period;
3	(6) whether the purchaser of a property at a tax sale should be allowed
4	to secure the property against illegal activity, damage from exposure to the
5	elements, deterioration, and potential fire prior to acquiring title to the
6	property; and
7	(7) a process for statewide collection of data relating to tax sales,
8	including to whom the data could be reported, the values of properties sold at
9	tax sales, the amounts and types of debts underlying tax sales, and descriptive
10	data for properties subject to tax sales.
11	(d) Report. On or before December 15, 2024, the Working Group shall
12	submit a written report to the House Committee on Ways and Means, House
13	Committee on Government Operations and Military Affairs, Senate Committee
14	on Finance, and Senate Committee on Government Operations with its
15	findings and any recommendations for legislative action, including proposed
16	legislative language.
17	(e) Compensation. Members shall not be compensated for participation in
18	the Working Group.
19	(f) Meetings.
20	(1) The representative appointed by Vermont Legal Aid shall call the
21	first meeting of the Working Group to occur on or before August 1, 2024.
