4	The Senate proposes to the House to amend the bill as follows:
5	First: In Sec. 10, 32 V.S.A. § 3602b, by striking out subsection (c) in its
6	entirety and inserting in lieu thereof a new subsection (c) to read as follows:
7	(c) As used in this section, "communications property" means tangible
8	personal property used to enable the real-time, two-way, electromagnetic
9	transmission of information, such as audio, video, and data, that is so fitted and
10	attached as to be part of a local, state, national, or international
11	communications network, as well as facilities that are part of a cable television
12	system as defined in 30 V.S.A. § 501(2). The term includes wires, cables,
13	conduit, pipes, antennas, poles, and wireless towers.
14	Second: By striking out Sec. 13a, 19 V.S.A. § 26a, and its reader assistance
15	heading in their entireties and inserting in lieu thereof a reader assistance
16	heading and a new section to be Sec. 14 to read as follows:

18	Sec. 14. STUDY; COMMUNICATIONS INFRASTRUCTURE;
19	RIGHT-OF-WAY
20	(a) The Secretary of Transportation, in consultation with the Commissioner
21	of Public Service and the Secretary of Digital Services, shall conduct a study

1	concerning access to and use of the public right-of-way (ROW) in Vermont by
2	telephone (wired and wireless) and broadband companies. In particular, the
3	Secretary shall determine how the ROW is currently being accessed and used
4	by such companies in Vermont and, in addition, shall review and assess how
5	other jurisdictions outside Vermont manage and charge for such access and
6	<u>use.</u>
7	(b) As used in this section, "public right-of-way" means the area on, below,
8	along, across, or above a public roadway that is part of the State highway
9	system.
10	(c) On or before October 15, 2025, the Secretary shall submit a written
11	report of the Secretary's findings and recommendations to the Senate
12	Committees on Finance and on Transportation and the House Committees on
13	Ways and Means, on Transportation, and on Environment and Energy.
14	Third: By striking out Sec. 14, effective dates, in its entirety and inserting
15	in lieu thereof a new section to be Sec. 15 to read as follows:
16	Sec. 15. EFFECTIVE DATES
17	This act shall take effect on passage, except that:
18	(1) Sec. 13 (PILOT Fund appropriation) shall take effect on July 1,
19	<u>2024.</u>
20	(2) Secs. 1–6 (VUSF contribution method; 988 funding) shall take effect
21	<u>on July 1, 2025.</u>

- 1 (3) Secs. 8–12 (communications property tax) shall take effect on July 1,
- 2 <u>2025 and shall apply to grand lists lodged on or after April 1, 2025.</u>
