13	Sec. 1. CHARTER ADOPTION APPROVAL
14	The General Assembly approves the adoption of the charter of the Town of
15	Waterbury as set forth in this act. The voters approved the charter proposal on
16	December 5, 2023.
17	Sec. 2. 24 App. V.S.A. chapter 159 is added to read:
18	CHAPTER 159. TOWN OF WATERBURY
19	§ 1. LOCAL OPTION TAX

The Town Selectboard is authorized to levy a one percent tax on sales,
meals and alcoholic beverages, and rooms. *A tax imposed under the authority* 

of this section shall be collected and administered by the Department of Taxes

pursuant to 24 V.S.A. § 138.
