6	§ 601. DEFINITIONS
7	Unless the context otherwise requires, words and phrases used in this
8	chapter shall be construed as follows As used in this chapter:

10	(11) "Personal injury by accident arising out of and in the course of
11	employment" includes an injury caused by the willful act of a third person
12	directed against an employee because of that employment.

14	(E) In the case of a firefighter, as defined in 20 V.S.A. § 3151(3) and
15	(4), who dies or has a disability from a cancer listed in subdivision (iii) of this
16	subdivision (E), the firefighter shall be presumed to have had the cancer as a
17	result of exposure to conditions in the line of duty, unless it is shown by a
18	preponderance of the evidence that the cancer was caused by nonservice-
19	connected risk factors or nonservice-connected exposure, provided:
20	(i)(I) the firefighter completed an initial and any subsequent
21	cancer screening evaluations as recommended by the American Cancer Society
22	based on the age and sex of the firefighter prior to becoming a firefighter or

1	within two years of July 1, 2007 while serving as a firefighter, and the
2	evaluation indicated no evidence of cancer;
3	(II) the firefighter was engaged in firefighting duties or other
4	hazardous activities over a period of at least five years in Vermont prior to the
5	diagnosis; and
6	(III) the firefighter is under 65 years of age.
7	(ii) The presumption shall not apply to any firefighter who has
8	used tobacco products at any time within 10 years of the date of diagnosis.
9	(iii) The disabling cancer shall be limited to leukemia, lymphoma,
10	or multiple myeloma, and cancers originating in the bladder, brain, breast,
11	colon, gastrointestinal tract, kidney, liver, lung, pancreas, reproductive system.
12	skin, or testicles <u>thyroid</u> .
13	(F) A firefighter who is diagnosed with cancer within 10 years of the
14	last active date of employment as a firefighter shall be eligible for benefits
15	under this subdivision. The date of injury shall be the date of the last injurious
16	exposure as a firefighter.
17	(G) It is recommended that fire departments:
18	(i) maintain incident report records for at least 10 years; and
19	(ii) offer or provide annual cancer screenings to all firefighters
20	who are employed by or who volunteer for the department.

1	Sec. 2. ANNUAL CANCER SCREENINGS; PERSONAL PROTECTIVE
2	EQUIPMENT UPGRADES; REPORT
3	(a) On or before January 15, 2024, the Director of the Division of Fire
4	Safety shall submit a written report to the House Committees on
5	Appropriations, on Commerce and Economic Development, and on
6	Government Operations and Military Affairs and the Senate Committees on
7	Appropriations; on Economic Development, Housing and General Affairs; and
8	on Government Operations regarding the following topics:
9	(1) the projected cost for the State to fund annual or biennial cancer
10	screenings for all career and volunteer firefighters in Vermont;
11	(2) the projected cost for the State to fund cancer screenings for all
12	enrollees in the Vermont Fire Academy Firefighter I certification program
13	prior to the commencement of training;
14	(3) potential opportunities for the State to reduce the cost for fire
15	departments to provide annual cancer screenings for their firefighters;
16	(4) the projected cost for the State to fund the replacement of personal
17	protective equipment for all volunteer and career firefighters on a rolling basis
18	so that all personal protective equipment is replaced within 10 years after being
19	acquired; and
20	(5) potential opportunities for the State to reduce the cost to fire
21	departments for the replacement of personal protective equipment.

1	(b) The report may include recommendations for legislative action to
2	facilitate:
3	(1) the early identification of cancer in firefighters;
4	(2) the acquisition of personal protective equipment by fire departments;

6	(3) the elimination of PFAS and other carcinogens in firefighting

8	Sec. 3. WORKERS' COMPENSATION FOR FIREFIGHTERS WITH
9	CANCER; ELIGIBILITY; REPORT
10	(a) On or before January 15, 2024, the Commissioners of Labor and of
11	Financial Regulation, in consultation with the Director of the Division of Fire
12	Safety, shall submit a written report to the House Committee on Commerce
13	and Economic Development and the Senate Committee on Economic
14	Development, Housing and General Affairs regarding the following topics:
15	(1) the potential impacts on workers' compensation claims, premiums,
16	and loss costs of amending or repealing the provisions of 21 V.S.A.
17	§ 601(11)(E) that bar a firefighter from the presumption that the firefighter's
18	cancer resulted from work-related exposure if the firefighter:
19	(A) is over 65 years of age; or
20	(B) has used tobacco products within the last 10 years;

1	(2) the potential impacts on workers' compensation claims, premiums,
2	and loss costs of amending 21 V.S.A. § 601(11)(E)(iii) to expand the list of
3	cancers presumed to have been caused by exposure to working conditions as a
4	firefighter, including:
5	(A) additional types of cancer:
6	(i) that occur more frequently in firefighters than the general
7	public;
8	(ii) that are caused by carcinogens to which firefighters are
9	exposed in the line of duty; or
10	(iii) both; or

12	(3) potential methods for apportioning liability for workers'
