4	First: By adding Secs. 6a and 6b to read as follows:
5	Sec. 6a. USE OF VERMONT ENVIRONMENTAL PROTECTION
6	AGENCY (EPA) POLLUTION CONTROL REVOLVING FUND
7	Notwithstanding the authority of the Secretary of Natural Resources under
8	24 V.S.A. § 4753 to transfer up to \$275,000.00 from the Vermont EPA
9	Pollution Control Revolving Fund to the Vermont Wastewater and Potable
10	Water Revolving Fund, the Secretary of Natural Resources shall not transfer
11	any funds from the EPA Pollution Control Revolving Fund to the Vermont

13	(1) the Secretary of Natural Resources submits the comprehensive fee

1	Sec. 6b. ANR REPORT ON REVOLVING LOAN FUNDS
2	On or before January 15, 2024, the Secretary of Natural Resources shall
3	submit to the House Committee on Corrections and Institutions and the Senate
4	Committee on Institutions a report summarizing the status of the Vermont
5	Environmental Protection Agency (EPA) Pollution Control Revolving Fund
6	and the Vermont Environmental Protection Agency (EPA) Drinking Water
7	State Revolving Fund. The report shall include an accounting of the Funds,
8	including the following information for each Fund as it existed at the end of
9	fiscal year 2023:
10	(1) the balance of funds in the Fund;
11	(2) the amount of funds loaned or obligated from the Fund;
12	(3) the amount of funds repaid to the Fund in fiscal year 2023; and
13	(4) the amount of funds due for repayment to the Fund.
14	Second: By striking out Sec. 7, 2018 Acts and Resolves No. 185, Sec. 12,
15	in its entirety and inserting in lieu thereof a new Sec. 7 and reader assistance
16	heading to read as follows:

18	Sec. 7. ANR REPORT ON RIPARIAN PROTECTION PROGRAM
19	The Secretary of Natural Resources shall conduct a stakeholder process to
20	develop recommendations on the implementation of a riparian protection
21	program in the State. The stakeholder process shall address what elements of a

- 2 and aquatic habitat and what funding would be required to implement a
