4	care rider to a life insurance policy or annuity contract shall be considered the

15	(7) "Commissioner" means the Commissioner of Financial Regulation.
16	(8) "Contractual obligation" means any obligation under a policy or
17	contract, or certificate under a group policy or contract, or portion thereof, for
18	which coverage is provided under section 4173 of this chapter.
19	(9) "Covered contract" or "covered policy" means a policy or contract,
20	or portion of a policy or contract, for which coverage is provided under section

4173 of this chapter.

1	(10) "Extra-contractual claims" includes, for example, claims relating to
2	bad faith in the payment of claims, punitive or exemplary damages, or
3	attorneys' fees and costs.
4	(11) "Health benefit plan" means any hospital or medical expense policy
5	or certificate, or health maintenance organization subscriber contract, or any
6	other similar health contract. "Health benefit plan" does not include:
7	(A) accident only insurance:
8	(B) credit insurance;
9	(C) dental only insurance;
10	(D) vision only insurance;
11	(E) Medicare Supplement insurance;
12	(F) benefits for long-term care, home health care, community-based
13	care, or any combination thereof;
14	(G) disability income insurance;
15	(H) coverage for on-site medical clinics; or
16	(I) specified disease, hospital confinement indemnity, or limited
17	benefit health insurance if the types of coverage do not provide coordination of
18	benefits and are provided under separate policies or certificates.
19	(12) "Impaired insurer" means a member insurer that, after the effective
20	date of this chapter, is not an insolvent insurer and who is placed under an
21	order of rehabilitation or conservation by a court of competent jurisdiction.

1	(13) "Insolvent insurer" means a member insurer that, after the effective
2	date of this chapter, is placed under an order of liquidation by a court of
3	competent jurisdiction with a finding of insolvency.
4	(14) "Member insurer" means any insurer or health maintenance
5	organization licensed or that holds a certificate of authority to transact in this
6	State any kind of insurance or health maintenance organization business for
7	which coverage is provided under section 4173 of this chapter and includes an
8	insurer or health maintenance organization whose license or certificate of
9	authority in this State may have been suspended, revoked, not renewed, or
10	voluntarily withdrawn, but does not include:
11	(A) a hospital or medical service organization, whether for-profit or
12	nonprofit;
13	(B) a fraternal benefit society;
14	(C) a mandatory State pooling plan;
15	(D) a mutual assessment company or other person that operates on an
16	assessment basis;
17	(E) an insurance exchange;
18	(F) an organization that has a certificate or license limited to the
19	issuance of charitable gift annuities under section 3718a of this title; or
20	(G) an entity similar to any of the above.

1	(15) "Moody's Corporate Bond Yield Average" means the Monthly
2	Average Corporates as published by Moody's Investors Service, Inc., or any
3	successor thereto.
4	(16) "Owner" of a policy or contract and "policyholder," "policy
5	owner," and "contract owner" mean the person who is identified as the legal
6	owner under the terms of the policy or contract or who is otherwise vested
7	with legal title to the policy or contract through a valid assignment completed
8	in accordance with the terms of the policy or contract and properly recorded as
9	the owner on the books of the member insurer. The terms owner, contract
10	owner, policyholder, and policy owner do not include persons with a mere
11	beneficial interest in a policy or contract.
12	(17) "Person" means any individual, corporation, limited liability
13	company, partnership, association, governmental body or entity, or voluntary
14	organization.
15	(18) "Plan sponsor" means:
16	(A) the employer in the case of a benefit plan established or
17	maintained by a single employer;
18	(B) the employee organization in the case of a benefit plan
19	established or maintained by an employee organization; or
20	(C) in the case of a benefit plan established or maintained by two or
21	more employers or jointly by one or more employers and one or more

1	employee organizations, the association, committee, joint board of trustees, or
2	other similar group of representatives of the parties who establish or maintain
3	the benefit plan.
4	(19) "Premiums" mean amounts or considerations, by whatever name
5	called, received on covered policies or contracts, less returned premiums,
6	considerations, and deposits, and less dividends and experience credits.
7	"Premiums" does not include amounts or considerations received for policies
8	or contracts or for the portions of any policies or contracts for which coverage
9	is not provided under subsection 4173(b) of this chapter except that assessable
10	premium shall not be reduced on account of subdivision 4173(b)(2)(C) of this
11	chapter, relating to interest limitations, and of subdivision 4173(c)(2) of this
12	chapter, relating to limitations with respect to one individual, one participant,
13	and one policy or contract owner. "Premiums" shall not include:
14	(A) premiums in excess of \$5,000,000.00 on an unallocated annuity
15	contract not issued under a governmental retirement benefit plan, or its trustee,
16	established under 26 U.S.C. § 401, 403(b), or 457 of the U.S. Internal Revenue
17	Code; or
18	(B) with respect to multiple nongroup policies of life insurance
19	owned by one owner, whether the policy or contract owner is an individual,
20	firm, corporation, or other person, and whether the persons insured are
21	officers, managers, employees, or other persons, premiums in excess of

1	\$5,000,000.00 with respect to these policies or contracts, regardless of the
2	number of policies or contracts held by the owner.
3	(20)(A) "Principal place of business" of a plan sponsor or a person other
4	than a natural person means the single state in which the natural persons who
5	establish policy for the direction, control, and coordination of the operations of
6	the entity as a whole primarily exercise that function, determined by the
7	Association in its reasonable judgment by considering the following factors:
8	(i) the state in which the primary executive and administrative
9	headquarters of the entity is located;
10	(ii) the state in which the principal office of the chief executive
11	officer of the entity is located;
12	(iii) the state in which the board of directors, or similar governing
13	person or persons, of the entity conducts the majority of its meetings;
14	(iv) the state in which the executive or management committee of
15	the board of directors, or similar governing person or persons, of the entity
16	conducts the majority of its meetings;
17	(v) the state from which the management of the overall operations
18	of the entity is directed; and
19	(vi) in the case of a benefit plan sponsored by affiliated companies
20	comprising a consolidated corporation, the state in which the holding company

1	or controlling affiliate has its principal place of business as determined using
2	the above factors;
3	(vii) however, in the case of a plan sponsor, if more than 50
4	percent of the participants in the benefit plan are employed in a single state,
5	that state shall be deemed to be the principal place of business of the plan
6	sponsor.
7	(B) The principal place of business of a plan sponsor of a benefit
8	plan described in subdivision (18)(C) of this section shall be deemed to be the
9	principal place of business of the association, committee, joint board of
10	trustees, or other similar group of representatives of the parties who establish
11	or maintain the benefit plan that, in lieu of a specific or clear designation of a
12	principal place of business, shall be deemed to be the principal place of
13	business of the employer or employee organization that has the largest
14	investment in the benefit plan in question.
15	(21) "Receivership court" means the court in the insolvent or impaired
16	insurer's state having jurisdiction over the conservation, rehabilitation, or
17	liquidation of the member insurer.
18	(22) "Resident" means any person to whom a contractual obligation is
19	owed and who resides in Vermont on the date of entry of a court order that
20	determines a member insurer to be an impaired insurer or a court order that
21	determines a member insurer to be an insolvent insurer, whichever occurs first

1	A person may be a resident of only one state, which in the case of a person
2	other than a natural person shall be that state where it has its principal place of
3	business. Citizens of the United States who are either residents of foreign
4	countries or residents of United States possessions, territories, or protectorates
5	that do not have an association similar to the Association created by this
6	chapter shall be deemed residents of the state of domicile of the member
7	insurer that issued the policies or contracts.
8	(23) "Structured settlement annuity" means an annuity purchased in
9	order to fund periodic payments for a plaintiff or other claimant in payment for
10	or with respect to personal injury suffered by the plaintiff or other claimant.
11	(24) "State" means a state, the District of Columbia, Puerto Rico, and a
12	U. S. possession, territory, or protectorate.
13	(25) "Supplemental contract" means a written agreement entered into
14	for the distribution of proceeds under a life, health, or annuity policy or
15	contract.
16	(26) "Unallocated annuity contract" means any annuity contract or
17	group annuity certificate that is not issued to and owned by an individual
18	except to the extent of any annuity benefits guaranteed to an individual by an
19	insurer under such contract or certificate.

§ 4176. CREATION OF THE ASSOCIATION

1	(a) There is created a nonprofit legal entity to be known as the Vermont
2	Life and Health Insurance Guaranty Association. All member insurers shall be
3	and remain members of the Association as a condition of their authority to
4	transact insurance or health maintenance organization business in Vermont.
5	The Association shall perform its functions under the plan of operation
6	established and approved under section 4180 of this chapter and shall exercise
7	its powers through a board of directors established under section 4177 of this
8	chapter. For purposes of administration and assessment, the Association shall
9	maintain two accounts:
10	(1) The life insurance and annuity account that includes the following
11	subaccounts;
12	(A) life insurance account;
13	(B) annuity account, which shall include annuity contracts owned by
14	a governmental retirement plan, or its trustee, established under section 401,
15	403(b), or 457 of the U.S. Internal Revenue Code, but shall otherwise exclude
16	unallocated annuities; and
17	(C) unallocated annuity account, which shall exclude contracts
18	owned by a governmental retirement plan, or its trustee, established under
19	section 401, 403(b), or 457 of the U.S. Internal Revenue Code.
20	(2) The health account.

(b) The Association shall come under the immediate supervision of the

	•
2	Commissioner and shall be subject to the applicable provisions of the
3	insurance laws of this State. Meetings and records of the Association may
4	be opened to the public upon majority vote of the Board of Directors of the
5	Association.
6	§ 4177. BOARD OF DIRECTORS
7	(a) The Board of Directors of the Association shall consist of not less than
8	seven nor more than 11 member insurers serving terms as established in the
9	plan of operation. Members of the Board shall be selected by member insurers
10	subject to the approval of the Commissioner. A vacancy on the Board shall be
11	filled for the remaining period of the term by a majority vote of the remaining
12	board members, for member insurers subject to the approval of the
13	Commissioner. To select the initial Board of Directors, and initially organize
14	the Association, the Commissioner shall give notice to all member insurers of
15	the time and place of the organizational meeting. In determining voting rights
16	at the organizational meeting, each member insurer shall be entitled to one
17	vote in person or by proxy. If the Board of Directors is not selected within 60
18	days after notice of the organizational meeting, the Commissioner may appoint
19	the initial insurer members. At least one of the directors shall be a person who
20	is an officer, director, or employee of an insurance company incorporated
21	under the laws of this State; provided, however, this provision shall not apply

1	in the event there is no member insurer incorporated under the laws of this
2	State.
3	(b) In approving selections or in appointing members to the Board, the
4	Commissioner shall consider, among other things, whether all member insurers
5	are fairly represented.
6	(c) Members of the Board may be reimbursed from the assets of the
7	Association for expenses incurred by them as members of the Board of
8	Directors, but members of the Board shall not otherwise be compensated by
9	the Association for their services.
10	§ 4178. POWERS AND DUTIES OF THE ASSOCIATION
11	(a) If a member insurer is an impaired insurer, the Association may, in its
12	discretion and subject to any conditions imposed by the Association that do not
13	impair the contractual obligations of the impaired insurer and that are
14	approved by the Commissioner:
15	(1) guarantee, assume, or reissue, reinsure, or cause to be guaranteed,
16	assumed, reissued, or reinsured, any or all of the policies or contracts of the
17	impaired insurer; or
18	(2) provide such monies, pledges, loans, notes, guarantees, or other
19	means as are proper to effectuate subdivision (1) of this subsection and ensure
20	payment of the contractual obligations of the impaired insurer pending action
21	under subdivision (1) of this subsection.

1	(b) If a member insurer is an insolvent insurer, the Association, in its
2	discretion, shall either:
3	(1)(A)(i) guarantee, assume, or reissue, reinsure, or cause to be
4	guaranteed, assumed, reissued, or reinsured, the policies or contracts of the
5	insolvent insurer; or
6	(ii) ensure payment of the contractual obligations of the insolvent
7	insurer; and
8	(B) provide monies, pledges, loans, notes, guarantees, or other means
9	reasonably necessary to discharge the Association's duties; or
10	(2) provide benefits and coverages in accordance with the following
11	provisions:
12	(A) With respect to policies and contracts, ensure payment of
13	benefits that would have been payable under the policies or contracts of the
14	insolvent insurer, for claims incurred:
15	(i) with respect to group policies and contracts, not later than the
16	earlier of the next renewal date under those policies or contracts or 45 days,
17	but in no event less than 30 days, after the date on which the Association
18	becomes obligated with respect to the policies and contracts;
19	(ii) with respect to nongroup policies, contracts, and annuities, not
20	later than the earlier of the next renewal date, if any, under the policies or

contracts	or one	year,	but in	no	event	less	<u>than</u>	30	<u>days,</u>	from	the	date	on	<u>which</u>
the Assoc	ciation l	oecon	nes ob	liga	ited w	ith re	espec	t to	the p	olicie	s or	cont	ract	ts.

(B) Make diligent efforts to provide all known insureds, enrollees, or annuitants, for nongroup policies and contracts, or group policy or contract owners with respect to group policies and contracts, 30 days' notice of the termination, pursuant to subdivision (2)(A) of this subsection (b), of the benefits provided.

(C) With respect to nongroup policies and contracts covered by the Association, make available to each known insured, enrollee, or annuitant, or owner if other than the insured or annuitant, and with respect to an individual formerly an insured, enrollee, or annuitant under a group policy or contract who is not eligible for replacement group coverage, make available substitute coverage on an individual basis in accordance with the provisions of subdivision (2)(D) of this subsection (b) if the insureds, enrollees, or annuitants had a right under law or the terminated policy, contract, or annuity to convert coverage to individual coverage or to continue an individual policy, contract, or annuity in force until a specified age or for a specified time, during which the insurer or health maintenance organization had no right unilaterally to make changes in any provision of the policy, contract, or annuity or had a right only to make changes in premium by class.

1	(D)(i) In providing the substitute coverage required under
2	subdivision (2)(C) of this subsection (b), the Association may offer either to
3	reissue the terminated coverage or to issue an alternative policy or contract,
4	subject to the prior approval of the Commissioner.
5	(ii) Alternative or reissued policies or contracts shall be offered
6	without requiring evidence of insurability and shall not provide for any
7	waiting period or exclusion that would not have applied under the terminated
8	policy or contract.
9	(iii) The Association may reinsure any alternative or reissued
10	policy or contract.
11	(E)(i) Alternative policies or contracts adopted by the Association
12	shall be subject to the approval of the Commissioner. The Association may
13	adopt alternative policies or contracts of various types for future issuance
14	without regard to any particular impairment or insolvency.
15	(ii) Alternative policies or contracts shall contain at least the
16	minimum statutory provisions required in Vermont and provide benefits that
17	shall not be unreasonable in relation to the premium charged. The Association

shall set the premium in accordance with a table of rates that it shall adopt.

The premium shall reflect the amount of insurance to be provided and the age

and class of risk of each insured. The premium shall not reflect any changes in

1	the health of the insured after the original policy or contract was last

3	(iii) Any alternative policy or contract issued by the Association
4	shall provide coverage of a type similar to that of the policy or contract issued
5	by the impaired or insolvent insurer, as determined by the Association.
6	(F) If the Association elects to reissue terminated coverage at a
7	premium rate different from that charged under the terminated policy or
8	contract, the premium shall be set by the Association in accordance with the
9	amount of insurance or coverage provided and the age and class of risk,
10	subject to prior approval of the Commissioner.
11	(G) The Association's obligations with respect to coverage under any
12	policy or contract of the impaired or insolvent insurer or under any reissued or
13	alternative policy or contract shall cease on the date the coverage or policy or
14	contract is replaced by another similar policy or contract by the policy or
15	contract owner, the insured, the enrollee, or the Association.
16	(H) When proceeding under this subdivision (b)(2) of this section
17	with respect to a policy or contract carrying guaranteed minimum interest
18	rates, the Association shall ensure the payment or crediting of a rate of interest
19	consistent with subdivision 4173(b)(2)(C) of this chapter.
20	(c) Nonpayment of premiums within 31 days after the date required under
21	the terms of any guaranteed, assumed, alternative, or reissued policy or

1	contract or substitute coverage shall terminate the Association's obligations
2	under the policy, contract, or coverage under this chapter with respect to the
3	policy, contract, or coverage, except with respect to any claims incurred or any
4	net cash surrender value that may be due in accordance with the provisions of
5	this chapter.
6	(d) Premiums due for coverage after entry of an order of liquidation of an
7	insolvent insurer shall belong to and be payable at the direction of the
8	Association. If the liquidator of an insolvent insurer requests, the Association
9	shall provide a report to the liquidator regarding such premium collected by
10	the Association. The Association shall be liable for unearned premiums due to
11	policy or contract owners arising after the entry of the order.
12	(e) The protection provided by this chapter shall not apply where any
13	guaranty protection is provided to residents of Vermont by the laws of the
14	domiciliary state or jurisdiction of the impaired or insolvent insurer other than
15	this State.
16	(f) In carrying out its duties under subsection (b) of this section, the
17	Association may:
18	(1) Subject to approval by a court in this State, impose permanent
19	policy or contract liens, in connection with a guarantee, assumption, or
20	reinsurance agreement, if the Association finds that the amounts that can be
21	assessed under this chapter are less than the amounts needed to ensure full and

1	prompt performance of the Association's duties under this chapter, or that the
2	economic or financial conditions as they affect member insurers are
3	sufficiently adverse to render the imposition of policy or contract liens to be in
4	the public interest.
5	(2) Subject to the approval by a court in this State, impose temporary
6	moratoriums or liens on payments of cash values and policy loans, or any
7	other right to withdraw funds held in conjunction with policies or contracts, in
8	addition to any contractual provisions for deferral of cash or policy loan value.
9	In addition, in the event of a temporary moratorium or moratorium charge
10	imposed by the receivership court on payment of cash values or policy loans,
11	or on any other right to withdraw funds held in conjunction with policies or
12	contracts, out of the assets of the impaired or insolvent insurer, the Association
13	may defer the payment of cash values, policy loans, or other rights by the
14	Association for the period of the moratorium or moratorium charge imposed
15	by the receivership court, except for claims covered by the Association to be
16	paid in accordance with a hardship procedure established by the liquidator or
17	rehabilitator and approved by the receivership court.
18	(g) A deposit in Vermont, held pursuant to law or required by the
19	Commissioner for the benefit of creditors, including policy or contract owners,
20	not turned over to the domiciliary liquidator upon the entry of a final order of
21	liquidation or order approving a rehabilitation plan of a member insurer

1	domiciled in this State or in a reciprocal state, shall be promptly paid to the
2	Association. The Association shall be entitled to retain a portion of any
3	amount so paid to it equal to the percentage determined by dividing the
4	aggregate amount of policy or contract owners' claims related to that
5	insolvency for which the Association has provided statutory benefits by the
6	aggregate amount of all policy or contract owners' claims in this State related
7	to that insolvency and shall remit to the domiciliary receiver the amount so
8	paid to the Association less the amount retained pursuant to this subsection.
9	Any amount so paid to the Association and retained by it shall be treated as a
10	distribution of estate assets pursuant to applicable state receivership law
11	dealing with early access disbursements.
12	(h) If the Association fails to act within a reasonable period of time with
13	respect to an insolvent insurer, as provided in subsection (b) of this section, the
14	Commissioner shall have the powers and duties of the Association under this
15	chapter with respect to the insolvent insurer.
16	(i) The Association may render assistance and advice to the Commissioner,
17	upon the Commissioner's request, concerning rehabilitation, payment of
18	claims, continuance of coverage, or the performance of other contractual
19	obligations of any impaired or insolvent insurer.
20	(j) The Association shall have standing to appear or intervene before any
21	court or agency in Vermont with jurisdiction over an impaired or insolvent

insurer concerning which the Association is or may become obligated under
this chapter or with jurisdiction over any person or property against which the
Association may have rights through subrogation or otherwise. Standing shall
extend to all matters germane to the powers and duties of the Association,
including proposals for reinsuring, reissuing, modifying, or guaranteeing the
policies or contracts of the impaired or insolvent insurer and the determination
of the policies or contracts and contractual obligations. The Association shall
also have the right to appear or intervene before a court or agency in another
state with jurisdiction over an impaired or insolvent insurer for which the
Association is or may become obligated or with jurisdiction over any person or
property against whom the Association may have rights through subrogation or
otherwise.
(k)(1) Any person receiving benefits under this chapter shall be deemed to
have assigned the rights under, and any causes of action against any person for
losses arising under, resulting from or otherwise relating to, the covered policy
or contract to the Association to the extent of the benefits received because of
this chapter, whether the benefits are payments of or on account of contractual
obligations, continuation of coverage, or provision of substitute or alternative
policies, contracts, or coverages. The Association may require an assignment
to it of such rights and cause of action by any enrollee, payee, policy or
contract owner, beneficiary, insured, or annuitant as a condition precedent to

1	the receipt of any rights or benefits conferred by this chapter upon such
2	person.
3	(2) The subrogation rights of the Association under this subsection shall
4	have the same priority against the assets of the impaired or insolvent insurer as
5	that possessed by the person entitled to receive benefits under this chapter.
6	(3) In addition to subdivisions (1) and (2) of this subsection, the
7	Association shall have all common law rights of subrogation and any other
8	equitable or legal remedy that would have been available to the impaired or
9	insolvent insurer or owner, beneficiary, enrollee, or payee of a policy or
10	contract with respect to the policy or contracts, including, without limitation,
11	in the case of a structured settlement annuity, any rights of the owner,
12	beneficiary, or payee of the annuity, to the extent of benefits received pursuant
13	to this chapter, against a person originally or by succession responsible for the
14	losses arising from the personal injury relating to the annuity or payment
15	therefore, excepting any such person responsible solely by reason of serving as
16	an assignee in respect of a qualified assignment under section 130 of the U.S.
17	Internal Revenue Code.
18	(4) If the preceding subdivisions of this subsection are invalid or
19	ineffective with respect to any person or claim for any reason, the amount
20	payable by the Association with respect to the related covered obligations shall
21	be reduced by the amount realized by any other person with respect to the

1	person or claim that is attributable to the policies or contracts, or portion
2	thereof, covered by the Association.
3	(5) If the Association has provided benefits with respect to a covered
4	obligation and a person recovers amounts as to which the Association has
5	rights as described in the preceding subdivisions of this subsection, the person
6	shall pay to the Association the portion of the recovery attributable to the
7	policies or contracts, or portion thereof, covered by the Association.
8	(l) In addition to the rights and powers elsewhere in this chapter, the
9	Association may:
10	(1) enter into such contracts as are necessary or proper to carry out the
11	provisions and purposes of this chapter;
12	(2) sue or be sued, including taking any legal actions necessary or
13	proper for recovery of any unpaid assessments under section 4179 of this
14	chapter and to settle claims or potential claims against it;
15	(3) borrow money to effect the purposes of this chapter; and any notes
16	or other evidence of indebtedness of the Association not in default shall be
17	legal investments for domestic member insurers and may be carried as
18	admitted assets;
19	(4) employ or retain such persons as are necessary or appropriate to
20	handle the financial transactions of the Association, and to perform such other
21	functions as become necessary or proper under this chapter;

1	(5) take such legal action as may be necessary or appropriate to avoid
2	payment or recover payment of improper claims;
3	(6) exercise, for the purposes of this chapter and to the extent approved
4	by the Commissioner, the powers of a domestic life insurer, health insurer, or
5	health maintenance organization, but in no event may the Association issue
6	policies or contracts other than those issued to perform its obligations under
7	this chapter;
8	(7) organize itself as a corporation or in other legal form permitted by
9	Vermont law;
10	(8) request information from a person seeking coverage from the
11	Association in order to aid the Association in determining its obligations under
12	this chapter with respect to the person, and the person shall promptly comply
13	with the request;
14	(9) unless prohibited by law, in accordance with the terms and
15	conditions of the policy or contract, file for actuarially justified rate or
16	premium increases for any policy or contract for which it provides coverage
17	under this chapter; and
18	(10) take other necessary or appropriate action to discharge its duties
19	and obligations under this chapter or to exercise its powers under this chapter.

1	(m) The Association may join an organization of one or more other State
2	associations of similar purposes, to further the purposes and administer the
3	powers and duties of the Association.
4	(n)(1)(A) At any time within 180 days after the date of the order of
5	liquidation, the Association may elect to succeed to the rights and obligations
6	of the ceding member insurer that relate to policies, contracts, or annuities
7	covered, in whole or in part, by the Association, in each case under any one or
8	more reinsurance contracts entered into by the insolvent insurer and its
9	reinsurers and selected by the Association. Any such assumption shall be
10	effective as of the date of the order of liquidation. The election shall be
11	effected by the Association or by the National Organization of Life and Health
12	Insurance Guaranty Associations (NOLHGA) on its behalf sending written
13	notice, return receipt requested, to the affected reinsurers.
14	(B) To facilitate the earliest practicable decision about whether to
15	assume any of the contracts of reinsurance, and in order to protect the financial
16	position of the estate, the receiver and each reinsurer of the ceding member
17	insurer shall make available upon request to the Association or to NOLHGA
18	on its behalf as soon as possible after commencement of formal delinquency
19	proceedings:

1	(i) copies of in-force contracts of reinsurance and all related files
2	and records relevant to the determination of whether such contracts should be
3	assumed; and
4	(ii) notices of any defaults under the reinsurance contacts or any
5	known event or condition that, with the passage of time, could become a
6	default under the reinsurance contracts.
7	(C) Subdivisions (i)–(iv) of this subdivision (1)(C) shall apply to
8	reinsurance contracts assumed by the Association under subdivision (1)(A) of
9	this subsection (n):
10	(i) The Association shall be responsible for all unpaid premiums
11	due under the reinsurance contracts for periods both before and after the date
12	of the order of liquidation and shall be responsible for the performance of all
13	other obligations to be performed after the date of the order of liquidation, in
14	each case that relate to policies, contracts, or annuities covered, in whole or in
15	part, by the Association. The Association may charge policies, contracts, or
16	annuities covered in part by the Association, through reasonable allocation
17	methods, the costs for reinsurance in excess of the obligations of the
18	Association and shall provide notice and an accounting of these charges to the
19	receiver liquidator.
20	(ii) The Association shall be entitled to any amounts payable by
21	the reinsurer under the reinsurance contracts with respect to losses or events

entitled to set off any unpaid amounts due under other contracts, or unpaid
amounts due from parties other than the Association, against amounts due the

1	(A)(i) neither the Association nor the reinsurer shall have any rights
2	or obligations under reinsurance contracts that the Association has the right to
3	assume under subdivision (1) of this subsection (n), whether for periods prior
4	to or after the date of the order of liquidation; and
5	(ii) the reinsurer, the receiver, and the Association shall, to the
6	extent practicable, provide each other data and records reasonably requested;
7	(B) provided that once the Association has elected to assume a
8	reinsurance contract, the parties' rights and obligations shall be governed by
9	subdivision (1) of this subsection (n).
10	(3) If the Association does not elect to assume a reinsurance contract by
11	the election date pursuant to subdivision (1) of this subsection (n), the
12	Association shall have no rights or obligations, in each case for periods both
13	before and after the date of the order of liquidation, with respect to the
14	reinsurance contract.
15	(4) When policies, contracts, or annuities, or covered obligations with
16	respect thereto, are transferred to an assuming insurer, reinsurance on the
17	policies, contracts, or annuities may also be transferred by the Association, in
18	the case of contracts assumed under subdivision (1) of this subsection (n),
19	subject to the following:

1	(i) unless the reinsurer and the assuming insurer agree otherwise,
2	the reinsurance contract transferred shall not cover any new policies of
3	insurance, contracts, or annuities in addition to those transferred;
4	(ii) the obligations described in subdivision (1) of this subsection
5	(n) shall no longer apply with respect to matters arising after the effective date
6	of the transfer; and
7	(iii) notice shall be given in writing, return receipt requested, by
8	the transferring party to the affected reinsurer not less than 30 days prior to the
9	effective date of the transfer.
10	(5) The provisions of this subsection shall supersede the provisions of
11	any State law or of any affected reinsurance contract that provides for or
12	requires any payment of reinsurance proceeds, on account of losses or events
13	that occur in periods after the date of the order of liquidation, to the receiver of
14	the insolvent insurer or any other person. The receiver shall remain entitled to
15	any amounts payable by the reinsurer under the reinsurance contracts with
16	respect to losses or events that occur in periods prior to the date of the order of
17	liquidation, subject to applicable setoff provisions.
18	(6) Except as otherwise provided in this section, nothing in this
19	subsection shall alter or modify the terms and conditions of any reinsurance
20	contract. Nothing in this subsection shall:

1	(A) abrogate or limit any rights of any reinsurer to claim that it is
2	entitled to rescind a reinsurance contract;
3	(B) give a policyholder, contract owner, enrollee, certificate holder,
4	or beneficiary an independent cause of action against a reinsurer that is not
5	otherwise set forth in the reinsurance contract;
6	(C) limit or affect the Association's rights as a creditor of the estate
7	against the assets of the estate; or
8	(D) apply to reinsurance agreements covering property or casualty
9	<u>risks.</u>
10	(o) The Board of Directors of the Association shall have discretion and
11	may exercise reasonable business judgment to determine the means by which
12	the Association is to provide the benefits of this chapter in an economical and
13	efficient manner.
14	(p) Where the Association has arranged or offered to provide the benefits
15	of this chapter to a covered person under a plan or arrangement that fulfills the
16	Association's obligations under this chapter, the person shall not be entitled to
17	benefits from the Association in addition to or other than those provided under
18	the plan or arrangement.
19	(q) Venue in a suit against the Association arising under this chapter shall
20	be in the Civil Division of the Washington Superior Court. The Association

1	shall not be required to give an appeal bond in an appeal that relates to a cause
2	of action arising under this chapter.
3	(r) In carrying out its duties in connection with guaranteeing, assuming,
4	reissuing, or reinsuring policies or contracts under subsection (a) or (b) of this
5	section, the Association may issue substitute coverage for a policy or contract
6	that provides an interest rate, crediting rate, or similar factor determined by use
7	of an index or other external reference stated in the policy or contract
8	employed in calculating returns or changes in value by issuing an alternative
9	policy or contract in accordance with all of the following provisions:
10	(1) In lieu of the index or other external reference provided for in the
11	original policy or contract, the alternative policy or contract provides for:
12	(A) a fixed interest rate;
13	(B) payment of dividends with minimum guarantees; or
14	(C) a different method for calculating interest or changes in value.
15	(2) There is no requirement for evidence of insurability, waiting period,
16	or other exclusion that would not have applied under the replaced policy or
17	contract.
18	(3) The alternative policy or contract is substantially similar to the
19	replaced policy or contract in all other material terms.
20	§ 4179. ASSESSMENTS

1	(a) For the purpose of providing the funds necessary to carry out the
2	powers and duties of the Association, the Board of Directors shall assess the
3	member insurers, separately for each account, at such times and for such
4	amounts as the Board finds necessary. Assessments shall be due not less than
5	30 days after prior written notice to the member insurers and shall accrue
6	interest at nine percent per annum on and after the due date.
7	(b) There shall be two classes of assessments, as follows:
8	(1) Class A assessments shall be authorized and called for the purpose
9	of meeting administrative and legal costs and other expenses. Class A
10	assessments may be authorized and called whether or not related to a particular
11	impaired or insolvent insurer.
12	(2) Class B assessments shall be authorized and called to the extent
13	necessary to carry out the powers and duties of the Association under section
14	4178 of this chapter with regard to an impaired or insolvent insurer.
15	(c)(1) The amount of any Class A assessment shall be determined by the
16	Board and may be authorized and called on a pro rata or non-pro rata basis. If
17	pro rata, the Board may provide that it be credited against future Class B
18	assessments.
19	(2) The amount of a Class B assessment, except assessments related to
20	long-term care insurance, shall be allocated for assessment purposes between

the accounts and among the subaccounts of the life insurance and annuity

account, pursuant to an allocation formula, which may be based on the
premiums or reserves of the impaired or insolvent insurer or any other
standard deemed by the Board in its sole discretion as being fair and
reasonable under the circumstances.

- (3) The amount of the Class B assessment for long-term care insurance written by the impaired or insolvent insurer shall be allocated according to a methodology included in the plan of operation and approved by the Commissioner. The methodology shall provide for 50 percent of the assessment to be allocated to accident and health member insurers and 50 percent to be allocated to life and annuity member insurers.
- (4) Class B assessments against member insurers for each account and subaccount shall be in the proportion that the premiums received on business in this State by each assessed member insurer on policies or contracts covered by each account for the three most recent calendar years for which information is available preceding the year in which the member insurer became insolvent or, in the case of an assessment with respect to an impaired insurer, the three most recent calendar years for which information is available preceding the year in which the member insurer became impaired, bears to premiums received on business in this State for those calendar years by all assessed member insurers.

1 (5) Assessments for funds to meet the requirements of the Association 2 with respect to an impaired or insolvent insurer shall not be authorized or 3 called until necessary to implement the purposes of this chapter. Classification 4 of assessments under subsection (b) of this section and computation of 5 assessments under this subsection shall be made with a reasonable degree of 6 accuracy, recognizing that exact determinations may not always be possible. 7 The Association shall notify each member insurer of its anticipated pro rata 8 share of an authorized assessment not yet called within 180 days after the 9 assessment is authorized. 10 (d) The Association may abate or defer, in whole or in part, the assessment 11 of a member insurer if, in the opinion of the Board, payment of the assessment 12 would endanger the ability of the member insurer to fulfill its contractual 13 obligations. In the event an assessment against a member insurer is abated or 14 deferred, in whole or in part, the amount by which such assessment is abated 15 or deferred may be assessed against the other member insurers in a manner 16 consistent with the basis for assessments set forth in this section. Once the 17 conditions that caused a deferral have been removed or rectified, the member 18 insurer shall pay all assessments that were deferred pursuant to a repayment 19 plan approved by the Association. 20 (e)(1)(A) Subject to the provisions of subdivision (1)(B) of this subsection 21 (e), the total of all assessments authorized by the Association with respect to a

member insurer for each subaccount of the life insurance and annuity account	
and for the health account shall not in one calendar year exceed two percent of	
that member insurer's average annual premiums received in Vermont on the	
policies and contracts covered by the subaccount or account during the three	
calendar years preceding the year in which the member insurer became an	
impaired or insolvent insurer.	
(B) If two or more assessments are authorized in one calendar year	
with respect to member insurers that become impaired or insolvent in different	
calendar years, the average annual premiums for purposes of the aggregate	
assessment percentage limitation referenced in subdivision (1)(A) of this	
subsection (e) shall be equal and limited to the higher of the three-year average	
annual premiums for the applicable subaccount or account as calculated	
pursuant to this section.	
(C) If the maximum assessment, together with the other assets of the	
Association in an account, does not provide in one year in either account an	
amount sufficient to carry out the responsibilities of the Association, the	
necessary additional funds shall be assessed as soon thereafter as permitted by	
this chapter.	
(2) The Board may provide in the plan of operation a method of	

allocating funds among claims, whether relating to one or more impaired or

3	(3) If the maximum assessment for a subaccount of the life and annuity
4	account in one year does not provide an amount sufficient to carry out the
5	responsibilities of the Association, then pursuant to subdivision (c)(2) of this
6	section, the Board shall access the other subaccounts of the life and annuity
7	account for the necessary additional amount, subject to the maximum stated in
8	subdivision (1) of this subsection.
9	(f) The Board may, by an equitable method as established in the plan of
10	operation, refund to member insurers, in proportion to the contribution of each
11	member insurer to that account, the amount by which the assets of the account
12	exceed the amount the Board finds is necessary to carry out during the coming
13	year the obligations of the Association with regard to that account, including
14	assets accruing from assignment, subrogation, net realized gains, and income
15	from investments. A reasonable amount may be retained in any account to
16	provide funds for the continuing expenses of the Association and for future

(g) It shall be proper for any member insurer, in determining its premium

maintenance organization business within the scope of this chapter, to consider

rates and policy owner dividends as to any kind of insurance or health

insolvent insurers, when the maximum assessment will be insufficient to cover

1	the amount reasonably necessary to meet its assessment obligations under this
2	chapter.
3	(h) The Association shall issue to each member insurer paying an
4	assessment under this chapter, other than a Class A assessment, a certificate of
5	contribution, in a form prescribed by the Commissioner, for the amount so
6	paid. All outstanding certificates shall be of equal dignity and priority without
7	reference to amounts or dates of issue. A certificate of contribution may be
8	shown by the member insurer in its financial statement as an asset in such form
9	and for such amount, if any, and period of time as the Commissioner may
10	approve.
11	(i)(1) A member insurer that wishes to protest all or part of an assessment
12	shall pay when due the full amount of the assessment as set forth in the notice
13	provided by the Association. The payment shall be available to meet
14	Association obligations during the pendency of the protest or any subsequent
15	appeal. Payment shall be accompanied by a statement in writing that the
16	payment is made under protest and setting forth a brief statement of the
17	grounds for the protest.
18	(2) Within 60 days following the payment of an assessment under
19	protest by a member insurer, the Association shall notify the member insurer
20	in writing of its determination with respect to the protest unless the

1	Association notifies the member insurer that additional time is required to
2	resolve the issues raised by the protest.
3	(3) Within 30 days after a final decision has been made, the Association
4	shall notify the protesting member insurer in writing of that final decision.
5	Within 60 days after receipt of notice of the final decision, the protesting
6	member insurer may appeal that final action to the Commissioner.
7	(4) In the alternative to rendering a final decision with respect to a
8	protest based on a question regarding the assessment base, the Association may
9	refer protests to the Commissioner for a final decision, with or without a
10	recommendation from the Association.
11	(5) If the protest or appeal on the assessment is upheld, the amount paid
12	in error or excess shall be returned to the member insurer. Interest on a refund
13	due a protesting member insurer shall be paid at the rate actually earned by the
14	Association.
15	(j) The Association may request information of member insurers in order
16	to aid in the exercise of its power under this section and member insurers shall
17	promptly comply with a request.
18	§ 4180. PLAN OF OPERATION
19	(a)(1) The Association shall submit to the Commissioner a plan of
20	operation and any amendments to the plan necessary or suitable to assure the
21	fair, reasonable, and equitable administration of the Association. The plan of

1	operation and any amendments to the plan shall become effective upon
2	approval in writing by the Commissioner.
3	(2) If the Association fails to submit a suitable plan of operation within
4	120 days following the effective date of this chapter or if at any time thereafter
5	the Association fails to submit suitable amendments to the plan, the
6	Commissioner shall, after notice and hearing, adopt such reasonable rules as
7	are necessary or advisable to effectuate the provisions of this chapter. Such
8	rules shall continue in force until modified by the Commissioner or superseded
9	by a plan submitted by the Association and approved by the Commissioner.
10	(b) All member insurers shall comply with the plan of operation.
11	(c) The plan of operation shall, in addition to requirements enumerated
12	elsewhere in this chapter:
13	(1) establish procedures for handling the assets of the Association;
14	(2) establish the amount and method of reimbursing members of the
15	Board of Directors under section 4177 of this chapter;
16	(3) establish regular places and times including virtual conference calls
17	for meetings of the Board of Directors;
18	(4) establish procedures for records to be kept of all financial
19	transactions of the Association, its agents, and the Board of Directors;
20	(5) establish the procedures whereby selections for the Board of
21	Directors will be made and submitted to the Commissioner;

1	(b) establish any additional procedures for assessments under section
2	4179 of this chapter;
3	(7) contain additional provisions necessary or proper for the execution
4	of the powers and duties of the Association;
5	(8) establish procedures whereby a Director may be removed for cause,
6	including in the case where a member insurer Director becomes an impaired or
7	insolvent insurer; and
8	(9) require the Board of Directors to establish a policy and procedures
9	for addressing conflicts of interests.
10	(d) The plan of operation may provide that any or all powers and duties of
11	the Association, except those under subdivision 4178(l)(3) and section 4179 of
12	this chapter, are delegated to a corporation, association, or other organization
13	that performs or will perform functions similar to those of this Association, or
14	its equivalent in two or more states. Such a corporation, association, or
15	organization shall be reimbursed for any payments made on behalf of the
16	Association and shall be paid for its performance of any function of the
17	Association. A delegation under this subsection shall take effect only with the
18	approval of both the Board of Directors and the Commissioner, and may be
19	made only to a corporation, association, or organization that extends protection
20	not substantially less favorable and effective than that provided by this chapter.
21	§ 4181. DUTIES AND POWERS OF THE COMMISSIONER

1	(a) In addition to the duties and powers enumerated elsewhere in this
2	chapter, the Commissioner shall:
3	(1) Upon the request of the Board of Directors, provide the Association
4	with a statement of the premiums in Vermont and in any other appropriate
5	states for each member insurer.
6	(2) Notify the Board of Directors of the existence of an impaired or
7	insolvent insurer not later than three days after a determination of impairment
8	or insolvency is made or the Commissioner receives notice of impairment or
9	insolvency.
10	(3) When an impairment is declared and the amount of the impairment
11	is determined, serve a demand upon the impaired insurer to make good the
12	impairment within a reasonable time. Notice to the impaired insurer shall
13	constitute notice to its shareholders, if any. The failure of the impaired insurer
14	to promptly comply with such demand shall not excuse the Association from
15	the performance of its powers and duties under this chapter.
16	(4) In any liquidation or rehabilitation proceeding involving a domestic
17	insurer, be appointed as the liquidator or rehabilitator. If a foreign or alien
18	member insurer is subject to a liquidation proceeding in its domiciliary
19	jurisdiction or state of entry, the Commissioner shall be appointed conservator.
20	(b) The Commissioner may suspend or revoke, after notice and hearing,
21	the certificate of authority to transact business in Vermont of any member

1	insurer that fails to pay an assessment when due or fails to comply with the
2	plan of operation. As an alternative, the Commissioner may levy a forfeiture
3	on any member insurer that fails to pay an assessment when due. Such
4	forfeiture shall not exceed five percent of the unpaid assessment per month,
5	but no forfeiture shall be less than \$500.00 per month.
6	(c) A final action of the Board of Directors or the Association may be
7	appealed to the Commissioner by a member insurer if such appeal is taken
8	within 60 days following its receipt of notice of the final action being
9	appealed. A final action or order of the Commissioner shall be subject to
10	judicial review in the Vermont Supreme Court.
11	(d) The liquidator, rehabilitator, or conservator of any impaired or
12	insolvent insurer may notify all interested persons of the effect of this chapter.
13	§ 4182. PREVENTION OF INSOLVENCIES
14	(a) To aid in the detection and prevention of member insurer impairment or
15	insolvency, it shall be the duty of the Commissioner to:
16	(1) Notify the commissioners of all the other states within 30 days
17	following the action taken or the date the action occurs when the
18	Commissioner takes any of the following actions against a member insurer:
19	(A) revocation of license;
20	(B) suspension of license; or

1	(C) makes a formal order that the member insurer restrict its
2	premium writing, obtain additional contributions to surplus, withdraw from
3	Vermont, reinsure all or any part of its business, or increase capital, surplus, or
4	any other account for the security of policy owners, contract owners,
5	certificate holders, or creditors.
6	(2) Report to the Board of Directors when the Commissioner has taken
7	any of the actions set forth in subdivision (1) of this subsection or has received
8	a report from any other commissioner indicating that any such action has been
9	taken in another state. The report to the Board of Directors shall contain all
10	significant details of the action taken or the report received from another
11	commissioner.
12	(3) Report to the Board of Directors when the Commissioner has
13	reasonable cause to believe from an examination, whether completed or in
14	process, of any member insurer that the insurer may be an impaired or
15	insolvent insurer.
16	(4) Furnish to the Board of Directors the NAIC Insurance Regulatory
17	Information System ratios and listings of companies not included in the ratios
18	developed by the National Association of Insurance Commissioners, and the
19	Board may use the information contained therein in carrying out its duties and
20	responsibilities under this section. The report and the information contained

1	therein shall be kept confidential by the Board of Directors until such time as
2	made public by the Commissioner or other lawful authority.
3	(b) The Commissioner may seek the advice and recommendations of the
4	Board of Directors concerning any matter affecting the duties and
5	responsibilities of the Commissioner regarding the financial condition of
6	member insurers and insurers or health maintenance organizations seeking
7	admission to transact business in Vermont.
8	(c) The Board of Directors, upon majority vote, may make reports and
9	recommendations to the Commissioner upon any matter germane to the
10	solvency, liquidation, rehabilitation, or conservation of any member insurer or
11	germane to the solvency of any insurer or health maintenance organization
12	seeking to do business in Vermont. Such reports and recommendations shall
13	not be considered public documents.
14	(d) The Board of Directors, upon majority vote, shall notify the
15	Commissioner of any information indicating a member insurer may be an
16	impaired or insolvent insurer.
17	(e) The Board of Directors, upon majority vote, may make
18	recommendations to the Commissioner for the detection and prevention of
19	member insurer insolvencies.
20	(f) The Board of Directors shall, at the conclusion of any insurer
21	impairment or insolvency in which the Association carried out its duties under

1	this chapter or exercised any of its powers under this chapter, prepare a report
2	on the history and causes of such impairment or insolvency, based on the
3	information available to the Association, and submit such report to the
4	Commissioner.
5	§ 4183. CREDITS FOR ASSESSMENTS PAID
6	(a) A member insurer may offset against its premium tax liability to
7	Vermont an assessment described in subsection 4179(h) of this chapter to the
8	extent of 20 percent of the amount of the assessment for each of the five
9	calendar years following the year in which the assessment was paid. In the
10	event a member insurer should cease doing business, all uncredited
11	assessments may be credited against its premium tax liability for the year it
12	ceases doing business.
13	(b) A member insurer that is exempt from taxes referenced in subsection
14	(a) of this section may recoup its assessments by a surcharge on its premiums
15	in a sum reasonably calculated to recoup the assessments over a reasonable
16	period of time, as approved by the Commissioner. Amounts recouped shall
17	not be considered premiums for any other purpose, including the computation
18	of gross premium tax, the medical loss ratio, or agent commission. If a
19	member insurer collects excess surcharges, the insurer shall remit the excess
20	amount to the Association, and the excess amount shall be applied to reduce
21	future assessments in the appropriate account.

1	(c) Any sums acquired by refund, pursuant to subsection 4179(f) of this
2	chapter, from the Association that have been written off by contributing
3	insurers and offset against premium taxes as provided in subsection (a) of this
4	section, and are not then needed for purposes of this chapter, shall be paid by
5	the insurer to the Commissioner, who shall deposit them with the State
6	Treasurer for credit to the General Fund.
7	§ 4184. MISCELLANEOUS PROVISIONS
8	(a) This chapter shall not be construed to reduce the liability for unpaid
9	assessments of the insureds of an impaired or insolvent insurer operating under
10	a plan with assessment liability.
11	(b)(1) Records shall be kept of all meetings of the Board of Directors to
12	discuss the activities of the Association in carrying out its powers and duties
13	under section 4178 of this chapter. The records of the Association with respect
14	to an impaired or insolvent insurer shall not be disclosed prior to the
15	termination of a liquidation, rehabilitation, or conservation proceeding
16	involving the impaired or insolvent insurer, except:
17	(A) upon the termination of the impairment or insolvency of the
18	member insurer; or
19	(B) upon the order of a court of competent jurisdiction.
20	(2) Nothing in this subsection shall limit the duty of the Association to
21	render a report of its activities under section 4185 of this chapter.

(c) For the purpose of carrying out its obligations under this chapter, the
Association shall be deemed to be a creditor of the impaired or insolvent
insurer to the extent of assets attributable to covered policies reduced by any
amounts to which the Association is entitled as subrogee pursuant to
subsection 4178(k) of this chapter. Assets of the impaired or insolvent insurer
attributable to covered policies shall be used to continue all covered policies
and pay all contractual obligations of the impaired or insolvent insurer as
required by this chapter. Assets attributable to covered policies or contracts, as
used in this subsection, are that proportion of the assets that the reserves that
should have been established for such policies or contracts bear to the reserves
that should have been established for all policies of insurance or health benefit
plans written by the impaired or insolvent insurer.
(d) As a creditor of the impaired or insolvent insurer pursuant to subsection
(c) of this section and consistent with section 7073 of this title, the Association
and other similar associations shall be entitled to receive a disbursement of
assets out of the marshaled assets, from time to time as the assets become
available to reimburse it, as a credit against contractual obligations under this
chapter. If the liquidator has not, within 120 days after a final determination
of insolvency of a member insurer by the receivership court, made an
application to the court for the approval of a proposal to disburse assets out of
marshaled assets to guaranty associations having obligations because of the

1	insolvency, then the Association shall be entitled to make application to the
2	receivership court for approval of its own proposal to disburse these assets.
3	(e)(1) Prior to the termination of any liquidation, rehabilitation, or
4	conservation proceeding, the court may take into consideration the
5	contributions of the respective parties, including the Association, the
6	shareholders, contract owners, certificate holders, enrollees, and policyowners
7	of the insolvent insurer, and any other party with a bona fide interest, in
8	making an equitable distribution of the ownership rights of the insolvent
9	insurer. In such a determination, consideration shall be given to the welfare of
10	the policylellar policyowners, contract owners, certificate holders, and
11	enrollees of the continuing or successor member insurer.
12	(2) No distribution to stockholders, if any, of an impaired or insolvent
13	insurer shall be made until and unless the total amount of valid claims of the
14	Association with interest thereon for funds expended in carrying out its powers
15	and duties under section 4178 of this chapter with respect to the member
16	insurer have been fully recovered by the Association.
17	(f) If an order for liquidation or rehabilitation of a member insurer
18	domiciled in Vermont has been entered, the receiver appointed under such
19	order shall have a right to recover on behalf of the member insurer from any
20	affiliate that controlled it the amount of distributions, other than stock
21	dividends paid by the member insurer on its capital stock, made at any time

1	during the five years preceding the petition for liquidation or rehabilitation
2	subject to the following limitations:
3	(1) A distribution shall not be recoverable if the member insurer shows
4	that, when paid, the distribution was lawful and reasonable and that the
5	member insurer did not know and could not reasonably have known that the
6	distribution might adversely affect the ability of the member insurer to fulfill
7	its contractual obligations.
8	(2) Any person who was an affiliate that controlled the member insurer
9	at the time the distributions were paid shall be liable up to the amount of
10	distributions received. Any person who was an affiliate that controlled the
11	member insurer at the time the distributions were declared shall be liable up to
12	the amount of distributions that would have been received if they had been
13	paid immediately. If two or more persons are liable with respect to the same
14	distributions, they shall be jointly and severally liable.
15	(3) The maximum amount recoverable under this subdivision shall be
16	the amount needed in excess of all other available assets of the insolvent
17	insurer to pay the contractual obligations of the insolvent insurer.
18	(g) If any person liable under subdivision (f)(2) of this section is insolvent.
19	all its affiliates that controlled it at the time the distribution was paid shall be
20	jointly and severally liable for any resulting deficiency in the amount
21	recovered from the insolvent affiliate.

1	§ 4185. EXAMINATION; ANNUAL REPORT

15	circulated, or placed before the public, in any newspaper, magazine or other
16	publication, or in the form of a notice, circular, pamphlet, letter, or poster, or
17	over any radio station or television station, or in any other way, any
18	advertisement, announcement, or statement, written or oral, that uses the
19	existence of the Insurance Guaranty Association of Vermont for the purpose of
20	sales, solicitation, or inducement to purchase any form of insurance or other
21	coverage covered by this chapter. However, this section shall not apply to the

1	Vermont Life and Health Insurance Guaranty Association or any other entity
2	that does not sell or solicit insurance or coverage by a health maintenance

4	(b) Within 180 days after the effective date of this chapter, the Association
5	shall prepare a summary document describing the general purposes and current
6	limitations of this chapter and complying with subsection (c) of this section.
7	This document shall be submitted to the Commissioner for approval. At the

9	the document, a member insurer may not deliver a policy or contract to a
10	policy owner, contract owner, certificate holder, or enrollee unless the

13	document shall also be available upon request by a policy owner, contract

	§ 7033. INJUNCTIONS AND ORDERS
	(a) A receiver appointed in a proceeding under this chapter may at any time apply for, and any court of general jurisdiction may grant, restraining orders, preliminary and permanent injunctions, and other orders as may be

deemed necessary and proper to prevent:

(2) the transfer of property;

(1) the transaction of further business;

- (3) interference with the receiver or with a proceeding under this chapter;
 - (4) waste of the insurer's assets;
 - (5) dissipation and transfer of bank accounts;
 - (6) the institution or further prosecution of any actions or proceedings;
- (7) the obtaining of preferences, judgments, attachments, garnishments, or liens against the insurer, its assets or its policyholders;
- (8) the levying of execution against the insurer, its assets or its policyholders;
- (9) the making of any sale or deed for nonpayment of taxes or assessments that would lessen the value of the assets of the insurer;
- (10) the withholding from the receiver of books, accounts, documents, or other records relating to the business of the insurer; or
- (11) any other threatened or contemplated action that might lessen the value of the insurer's assets or prejudice the rights of policyholders, creditors, or shareholders, or the administration of any proceeding under this chapter.
- (b) The receiver may apply to a court outside the State for the relief described in subsection (a) of this section.
- (c) Notwithstanding subsections (a) and (b) of this section, subsection 7054(a) of this title, or any other provision of this chapter to the contrary, no person, for more than 10 days, shall be restrained, stayed, enjoined, or prohibited from exercising or enforcing any right or cause of action under any pledge, security, credit, collateral, loan, advances, reimbursement, or guarantee agreement or arrangement, or any similar agreement, arrangement, or other credit enhancement to which a federal home loan bank is a party.
- (d) A federal home loan bank exercising its rights regarding collateral pledged by an insurer-member shall, within seven days after receiving a redemption request made by the insurer-member, repurchase any of the insurer-member's outstanding capital stock in excess of the amount the insurer-member must hold as a minimum investment. The federal home loan bank shall repurchase the excess outstanding capital stock only to the extent that it determines in good faith that the repurchase is both of the following:
- (1) permissible under federal laws and regulations and the federal home loan bank's capital plan; and

- (2) consistent with the capital stock practices currently applicable to the federal home loan bank's entire membership.
- (e) Not later than 10 days after the date of appointment of a receiver in a proceeding under this chapter involving an insurer-member of a federal home loan bank, the federal home loan bank shall provide to the receiver a process and timeline for the following:
- (1) the release of any collateral held by the federal home loan bank that exceeds the amount that is required to support the secured obligations of the insurer-member and that is remaining after any repayment of loans, as determined under the applicable agreements between the federal home loan bank and the insurer-member;
- (2) the release of any collateral of the insurer-member remaining in the federal home loan bank's possession following repayment in full of all outstanding secured obligations of the insurer-member;
- (3) the payment of fees owed by the insurer-member and the operation, maintenance, closure, or disposition of deposits and other accounts of the insurer-member, as mutually agreed upon by the receiver and the federal home loan bank; and
- (4) any redemption or repurchase of federal home loan bank stock or excess stock of any class that the insurer-member is required to own under agreements between the federal home loan bank and the insurer-member.
- (f) Upon the request of a receiver appointed in a proceeding under this chapter involving a federal home loan bank insurer-member, the federal home loan bank shall provide to the receiver any available options for the insurer-member to renew or restructure a loan. In determining which options are available, the federal home loan bank may consider market conditions, the terms of any loans outstanding to the insurer-member, the applicable policies of the federal home loan bank, and the federal laws and regulations applicable to federal home loan banks.
- (g) As used in this section, "federal home loan bank" means an institution chartered under the "Federal Home Loan Bank Act of 1932," 12 U.S.C. 1421, et seq. and "insurer-member" means a member of the federal home loan bank in question that is an insurer.

- § 7065. FRAUDULENT TRANSFERS PRIOR TO PETITION
- (a) Every transfer made or suffered and every obligation incurred by an insurer within one year prior to the filing of a successful petition for

rehabilitation or liquidation under this chapter is fraudulent as to then existing and future creditors if made or incurred without fair consideration, or with actual intent to hinder, delay, or defraud either existing or future creditors. A transfer made or an obligation incurred by an insurer ordered to be rehabilitated or liquidated under this chapter, which is fraudulent under this section, may be avoided by the receiver, except as to a person who in good faith is a purchaser, lienor, or obligee, for a present fair equivalent value, and except that a purchaser, lienor, or obligee, who in good faith has given a consideration less than fair for such transfer, lien, or obligation, may retain the property, lien, or obligation as security for repayment. The Court may, on due notice, order any such transfer or obligation to be preserved for the benefit of the estate, and in that event, the receiver shall succeed to and may enforce the rights of the purchaser, lienor, or obligee.

(e) Notwithstanding subsection (a) of this section, section 7066 of this title, or any other provision of this chapter to the contrary, no receiver or any other person shall avoid any transfer of, or any obligation to transfer, money or any other property arising under or in connection with any pledge, security, credit, collateral, loan, advances, reimbursement, or guarantee agreement or arrangement, or any similar agreement, arrangement, or other credit enhancement to which a federal home loan bank, as defined in section 7033 of this title, is a party, that is made, incurred, or assumed prior to or after the filing of a successful petition for rehabilitation or liquidation under this chapter, or otherwise would be subject to avoidance under this section or section 7066 of this title; provided, however, that a transfer may be avoided under this section or section 7066 of this title if the transfer was made with actual intent to hinder, delay, or defraud the insurer, a receiver appointed for the insurer, or existing or future creditors.

§ 7067. VOIDABLE PREFERENCES AND LIENS

(a)(1) A preference is a transfer of any of the property of an insurer to or for the benefit of a creditor, for or on account of an antecedent debt, made or suffered by the insurer within one year before the filing of a successful petition for liquidation under this chapter, the effect of which transfer may be to enable the creditor to obtain a greater percentage of this debt than another creditor of the same class would receive. If a liquidation order is entered while the insurer is already subject to a rehabilitation order, then such transfers shall be deemed preferences if made or suffered within one year before the filing of the

successful petition for rehabilitation, or within two years before the filing of the successful petition for liquidation, whichever time is shorter.

- (2) A preference may be avoided by the liquidator if:
 - (A) the insurer was insolvent at the time of the transfer of property;
- (B) the transfer of property was made within four months before the filing of the petition;
- (C) the creditor receiving it or to be benefited by it or the creditor's agent acting with reference to it had, at the time when the transfer of property was made, reasonable cause to believe that the insurer was insolvent or was about to become insolvent; or
- (D) the creditor receiving transferred property was an officer, or any employee or attorney or other person who was in fact in a position of comparable influence in the insurer to an officer whether or not he or she held such position, or any shareholder holding directly or indirectly more than five per centum of any class of any equity security issued by the insurer, or any other person, firm, corporation, association, or aggregation of persons with whom the insurer did not deal at arm's length.
- (3) Where the preference is voidable, the liquidator may recover the property or, if it has been converted, its value from any person who has received or converted the property; except where a bona fide purchaser or lienor has given less than fair equivalent value, he or she the purchaser or lienor shall have a lien upon the property to the extent of the consideration actually given by him or her the purchaser or lienor. Where a preference by way of lien or security title is voidable, the court may on due notice order the lien or title to be preserved for the benefit of the estate, in which event the lien or title shall pass to the liquidator.
- (4) Notwithstanding subdivision (2) of this section, or any other provision of this chapter to the contrary, no receiver or any other person shall avoid any preference arising under or in connection with any pledge, security, credit, collateral, loan, advances, reimbursement, or guarantee agreement or arrangement, or any similar agreement, arrangement, or other credit enhancement to which a federal home loan bank, as defined in section 7033 of this title, is a party.
