6	(a) The Secretary of Human Services, in collaboration with the Deputy
7	Secretary of Human Services and the commissioner of each department within
8	the Agency of Human Services and in consultation with the Office of the
9	Health Care Advocate; the Office of the Child, Youth, and Family Advocate;
10	Disability Rights Vermont; the Office of the Long-Term Care Ombudsman;
11	and other relevant stakeholders, shall consider options for reenvisioning the
12	Agency of Human Services, such as restructuring the existing Agency of
13	Human Services or dividing the existing Agency of Human Services into two
14	or more separate agencies.
15	(b) The Secretary of Human Services and the other stakeholders identified
16	in subsection (a) of this section shall evaluate the current structure of the
17	Agency of Human Services, identify potential options for reenvisioning the
18	Agency and engage in a cost-benefit analysis of each option, and develop one
19	or more recommendations for implementation.
20	(c) On or before February 1, 2025, the Secretary shall provide the
21	recommendations developed by the Secretary and stakeholders to the House

4	(1) the rationale for selecting the recommended option or options;

8	(3) how the recommendations would center the needs of and lead to
9	better outcomes for the individuals and families served by the Agency and its
