4	It is hereby enacted by the General Assembly of the State of Vermont:
5	Sec. 1. 18 V.S.A. § 7260 is added to read:
6	§ 7260. MENTAL HEALTH RESPONSE SERVICE GUIDELINES
7	(a) The Department shall develop guidelines for use by municipalities,
8	including use by emergency medical technicians and public safety personnel,
9	such as law enforcement officers as defined by 20 V.S.A. § 2351a and
10	firefighters as defined in 20 V.S.A. § 3151, who are employed, volunteer, or
11	are under contract with a municipality. The guidelines shall recommend best
12	practices for de-escalation and for mental health response services, including
13	crisis response services. The Department shall make the guidelines available
14	to municipalities and publish the guidelines on the Department's website.
15	(b) In developing the guidelines required pursuant to subsection (a) of this
16	section, the Department shall consult with the following entities:
17	(1) the Department of Health;
18	(2) the Department of Disabilities, Aging, and Independent Living;
19	(3) the Department of Public Safety;
20	(4) the Vermont Care Partners;
21	(5) the Vermont Psychiatric Survivors;

1	(6) the Vermont chapter of the National Alliance on Mental Illness;
2	(7) the Vermont Criminal Justice Council;
3	(8) the Vermont League of Cities and Towns; and
4	(9) any other entity the Department deems appropriate.
5	Sec. 2. PRESENTATION; SOCIAL SERVICE PROVIDER SAFETY
6	(a) On or before November 15, 2024, the Agency of Human Services, in
7	collaboration with the Vermont chapter of the National Association of Social
8	Workers, shall convene one or more meetings related to social service provider
9	safety with community-based social service organizations.
10	(1) The following community-based social service organizations and
11	professions may be included in the meeting or meetings described in this
12	subsection:
13	(A) the Vermont Network Against Domestic and Sexual Violence;
14	(B) the Vermont Coalition to End Homelessness;
15	(C) mental health and health care providers;
16	(D) community action programs;
17	(E) restorative justice service providers; and
18	(F) disability service providers and advocates.
19	(2) In advance of the meeting or meetings described in this subsection,
20	the participating community-based social service organizations and professions

1	may review both studies related to social service provider safety and individual
2	social service provider safety experiences.
3	(b) On or before January 31, 2025, the Agency of Human Services, in
4	collaboration with the Vermont chapter of the National Association of Social
5	Workers, shall present findings and recommendations to the House Committee
6	on Human Services and the Senate Committee on Health and Welfare,
7	including a list of the community-based social service organizations that
8	participated in the meeting or meetings and the number of meetings convened.
9	Sec. 3. 33 V.S.A. § 6309 is added to read:
10	§ 6309. STAFF SAFETY; DISCHARGE FROM SERVICE
11	If an individual was previously discharged from service by a home health
12	agency to protect the safety of staff in accordance with the rules adopted by the
13	Department of Disabilities, Aging, and Independent Living pursuant to
14	subsection 6303(a) of this chapter, and the behavior or conditions causing the
15	discharge cannot be mitigated or eliminated, a home health agency may:
16	(1) deny a subsequent admission; or
17	(2) decline to send a home health agency employee to make a visit if the
18	home health agency has reason to believe that the individual who exhibited the
19	behavior that resulted in the discharge is present in the home.
