#### Joint Resolution Adopted on the Part of the Senate

#### J.R.S. 41.

Joint Senate resolution of the following title was read the third time and adopted on the part of the Senate:

Joint resolution requesting that the U. S. Postal Service reestablish, as rapidly as possible, a full-service U.S. Post Office in downtown Montpelier.

#### **Proposal of Amendment; Third Reading Ordered**

### H. 518.

Senator Vyhovsky, for the Committee on Government Operations, to which was referred House bill entitled:

An act relating to the approval of amendments to the charter of the Town of Essex.

Reported recommending that the Senate propose to the House to amend the bill in Sec. 2, 24 App. V.S.A. chapter 117 (Town of Essex), in section 701 (fiscal year), following the words "first day of July" by striking out the words "and end on the last day of June"

And that the bill ought to pass in concurrence with such proposal of amendment.

Thereupon, the bill was read the second time by title only pursuant to Rule 43, the proposal of amendment was agreed to, and third reading of the bill was ordered.
