

Median household income, adjusted for inflation, 2013-2023





Joblessness hit 20-year lows in 2023


Vermont annual average U-3 and U-6 unemployment, 2003-2023



Fewer than half of single-adult households with or without kids could meet basic needs Share of households with sufficient income to meet basic needs, by family type, 2021-2022





Homeless Vermonters with and without shelter, Jan 2019-Jan 2024



costs Percent of households with income under \$75,000 in unaffordable housing, by unit type, 2018 and 2023






Average prices and wage as a percentage of U.S. averages, New England states, 2022

Poverty for Vermonters of color was higher than the state average Poverty rates by race and Vermont average, with margin-of-error bars, 2022



funding Total Vermont budget appropriations by funding source, in billions, FY2014-FY2025



Appropriations by major spending category, FY2025



State programs help Vermonters afford childcare, housing, and other basic needs, but more is needed Individual wellbeing supports and housing investments, by subcategory, FY2025






Vermont relies on income, property and consumption taxes in addition to federal funds Revenues by major category, FY2025




