10	Statement of purpose of bill as introduced: This bill proposes to require the
11	Agency of Education, in conjunction with the Agency of Agriculture, Food and
12	Markets, to develop a statewide agriculture and nutrition education curriculum
13	and the State Board of Education and supervisory unions to ensure agriculture
14	and nutrition education is included in education quality standards and union-
15	wide curriculum. This bill also proposes to amend the minimum course of
16	study to include agriculture and nutrition education as a part of the natural
17	sciences field.

5	(a) The Secretary, in conjunction with the Agency of Agriculture, Food and
6	Markets, shall develop an agriculture and nutrition education curriculum for
7	elementary and secondary schools. The curriculum shall include teaching
8	about the cultivation of food, farming practices, and nutritional benefits.
9	(b) The State Board of Education shall ensure that agriculture and nutrition
10	education is included in its education quality standards under subdivision
11	165(a)(3)(B) of this title.
12	(c) Each supervisory union shall ensure that agriculture and nutrition
13	education is included in its union-wide curriculum.

17	(b) For purposes of this title, the minimum course of study means learning
