FRUIT FARMER ASSISTANCE PROGRAM 8 (a)(1) The Agency of Agriculture, Food and Markets shall establish the 9 Fruit Farmer Assistance Program consistent with the requirements of this 10 section. (2) "Fruit" means the harvestable or harvested part of a plant developed 11 from a flower. "Fruit" includes all perennial and annual fruit, such as apples, 12 berries, grapes, pears, cherries, and peaches. "Fruit" shall not include plants 13 commonly classified as a vegetable. 14 15 (b) A farm in the State that grows fruit is eligible for assistance under this 16 section if: 17 (1) the farm is currently operating and producing fruit; 18 (2) the farm suffered production losses in calendar year 2023 due to freezing or frost conditions; 19 20 (3) the farm is in good standing with the Agency of Agriculture, Food 21 and Markets; and

9	formula for calculation of an award under this section. The formula shall

11	(A) the self-certified total production losses of a farm in calendar
