18	preponderance of the evidence that the cancer was caused by nonservice-
19	connected risk factors or nonservice-connected exposure, provided:
20	(i)(I) the firefighter completed an initial and any subsequent
21	cancer screening evaluations as recommended by the American Cancer Society

1	based on the age and sex of the firefighter prior to becoming a firefighter or
2	within two years of July 1, 2007 while serving as a firefighter, and the
3	evaluation indicated no evidence of cancer;
4	(II) the firefighter was engaged in firefighting duties or other
5	hazardous activities over a period of at least five years in Vermont prior to the
6	diagnosis; and
7	(III) the firefighter is under 65 years of age.
8	(ii) The presumption shall not apply to any firefighter who has
9	used tobacco products at any time within 10 years of the date of diagnosis.
10	(iii) The disabling cancer shall be limited to leukemia, lymphoma,
11	or multiple myeloma, and cancers originating in the bladder, brain, breast,
12	colon, gastrointestinal tract, kidney, liver, pancreas, reproductive system, skin,
13	or testicles <u>thyroid</u> .
14	(F) A firefighter who is diagnosed with cancer within 10 years of the
15	last active date of employment as a firefighter shall be eligible for benefits
16	under this subdivision. The date of injury shall be the date of the last injurious
17	exposure as a firefighter.

19	(i) maintain incident report records for at least 10 years; and
20	(ii) offer or provide annual cancer screenings to all firefighters
21	who are employed by or who volunteer for the department.

3	EQUIPMENT UPGRADES; REPORT
4	(a) On or before January 15, 2024, the Director of the Division of Fire
5	Safety shall submit a written report to the House Committees on
6	Appropriations, on Commerce and Economic Development, and on
7	Government Operations and Military Affairs and the Senate Committees on
8	Appropriations; on Economic Development, Housing and General Affairs; and
9	on Government Operations regarding the following topics:
10	(1) the projected cost for the State to fund annual or biennial cancer
11	screenings for all career and volunteer firefighters in Vermont;
12	(2) the projected cost for the State to fund cancer screenings for all
