AK S 112	Digital Product Repair	Pending	Relates to the diagnosis, maintenance, and repair of products that use digital electronics to operate, adds an unlawful act to the Alaska Unfair Trade Practices and Consumer Protection Act.
<u>CAS 244</u>	Right to Repair Act	Pending	Enacts the Right to Repair Act. Requires, with specified exceptions and regardless of whether any express warranty is made, the manufacturer of a specified electronic or appliance product, in certain circumstances, and in those same circumstances but sold to others outside of direct retail sales, to make available, on fair and reasonable terms, to product owners, service and repair facilities, and service dealers, the means to effect the diagnosis, maintenance, or repair of the product.
<u>CAS 271</u>	Powered Wheelchairs: Right to Repair	Pending	Requires an original manufacturer of a powered wheelchair to provide documentation, parts, embedded software, firmware, and tools used to inspect, diagnose, maintain, and repair the wheelchair to an owner or an independent repair provider for the purposes of providing service on the equipment in the state, on fair and reasonable terms and costs.
CO H 1011	Consumer Right To Repair Agricultural Equipment	Pending	Concerns a requirement that an agricultural equipment manufacturer facilitate the repair of its equipment by providing certain other persons with the resources needed to repair the manufacturer's agricultural equipment.
CT H 5723	Repair of Electronic Devices	Failed	Concerns the repair of electronic devices, requires electronic device manufacturers to make available the documentation, parts and tools needed to maintain, modify and repair such devices.

FL H 533	Fair Repair of Agricultural Equipment	Pending	Relates to fair repair of agricultural equipment, requires original equipment manufacturers of agricultural equipment to provide certain manufacturing, diagnostic, and repair information to independent repair providers and owners, prohibits original equipment manufacturers from excluding certain information concerning security-related functions, provides civil liability.
FL S 422	Agricultural Equipment Fair Repair Act	Pending	Relates to fair repair of agricultural equipment, cites this act as the Agricultural Equipment Fair Repair Act, requires original equipment manufacturers of agricultural equipment to make certain manufacturing, diagnostic, and repair information available to independent repair providers and owners, prohibits the original equipment manufacturers from excluding certain information concerning security-related functions.

HI H 53	Right to Repair	Pending	Requires manufacturers of digital electronic equipment to make available to owners and independent repair providers, on fair and reasonable terms, the documentation, parts, and tools used to diagnose, maintain, and repair the equipment.
HI H 645	Digital Electronic Equipment	Pending	Requires original equipment manufacturers of digital electronic equipment to make documentation, parts, and tools available to independent repair providers and owners for the purposes of diagnosis, maintenance, and repair on fair and reasonable terms, excludes certain manufacturers, dealers, distributors, and importers of certain motor vehicles or motor vehicle equipment, all-terrain sports vehicles and motorcycles, heavy construction equipment, and medical equipment valued at or over \$100,000.
HI H 1287	Right to Repair	Pending	Requires manufacturers of digital electronic equipment to make available to owners and independent repair providers, on fair and reasonable terms, the documentation, parts, and tools used to diagnose, maintain, and repair the equipment.
HI S 1105	Digital Electronic Equipment Repairs	Pending	Requires original equipment manufacturers of digital electronic equipment to make documentation, parts, and tools available to independent repair providers and owners for the purposes of diagnosis, maintenance, and repair on fair and reasonable terms, excludes certain manufacturers, dealers, distributors, and importers of certain motor vehicles or motor vehicle equipment, all-terrain sports vehicles and motorcycles, heavy construction equipment, and medical equipment valued at or over a certain amount.

HI S 1172	Powered Medical Equipment Repair	Pending	Requires manufacturers of powered medical equipment to make available to powered medical equipment owners and independent repair providers parts, equipment, tools, documentation, and training courses and materials, requires manufacturers to provide tools to repair equipment having a cost greater than or equal to a certain amount, creates a right of action by the Attorney General for certain violations of the state's medical device right to repair laws.
<u>IA H 587</u>	Consumer Rights to Repair Specified Goods	Pending	Relates to consumer rights to repair specified goods, and provides penalties.
IL H 3593	Digital Electronic Equipment Right to Repair Act	Pending	Creates the Digital Electronic Equipment Right to Repair Act, provides that, for digital electronic equipment and parts for digital electronic equipment sold or used in the state, an original equipment manufacturer shall make available to an independent repair provider, solely for the purpose of repairing digital electronic equipment, on fair and reasonable terms, any documentation, parts, service access methods, and tools, including, but not limited to, any updates to information.
IL H 3601	Educational Technology Right to Repair Act	Pending	Creates the Educational Technology Right to Repair Act, provides that for educational technology equipment and parts for educational technology equipment sold or used in the state, an original equipment manufacturer shall make available to an independent repair provider, solely for the purpose of repairing educational technology equipment, on fair and reasonable terms, any documentation, parts, service access methods, and tools, including, but not limited to, any updates to information.
IL H 3602	Powered Wheelchair Right to Repair Act	Pending	Creates the Powered Wheelchair Right to Repair Act, provides that, for powered wheelchairs and parts for powered wheelchairs sold or used in the state, an original equipment manufacturer shall make available to an independent repair provider, solely for the purpose of repairing powered wheelchairs, on fair and reasonable terms, any documentation, parts, service access methods, and tools, including, but not limited to, any updates to information, firmware, or embedded software that is needed for purpose.

NY A 1285	Sale of Digital Electronic Equipment	Enacted	Relates to the sale of digital electronic equipment and providing diagnostic and repair information, provides that an original equipment manufacturer who, in the regular course of business, offers to an owner the services of diagnosis, maintenance or repair of its own digital electronic equipment, and who does not have an arrangement with an unaffiliated individual or business, shall be considered an authorized repair provider with respect to such equipment.
