~~Enrollments in home study programs shall expire on July 1. If a home study~~

~~program intends to re-enroll a child for the following school year, a new notice~~

~~under this section is required and may be submitted at any time after March 1.~~

A parent or legal guardian shall send the Secretary annual notice of intent to

11

enroll the parent's or legal guardian's child in a home study program at least

10 business days prior to commencing home study. Such notice shall be

6 in the development of school curriculum;

7 (6) the designee of the Vermont Curriculum Leaders Association;

8 (7) the Vermont Coalition for Ethnic and Social Equity in Schools

9 appointee member from Outright Vermont;

10 (8) the Vermont-based, college-level faculty expert in ethnic studies;

11 (9) the designee of the Vermont Office of Racial Equity;

12 (10) the student appointee from Montpelier High School;

13 (11) the designee of the Vermont Independent Schools Association; and

14 (12) the designee of the Agency of Education.

15 (c) Powers and duties. The Advisory Group shall provide assistance to the

16 General Assembly, the Agency of Education, and the State Board of Education

17 on the following recommendations made by the Working Group:

18 (1) proposed revisions and comments to Agency of Education, State

19 Board Rule 2000 Education Quality Standards (CVR 22-000-003);

20 (2) recommended updates and additional standards for student

21 performance proposed to the State Board of Education pursuant to 2019 Acts

1 and Resolves No. 1, Sec. 1, subdivision (g)(1);

2 (3) policy recommendations submitted to the General Assembly; and

3 (4) any other recommendations submitted to the General Assembly or
4 State Board of Education.

5 (d) Assistance. The Advisory Group shall have the assistance of the
6 Agency of Education for the purposes of scheduling meetings.

9 Group as of August 31, 2023. If a member resigns before the Advisory Group
10 ceases to exist, the organization impacted by the resignation shall have the
