3	Subject: Education; school construction; facilities; grant program; PCBs
4	Statement of purpose of bill as introduced: This bill proposes to:
5	(1) create the Facilities Master Plan Grant Program to support
6	supervisory unions and independent career and technical education districts to
7	support the development of a master plan that complies with State construction
8	aid requirements;
9	(2) require the Department of Buildings and General Services to
10	establish a list of prequalified architecture and engineering consultants;
11	(3) create the State Aid for School Construction Working Group to
12	study and design a plan for a statewide school construction aid program; and
13	(4) require the Joint Fiscal Office to model stable perpetual revenue
14	sources to fund a statewide school construction aid program.
15 16	An act relating to the development of an updated State aid to school construction program
17	It is hereby enacted by the General Assembly of the State of Vermont:

1	Sec. 1. 16 V.S.A. § 3441 is added to read:
2	§ 3441. FACILITIES MASTER PLAN GRANT PROGRAM; REPORT
3	(a) Intent. It is the intent of the General Assembly that the Facilities
4	Master Plan Grant Program established pursuant to this section shall enable
5	supervisory unions to develop a supervisory union level vision for all school
6	buildings that meets the educational needs and goals of the supervisory union.
7	The goal of a facilities master plan shall be to facilitate an evaluation of the
8	capacity of existing facilities to deliver on identified 21st century educational
9	goals. A facilities master plan shall also enable and require supervisory unions
10	to engage in intentional and robust conversations with the larger community
11	that will hopefully lead to the successful passage of bonds needed to support
12	the renovation or construction needs of the supervisory union.
13	(b) Establishment. There is established the Facilities Master Plan Grant
14	Program to be administered by the Agency of Education, from funds
15	appropriated for this purpose, to supervisory unions and independent career
16	and technical education districts to support the development of educational
17	facilities master plans. Grant funds may be used to hire a consultant to assist
18	in the development of the master plan with the goal of developing a final
19	master plan that complies with State construction aid requirements
20	(c) Standards for the disbursement of funds. The Agency shall develop
21	standards for the disbursement of grant funds in accordance with the following:

1	(1) Grants shall be awarded to applicants with the highest facilities
2	needs. The Agency shall develop a prioritization formula based on an
3	applicant's poverty factor and average facilities condition index score. The
4	Agency shall develop or choose a poverty metric to use for the prioritization
5	formula. The Agency may give priority to applications with a regionalization
6	focus that consist of more than one supervisory union or independent career
7	and technical education district that apply as a consortium.
8	(2) Award amounts shall be commensurate with the gross square
9	footage of buildings located within the applicable supervisory union or career
10	and technical education district.
11	(3) Grants shall include a funding match from other sources, including
12	grants from businesses, foundations, or other federal or local funding, in an
13	amount equal to [decision point—flat rate or tiered based on need]
14	(4) The Agency shall develop minimum requirements for an educational
15	facilities master plan, which shall include, at a minimum, the following
16	elements:
17	(A) a description of the educational mission, vision, and goals of the
18	supervisory union;
19	(B) a description of educational programs and services offered by the
20	supervisory union;
21	(C) the performance of a space utilization assessment;

1	(D) the identification of new program needs;
2	(E) the development of enrollment projections;
3	(F) the performance of a facilities assessment; and
4	(G) information regarding the various design options explored to
5	address the supervisory union's identified needs.
6	(d) Report. Annually on or before December 31, the Agency shall submit
7	to the House and Senate Committees on Education a written report with
8	information on the implementation of the grant program created in this section.
9	Sec. 2. REPEAL; FACILITIES MASTER PLAN GRANT PROGRAM

12	Sec. 3. PREQUALIFIED ARCHITECTURE AND ENGINEERING
13	CONSULTANTS
14	On or before October 15, 2024, the Department of Buildings and General
15	Services shall assist the Agency of Education in developing prequalification
16	criteria for architecture and engineering firms specializing in prekindergarten
17	through grade 12 school design and construction.

1	Sec. 4. STATE AID FOR SCHOOL CONSTRUCTION WORKING GROUP
2	REPORT
3	(a) Creation. There is created the State Aid for School Construction
4	Working Group to study and design a plan for a statewide school construction
5	aid program.
6	(b) Membership. The Working Group shall be composed of the following
7	members:
8	(1) three current members of the House of Representatives, not all from
9	the same political party, who shall be appointed by the Speaker of the House;
10	(2) three current members of the Senate, not all from the same political
11	party, who shall be appointed by the Committee on Committees; and
12	(3) the Secretary of Education, or designee.
13	(c) Powers and duties.
14	(1) The Working Group shall study and create a recommended plan for
15	a statewide school construction aid program, including recommendations on
16	implementation. To facilitate its understanding of school construction projects
17	and other school construction state aid programs, the Working Group may
18	travel to conduct site visits at schools or other state programs. In creating its
19	recommendations, the Working Group shall address the following topics,
20	building from the recommendations contained in the report of the School

1	Construction Aid Task Force, created in 2023 Acts and Resolves No. 78, Sec.
2	<u>E.131.1:</u>
3	(A) Governance. The Working Group shall study other state
4	governance models for school construction aid programs, including inviting
5	testimony from school officials from those states, and make a recommendation
6	for a governance model for Vermont that aligns with the other funding and
7	programmatic recommendations of the Working Group. Governance
8	recommendations shall include recommendations on staffing levels and a
9	stable appropriation for the funding of the recommended governance structure.
10	(B) Prioritization criteria. The Working Group shall make
11	recommendations on state aid prioritization criteria that will drive funding
12	towards projects that are aligned to the State's educational policies and
13	priorities.
14	(C) Eligibility criteria. The Working Group shall consider the
15	following state aid eligibility criteria:
16	(i) appropriate maintenance and operations budgeting at the
17	supervisory union level;
18	(ii) a requirement for eligible supervisory unions to have a five
19	year capital plan;

1	(iii) a facility condition index maximum level that would preclude
2	eligibility but may qualify a building for a State share percentage bonus to
3	replace the building;
4	(iv) a requirement for a supervisory union master planning process
5	that would require consideration of the adaptive reuse of schools for housing or
6	other social infrastructure; and
7	(v) a prohibition on exclusionary zoning regulations that would
8	preclude lesser resourced families from living in the applicable school district.
9	(D) State base share. The Working Group shall make
10	recommendations for tiered levels of State support based on student or
11	community poverty factors. The Working Group shall consider factors such as
12	local taxing capacity, student poverty data, environmental justice metrics, and
13	energy burden metrics.
14	(E) Incentives. The Working Group shall consider the use of
15	incentives or State share bonuses that align with Vermont's educational
16	priorities with the goal of using taxpayer supported school construction aid to
17	improve student learning environments and opportunities. The Working
18	Group shall consider appropriate limits on cumulative incentives and whether
19	incentives shall be bundled for eligibility. Policy areas to consider for
20	incentives include:
21	(i) school safety and security;

1	(ii) health;
2	(iii) educational enhancements;
3	(iv) overcrowding solutions;
4	(v) environmental performance:
5	(vi) newer and fewer buildings;
6	(vii) major renovations to improve PreK-12 systems educational
7	alignment and capacity;
8	(viii) replacement of facilities with a current facility condition
9	index of 65 percent or higher, in combination with other policy area incentives;
10	<u>and</u>
11	(ix) schools identified with actionable levels of airborne PCBs in

1	(III) a district to complete a full commissioning process as a
2	requirement to receive State funds at the end of the project; and
3	(IV) a clerk of the works throughout the lifespan of the project.
4	(ii) The Working Group shall also consider whether the assurance
5	and certification process shall be eligible for State funding support, as well as
6	whether a preferred vendor list for the commissioning process and clerk of the
7	works is advisable.
8	(G) Environmental hazards and contaminants. The Working
9	Group shall make recommendations that approach environmental hazards and
10	contaminants in a comprehensive manner, incorporating existing programs into
11	the school construction aid program where possible.
12	(H) Pre-program construction aid. The Working Group shall
13	consider whether and to what extent State aid should be made available to
14	school districts that begin construction projects prior to the establishment or
15	renewal of a State school construction aid program.
16	(I) Current law. The Working Group shall review State statutes and
17	State Board of Education rules that concern or impact school construction and
18	make recommendations to the General Assembly for any amendments
19	necessary to align with the Working Group's proposed construction aid
20	program.

1	(J) Efficiencies. The Working Group shall identify areas where
2	economizations or efficiencies might be gained in the creation of the program,
3	including consideration of the following:
4	(i) a prequalification process for consultants with experience in the
5	planning, renovation, and construction of kindergarten through grade 12
6	schools; and
7	(ii) cost containment strategies such as the use of building
8	templates for new construction.
9	(K) Fiscal modeling. The Working Group shall align the proposed
10	construction aid program with fiscal modeling produced by the Joint Fiscal
11	Office.
12	(L) School Construction Planning Guide. The Working Group
13	shall review the Vermont School Construction Planning Guide and make
14	recommendations for any amendments necessary to align with the Working
15	Group's proposed construction aid program.
16	(M) Additional considerations. The Working Group may consider
17	any other topic, factor, or issue that it deems relevant to its work and
18	recommendations.
19	(2) The Working Group shall consult with the following entities in
20	developing its proposed plan to ensure all applicable areas of Vermont law and
21	federal funding opportunities are taken into consideration:

1	(A) the Agency of Education;
2	(B) the Agency of Natural Resources;
3	(C) the Department of Public Safety, Division of Fire Safety;
4	(D) the Natural Resources Board;
5	(E) the Agency of Commerce and Community Development,
6	Division for Historic Preservation;
7	(F) the U.S. Department of Education;
8	(G) U.S. Department of Agriculture, Rural Development; and
9	(H) any other entity the Working Group deems relevant to its work.
10	(d) Assistance. The Working Group shall have the administrative,
11	technical, and legal assistance of the Agency of Education, the Office of
12	Legislative Counsel, the Joint Fiscal Office, and the Office of Legislative
13	Operations.
14	(e) Proposed legislation. On or before December 15, 2024, the Working
15	Group shall submit its findings and recommendations in the form of proposed
16	legislation to the General Assembly.
17	(f) Meetings.
18	(1) The Office of Legislative Counsel shall call the first meeting of the
19	Working Group to occur on or before August 1, 2024.

1	(2) The Working Group shall select co-chairs from among its members
2	at the first meeting, one a member of the House and the other a member from
3	the Senate.
4	(3) A majority of the membership shall constitute a quorum.
5	(4) The Working Group shall cease to exist on December 31, 2024.
6	(g) Compensation and reimbursement. For attendance at meetings during
7	adjournment of the General Assembly, members of the Study Committee shall
8	be entitled to per diem compensation and reimbursement of expenses pursuant
9	to 2 V.S.A. § 23 for not more than 10 meetings. These payments shall be
10	made from monies appropriated to the General Assembly.
11	Sec. 5. APPROPRIATION; STATE AID FOR SCHOOL CONSTRUCTION
12	WORKING GROUP
13	The sum of \$15,000.00 is appropriated from the General Fund to the
14	General Assembly in fiscal year 2025 for the purpose of funding travel by the
15	State Aid for School Construction Working Group pursuant to Sec. 4,
16	subsection (c) of this act.
17	Sec. 6. REVENUE SOURCES
18	On or before December 1, 2024, the Joint Fiscal Office shall model
19	potential sources of funding to sustainably support a school construction aid

- program. Modeling shall be performed at the direction of the State Aid for
- 2 School Construction Working Group.
- 3 Sec. 7. EFFECTIVE DATE
- 4 This act shall take effect on July 1, 2024.
