Re: Support of proposed amendment to S. 103, An act relating to amending the prohibitions on discrimination.

The LGBTQIA Alliance of Vermont would like to take this opportunity to support eliminating the "severe or pervasive" standard for harassment in places of public accommodation and employment, including schools currently being considered during the committee debate on S. 103, An act relating to amending the prohibition on discrimination.

I appreciate the committee has recently taken up this bill and is attempting to act quickly on it, so my comments will be brief.

Since the founding of Outright VT in 1989, leaders within VT's LGBTQ+ communities have been hearing stories from our youth describing how they have encountered bullying and harassment within their school environments. Despite Vermont's commitment to working towards inclusion and equity, we have continued to hear these stories. The information gathered via the VT Department of Health Youth Risk Behavior Survey (YRBS), started in 1993 and repeated every 2 years, has supported that the stories being shared were not isolated to a particular school or region of Vermont. These incidents of bullying and harassment can, and do, occur statewide. The surveys have shown these incidents have remained prevalent for the LGBTQ+ respondents.

Listening to the recounts from our youth they have expressed how they felt unsupported by school staff/administration when they reported incidents. Some were left with the impression that what they were experiencing was not severe enough to warrant a response or intervention, the actions were being condoned, or that they should merely be tolerated. Although some actions could be viewed as microaggressions, being subjected to these actions on an ongoing basis can have a noticeable and adverse impact on the person to whom they are directed. The YRBS results have indicated that a higher percentage of LGBTQ+ youth have skipped school to avoid being subjected to these actions. However, in this age of social media, it should be acknowledged that not all incidents occur in-person.

The language in the proposed draft would encourage, and allow schools, to view reported incidents with a broader and more comprehensive appreciation of the ongoing impact they have on LGBTQ+ youth.

While I have only specifically referenced LGBTQ+ youth, as that is the group with whom I have had direct contact, I want to acknowledge that they are not the only group subjected to bullying and harassment. Unfortunately, it is an experienced shared with other underrepresented populations, such as BIPOC, people living with a disability, new Americans, people experiencing housing insecurity, people experiencing food/economic insecurity, etc.

Thank you for including this brief statement of support in your committee discussion.
