Common Terms

- ESSER: Elementary and Secondary School Emergency Relief fund
- LEA: Local Education Entity (in Vermont, this is our Supervisory Unions and Supervisory Districts (SU/SDs)
- **SEA**: State Education Entity (the Vermont Agency of Education, AOE)
- **Period of performance**: the period of time in which an LEA/SEA needs to obligate or encumber its funds. Any funds not obligated must be returned to the federal government








ARP ESSER Spending Mandates


LEA Spending Mandates


