1 Sec. X. PCB TESTING AND REMEDIATION IN SCHOOLS 2 (a) If a school is required to test for the presence of polychlorinated 3 biphenyls (PCBs) pursuant to 2021 Acts and Resolves No. 74, Sec. E.709.1, 4 the Agency of Natural Resources (ANR) shall conduct the testing or pay for 5 testing conducted by the school. 6 (b) It is the intent of the General Assembly that ANR shall seek to hold the 7 manufacturers of PCBs liable under 10 V.S.A. § 6615 for the cost of PCB 8 investigation, remediation, and removal in schools. Prior to any judgment or 9 settlement under which PCB manufacturers pay for PCB investigation, 10 remediation, and removal in schools, it is the intent of the General Assembly as 11 signified by 2023 Acts and Resolves No. 78, Sec. C.112, that the State of 12 Vermont shall pay for the costs of investigation, remediation, and removal of PCBs at any school where testing under 2021 Acts and Resolves No. 74, Sec. 13 14 E.709.1 exceeded the State school action levels. When a judgement or 15 settlement is reached under which PCB manufacturers pay for PCB 16 investigation, remediation, and removal in schools, any funds received under the judgment or settlement related to PCBs in schools shall first be used to 17 18 reimburse the State for the costs related to investigation, remediation, and 19 removal of PCBs at schools that exceeded the State school action levels. Any 20 reimbursed monies shall be deposited into the Fund from which the money was 21 expended.

1	(c)(1) Beginning on July 1, 2024, and every month thereafter, the Secretary
2	of Education, after consultation with the Secretary of Natural Resources, shall
3	report to the Joint Fiscal Committee Secretary of Administration the following
4	information regarding the funds appropriated to the Agencies Agency of
5	Education and Natural Resources in 2023 Acts and Resolves No. 78, Sec.
6	C.112 and subsequent appropriations for grants for investigation, remediation,

2 Board. 3 (3) If the Secretary of Natural Resources Education fails to submit a 4 report required by this subsection to the Joint Fiscal Committee Secretary of 5 Administration, a school shall not be required to initiate testing for PCBs until 6 15 days after the Secretary of Natural Resources Education has submitted a 7 required report to the Joint Fiscal Committee Secretary of Administration. 8 (d)(1) If the Secretary of Natural Resources Education reports under 9 subsection (c) of this section that there is \$2,000,000.00 or less of funds 10 remaining for the investigation, remediation, and removal of PCBs, ANR shall 11 not initiate testing or payment for initial testing for PCBs at a school under 12 subsection (a) of this section, and a school shall not be required to initiate 13 testing for PCBs until such time as the General Assembly enacts a 14 comprehensive plan for funding PCB investigation, remediation, and removal 15 of PCBs in schools or as provided in subdivision (2) of this subsection. 16 (2) If initial testing of a school for PCBs is paused under subdivision (1) 17 of this subsection when the General Assembly is not in session, the Emergency 18 Board is authorized to transfer \$2,000,000.00 to the Agency of Education for 19 the purpose of providing grants to schools for the investigation, remediation, 20 and removal of PCBs. 1	(e) If a school tested positive for the presence of PCBs in excess of the
2	school action levels and the State lacks sufficient funds for the investigation,
3	remediation, and removal of PCBs in the school, the Secretary of Natural
4	Resources Education shall submit to the House Committees on Education and
5	on Appropriations and the Senate Committees on Education and on
6	Appropriations the amount of funds that the General Assembly should
7	appropriate to the Agency of Education to sufficiently fund investigation,
8	remediation, and removal of PCBs in the school.
9	(f) Notwithstanding subsection (b) of this section and the intent of the
10	General Assembly to pay for the investigation, remediation, and removal of
11	PCBs in schools, the State of Vermont shall not pay for the costs of
12	investigation, remediation, and removal of PCBs in schools when the
13	investigation, remediation, and removal was not in response to indoor air
14	testing required pursuant to 2021 Acts and Resolves No. 74, Sec. E.709.1 but
15	was part of a planned renovation or construction project at a school under
16	which the PCBs would be remediated or removed as part of the project. This
17	subsection shall not apply to the \$16,000,000.00 reserved for the Burlington
