We, the undersigned, fully support the request from the Vermont Association of Conservation Districts (VACD) to increase base funding for the State's 14 Natural Resources Conservation Districts by \$2,638,000 for a total base appropriation of \$3,000,000 for fiscal year 2024.

Vermont's Conservation Districts are trusted and effective members of the agricultural and conservation communities. District staff and board members maintain a wealth of skills, information and relationships necessary to help local land stewards and communities address natural resource concerns.

By working with landowners, Conservation Districts help people steward their land for the future and build climate resilience for our state.
