# FY23 Climate Investments, in brief

- FY23 budget invested more than \$200 million of one-time monies in climate-related initiatives
  - Nearly \$160 million of ARPA
  - \$40 million in general fund
- Work actively underway includes:
  - Expanded weatherization \$80,000,000
  - Installation of EV charging infrastructure
  - Providing EV purchase incentives
  - Electrical System Upgrades/Advanced Metering
  - Supporting municipal energy resilience
  - Mitigating flood hazards
  - Investing in natural and working lands

\$80,000,000 \$12,000,000 \$20,000,000 \$27,000,000 \$45,000,000 \$15,000,000 \$5,760,000



# Base Budget: Climate Office "true up"

- Climate Action Office (CAO) was created with the FY23 budget
  - Eight positions in total
    - Climate Office Director
    - Climate Change Mitigation Manager
    - Climate Change Policy and Modeling Coordinator
    - Resilience and Adaptation Coordinator
    - Natural and Working Lands Coordinator
    - Climate Data Analyst
    - Community Engagement and Communications Coordinator
    - Grants and Contracts Manager
  - To date, four positions have been filled and three are currently under recruitment



• FY24 budget adjusts base funding to meet actual staff salaries

### **One-Time Appropriations: Climate Office**

Technical Analyses, Tools and Training:

\$900,000

- On-going evaluation, development, implementation support and tracking the impact of programs and policy approaches to reduce GHG emissions and improve landscape-level resilience consistent with the Global Warming Solutions Act
  - Thermal Sector Program
    \$400,000
  - Measuring and Assessing Progress (MAP) Tool, Phase 2
    \$250,000
  - Municipal Vulnerability Index roll-out
    \$150,000
  - Cost Abatement Curve for Resilience/Adaptation
    \$100,000



# **One-Time Appropriations: Climate Office**

Clean Heat Homes:

\$5,000,000 (PSD)

- A "single-point program" to help Vermonters with whole home climate improvements, supported by on-bill financing
  - Weatherization
  - Clean heat systems
  - Electrification-ready upgrades
- Administered by VEIC, in partnership with VHFA and VGS
- Focused on low- and moderate-income Vermonters
  - Complements the existing Home Weatherization Assistance Program (HWAP)
  - Focused on underserved households who are not HWAP eligible but earn less than 120% of Area Median Income
- Expands \$8.5 million Congressionally-Directed Spending award secured by Senator Leahy



### **One-Time Appropriations: Climate Office**

Refrigerant Management:

\$700,000

- Expands VEIC program to help stores phase-out use of refrigerants with high global warming potential (GWP)
  - Funding will support work with ~75 stores in FY 2024
  - Focus on General Stores and small convenience store
- Will provide direct technical and financial assistance to store owners
- Leverages \$350,000 of funding thru VEIC
- Anticipated to support
  - 30 permanent leak detection systems
  - 30 low GWP condensing units
  - 30 low GWP packaged walk-in units



## Environmental Justice Budget Initiative

- FY24 Governor's Recommend includes:
  - ANR
    - \$300,000 in one-time GF to provide one year of additional support for the three staff positions at ANR
  - Office of Racial Equity
    - \$700,000 in base GF to the Office of Racial Equity to provide whole-of-government services around language access
    - \$2.3 million in one-time GF to the Office of Racial Equity to support "catch up" in the translation of vital documents statewide
- General Assembly's plan for fully funding on-going costs of EJ work required by Act 154 is unclear
  - On-going staff costs
  - Completing/maintaining mapping tool
  - Advisory Council support/facilitation
  - Community engagement stipends
