

Sec. __. 7 V.S.A. § 909a is added to read:

§ 909a. LIMITED EVENT PERMIT

- (a) A cannabis retail establishment licensed and in good standing with the Board may apply to the Board for a limited event permit.
- (b) Notwithstanding 7 V.S.A. chapter 31, a limited event permit issued under this section shall confer upon the recipient cannabis retail establishment authority to coordinate, oversee, and be the responsible administrator of a single, defined social or commercial event, held at a defined access-controlled location, for a defined period not to exceed 24 hours, at which cannabis or cannabis products lawfully may be transported, possessed, sold, and consumed by participants acting in conformity with terms set out by the Board in the issued permit.
- (c) To be eligible for a limited event permit, an applicant must demonstrate to the Board's satisfaction:
 - (1) written approval for the permit by the local cannabis control commission as authorized under 7 V.S.A. chapter 33;
 - (2) a security plan to ensure persons under 21 years of age cannot access the space subject to the permit, that the premises are secured from diversion or inversion, and that the premises lawfully may be used for the purpose intended;
 - (3) a safe transportation plan to ensure attendees who require motor vehicle transport from the event are transported by an insured driver who has not consumed cannabis, alcohol, or any other intoxicating substance;
 - (4) a product sale plan that explains how any cannabis or cannabis products, if any, to be sold, given, provided, or otherwise available to event attendees will be labeled, tracked, and sold in conformity with State law and Board rule;
 - (5) actual capacity and intent to administer and enforce its written plans for security, safe transportation, and if applicable, product sale; and
 - (6) compliance with such other requirements as the Board may by rule prescribe.

Sec. __. 7 V.S.A. § 909b is added to read:

§ 909b. LIMITED EVENT PROVIDER ENDORSEMENT

- (a) A cannabis retail establishment licensed and in good standing with the Board may apply to the Board for a limited event provider endorsement.
- (b) Notwithstanding 7 V.S.A. chapter 31, a limited event provider endorsement issued under this section shall confer upon the recipient cannabis retail establishment authority to host, at a single defined and approved location, events at which cannabis or cannabis products at which cannabis or cannabis products lawfully may be transported, possessed, sold, and consumed by participants acting in conformity with terms set out by the Board in the issued endorsement.
- (c) The minimum requirements for a limited event provider endorsement under this section, 909b, shall include those applicable to a limited event permit pursuant to section 909a.
- (d) A limited event provider endorsement issued under this section shall attach to the active cannabis establishment license of the bearer, shall be valid for no longer than the

underlying cannabis establishment license, and shall specify the maximum number and frequency of events permitted.

Sec___. 7 V.S.A. § 910 is amended to read:

The following fees shall apply to each person or product licensed by the Board:

(12) Event fees.

(A) Application. Cannabis establishments shall be assessed a fee of \$250 to apply for a limited event permit or endorsement under sections 909a and 909b of this chapter.

(B) Event. The bearer of a permit or endorsement shall be assessed a limited event fee of \$500 for each limited event authorized or held.
