12	and Ireland. The Commission shall consist of nine members to be appointed as

14	(1) three members, appointed by the Governor;	
15	(2) three members, appointed by the Speaker of the House; and	
16	(3) three members, appointed by the President Pro Tempore of the	
17	Senate.	
18	(b) The purposes of the Vermont-Ireland Trade Commission are to:	
19	(1) advance bilateral trade and investment between Vermont and

9	(c) The members of the Commission shall be appointed for terms of four		
10	years each and shall continue to serve until their successors are appointed,		
11	except that in order to achieve staggered terms, the three members appointed		
12	by the Governor shall serve initial terms of two years each and the three		
13	members appointed by the President Pro Tempore of the Senate shall serve		
14	initial terms of three years each. Members may be reappointed.		
15	(d) A vacancy in the membership of the Commission shall be filled by the		
16	relevant appointing authority within 90 days after the vacancy.		
17	(e) The Commission shall select a chair from among its members at the		
18	first meeting. The Chair, as appropriate, may appoint from among the		
19	Commission members subcommittees or a subcommittee at the Chair's		
20	discretion. A majority of the members of the Commission shall constitute a		
21	quorum for purposes of transacting the business of the Commission.		

1	(f) The Commission shall submit a written report with its findings, results,		
2	and recommendations to the Governor and the General Assembly within one		
3	year of its initial organizational meeting and on or before November 1 of each		
4	succeeding year for the activities of the current calendar year.		
5	(g) The Vermont-Ireland Trade Commission is authorized to raise funds,		
6	through direct solicitation or other fundraising events, alone or with other		
7	groups, and accept gifts, grants, and bequests from individuals, corporations,

20	is repealed on June 30, 2029.
