2023 Vermont Law Enforcement Agency Drone Use

This document serves as the 2023 reporting requirement mandated by Section 4624 of Title 20. By statute, law enforcement agencies are required to send the Department of Public Safety (DPS) information related to any drone use within the previous 12 months. *See* 20 V.S.A. § 4624(a). Annually, DPS must forward the information collected pursuant to subsection (a) of this statute to the House and Senate Committees on Judiciary and on Government Operations. *See* 20 V.S.A. § 4624(b).

Vermont law enforcement agencies must report to DPS the following information:

- (1) The number of times the agency used a drone within the previous 12 months. For each use of a drone, the agency shall report the type of incident involved, the nature of the information collected, and the rationale for deployment of the drone.
- (2) The number of criminal investigations aided and arrests made through use of information gained by the use of drones within the previous 12 months, including a description of how the drone aided each investigation or arrest.
- (3) The number of times a drone collected data on any person, home, or area other than the target of the surveillance within the previous 12 months and the type of data collected in each instance.
- (4) The cost of the agency's drone program and the program's source of funding.

See 20 V.S.A. § 4624(a).

In accordance with statute, DPS submits the following 2023 law enforcement drone usage information received from the Vermont State Police, Burlington Police Department & Milton Police Department:

\*The Department of Public Safety is not knowingly in receipt of any reports or information documenting the use of drones from other municipal, county or state law enforcement agencies\*

- 1. The number of times the agency used a drone within the previous 12 months. For each use of a drone, the agency shall report the type of incident involved, the nature of the information collected, and the rationale for deployment of the drone.
  - The Vermont State Police report deploying a drone 159 times in 2023. See Appendix (A)\* for type of incident involved, nature of information collected and reason for deployment
  - The Burlington Police Department report deploying a drone 1 time in 2023. See Appendix (B)\* for type of incident involved, nature of information collected and reason for deployment.
  - The Milton Police Department reported one (1) deployment in the last 12 months. See Appendix (C)\* for type of incident involved, nature of information collected and reason for deployment.
- 2. The number of criminal investigations aided and arrests made through use of information gained by the use of drones within the previous 12 months, including a description of how the drone aided each investigation or arrest.
  - The State Police used drones to support investigations 134 times. 56 times drones were used to capture images of serious/fatal motor vehicle crashes, 25 times for documenting various crime scenes, 17 times to capture aerial images of fire/arson scenes, and 36 times to locate and observe the actions of subjects that were determined to possess a risk of harm to officers or the public.
  - State Police drones were used to aid investigations by capturing images, and/or video, and/or providing non-recorded real-time video feed.
  - The use of State Police drones and the information gained by this use was never the sole basis for an arrest.
  - Burlington Police used drones for 1 search and rescue mission for a person in Lake Champlain and in the heavily wooded area of Rock Point in Burlington, VT. The use of the Burlington Police Department drones and the information gained from their use was not the sole basis for any arrests.
  - The Milton Police Department reported that no incidents met the above reporting criteria.

- 3. The number of times a drone collected data on any person, home, or area other than the target of the surveillance within the previous 12 months and the type of data collected in each instance.
  - The Vermont State Police is not aware of any collected data on any person, home, or area other than the target of the surveillance and in accordance with Title 20 V.S.A § 4622.
  - Burlington Police Department is not aware of any data that was collected on any person, home other than the subject of a search and rescue mission on Lake Champlain.
  - The Milton Police Department reported that no information on uninvolved third parties was collected.

#### 4. The cost of the agency's drone program and the program's source of funding.

- The Vermont State Police's Unmanned Aircraft Systems (UAS) program incurred \$66.00 propellers and guards and \$729.01 in the purchase of protective cases and guards. An additional \$4,866.25 was used to purchase Remote ID modules to stay in compliance with a new FAA Remote ID requirement going into effect on March 16, 2024. These purchases were made using Vermont State Police General Funds. The State Police UAS program also received its equipment from the 2022 State Homeland Security Grant Fund. This amount was reported in last year's report and totaled \$110,658.10.
- Burlington Police Department Unmanned aerial vehicles (UAV/drone) program was created in 2023. Using equitable sharing funds the Burlington Police Department purchased (1) DJI Mavic 3 for \$3598.60 and (1) DJI Mavic 3T for \$5460.60, (4) DJI Mavic 3 Enterprise battery kits for \$2504.20, (1) DJI Mavic 3 Enterprise RTK Module for \$673.55, DJI propellers for \$36.10, 2 launch pads for \$139.98, and PIX4DMatic for crash reconstruction \$5990.00, (2) Mavic Series Equipment Set up for (\$310), Shipping fees for the equipment \$105 totaling: \$18,818.03. Burlington Police also purchased a Fast Charger system for \$809.50 using general funds. In 2023 the Burlington Police Department used \$19627.53 for the creation of their UAV/ Drone Program
- The Milton Police Department reported the following information regarding the cost of their agency's drone program. The following equipment was purchased using authorized forfeiture funds from the DEA asset forfeiture program. DJI Mavic 3 Thermal \$5,604.30, DJI Mavic 3 Battery Kit \$642.52, DJI Avata Public Safety Package \$2,025.00. Additional items purchased with Milton Police Department General Funds: Spare Propellers for Avata \$9.00,4x Aurora A1 flashlights for Avata \$111.80, DJI Avata Flymore Battery Kit \$279.00. The total of all costs was \$8671.62.

# • <u>Chapter 205</u>: Drones

(Cite as: 20 V.S.A. § 4624) § 4624. Reports

(a) On or before September 1 of each year, any law enforcement agency that has used a drone within the previous 12 months shall report the following information to the Department of Public Safety:

- (1) The number of times the agency used a drone within the previous 12 months. For each use of a drone, the agency shall report the type of incident involved, the nature of the information collected, and the rationale for deployment of the drone.
- (2) The number of criminal investigations aided and arrests made through use of information gained by the use of drones within the previous 12 months, including a description of how the drone aided each investigation or arrest.
- (3) The number of times a drone collected data on any person, home, or area other than the target of the surveillance within the previous 12 months and the type of data collected in each instance.
- (4) The cost of the agency's drone program and the program's source of funding.
- (b) On or before December 1 of each year that information is collected under subsection (a) of this section, the Department of Public Safety shall report the information to the House and Senate Committees on Judiciary and on Government Operations.
