9	§ 4671. CREATION OF PROGRAM	
10	The Agency of Human Services may contract or enter into agreements with	
11	qualified entities as needed to create and administer an unused drug repository	
12	program for the collection and distribution of unused drugs in Vermont, to the	
13	extent that funds are appropriated or otherwise made available for this purpose.	
14	§ 4672. AGENCY OF HUMAN SERVICES; RULEMAKING	
15	The Agency of Human Services shall adopt rules for the administration of	
16	the program, including rules regarding:	
17	(1) donations to the program, which may include donations from	
18	institutional settings in Vermont, such as pharmacies, long-term care facilities,	
19	Veterans' Administration facilities, correctional facilities, hospitals, and other	
20	facilities, as well as donations from individuals;	
21	(2) what types of drugs may be donated to the program;	

1	(3) safety criteria for donated drugs, which may include packaging	
2	requirements and inspections; and	
3	(4) patient eligibility to receive drugs from the program, which shall be	
4	available to any patient, with priority given to patients who meet one or more	
5	of the following criteria:	
6	(A) patients whose household income is below 400 percent of the	
7	federal poverty level;	
8	(B) patients who are uninsured;	
9	(C) patients who are underinsured;	
10	(D) patients who are Medicare beneficiaries and are experiencing a	
11	coverage gap in their Medicare prescription drug coverage; and	
12	(E) patients who are on a high-deductible health plan or on a plan	
13	with high co-payment requirements for prescription drugs, or both.	
14	§ 4673. LIMITATIONS ON LIABILITY	
15	Except in cases of bad faith, gross negligence, intentional misconduct, or	
16	noncompliance with the rules adopted pursuant to section 4672 of this chapter,	
17	the following persons shall not be subject to civil or criminal liability or	
18	professional disciplinary action for participating in or otherwise complying	

1	with the program established by this subchapter or rules adopted pursuant to	
2	this subchapter:	
3	(1) a person who donates or gives drugs to an eligible recipient,	
4	including a drug manufacturer; wholesaler; reverse distributor pharmacy; third	
5	party logistics provider; governmental entity; hospital or other health care	
6	facility, as defined in section 9432 of this title; or long-term care facility	
7	licensed under 33 V.S.A. chapter 71;	
8	(2) an eligible recipient, as defined by the Agency by rule pursuant to	
9	subdivision 4672(4) of this chapter;	
10	(3) a health care provider, as defined in section 9402 of this title, who	
11	prescribes or dispenses a donated drug;	
12	(4) an intermediary that helps administer the program by facilitating the	
13	donation or transfer of drugs to eligible recipients;	
14	(5) a manufacturer or repackager of a donated drug; and	
15	(6) any employee, volunteer, trainee, or other staff of any person listed	
16	in subdivisions (1)–(5) of this section.	
17	Sec. 2. UPDATE ON RULEMAKING PROCESS; REPORT	
18	The Agency of Human Services shall provide an update on the status of	
19	rulemaking for the administration of the unused drug repository program as	
20	part of the Agency's fiscal year 2024 budget adjustment presentation.	

1	Sec. 3. EFFECTIVE DATE	
2	This act shall take effect on July 1, 2023.
