12	<u>§ 3191. DEFINITIONS</u>
13	As used in this chapter:
14	(1) "Certified peer support provider" means an individual who holds a
15	certificate to engage in the practice of peer support services under this chapter.
16	(2) "Certified recovery support specialist" means an individual who
17	holds a certificate to engage in the practice of recovery support services under
18	this chapter.
19	(3) "Code of Ethics for Certified Peer Support Providers" means the
20	code of ethics for certified peer support providers approved and adopted by the
21	Department of Mental Health.

1	(4) "Office" means the Office of Professional Regulation.
2	(5) "Peer support provider credentialing body" means the entity
3	authorized by the Department of Mental Health to, in addition to other duties:
4	(A) issue credentials to peer support providers to demonstrate that a
5	peer support provider has met the qualifications for certification under the
6	chapter; and
7	(B) approve acceptable continuing education courses.
8	(6) "Peer support" means the provision of those services that address
9	mutually agreeable issues or areas of life consistent with the Code of Ethics for
10	Certified Peer Support Providers that are reasonably related to increasing an
11	individual's capacity to live a self-determined life of their own choosing and
12	that are provided in a mutual relationship between individuals with a lived
13	experience of trauma, mental health, or substance use challenges. "Peer
14	support" emphasizes a nonjudgmental, values-driven approach that promotes
15	multiple perspectives, advocates for human rights and dignity, and focuses on
16	genuine, mutual relationships that enrich the lives of those involved. "Peer
17	support" includes providing health and wellness supports; supporting
18	individuals in accessing community-based resources and navigating State and
19	local systems; providing employment supports, including transitioning into and
20	staying in the workforce; and promoting empowerment and a sense of hope

1	through self-advocacy. "Peer support" does not include the provision of
2	psychotherapy as defined in 26 V.S.A. § 4082.
3	(7) "Practice of peer support" means the provision of peer support in a
4	manner consistent with the Code of Ethics for Certified Peer Support
5	Providers.
6	(8) "Practice of recovery support services" means the practice of
7	recovery support services.
8	(9) "Recovery support services" means a set of culturally competent,
9	nonclinical, evidence-based activities coordinated through a written
10	individualized recovery plan of care that documents a substance use disorder
11	and reflects the need and preferences of the individual in achieving the
12	specific, individualized, measurable goals specified in the plan. "Recovery
13	support services" include a range of social and other services that facilitate
14	recovery from substance use disorder, support health and wellness, and link
15	individuals with service providers and other supports shown to improve quality
16	of life for persons, and their families, in and seeking recovery from substance
17	use. "Recovery support services" do not include the provision of
18	psychotherapy as defined in 26 V.S.A. § 4082.
19	(10) "Recovery support specialist credentialing body" means the entity
20	authorized by the Department of Health to, in addition to other duties:

1	(A) issue credentials to recovery support specialists to demonstrate
2	that a recovery support specialist has met qualifications for certification under
3	this chapter; and
4	(B) approve acceptable continuing education courses.
5	<u>§ 3192. PROHIBITIONS; PENALTIES</u>
6	(a) Nothing in this subchapter shall be construed to prohibit the practice of
7	peer support by a noncertified provider. However, a person shall not use in
8	connection with the person's name any letters, words, or insignia indicating or
9	implying that the person is a certified peer support provider unless that person
10	is certified in accordance with this chapter.
11	(b) Nothing in this subchapter shall be construed to prohibit the practice of
12	recovery support services by a noncertified provider. However, a person shall
13	not use in connection with person's name any letters, words, or insignia
14	indicating or implying that the person is a certified recovery support specialist
15	unless that person is certified in accordance with this chapter.

19	Mental Health to serve as advisors to the Director in matters relating to peer
20	support and recovery support. Advisors shall be appointed to five-year
21	staggered terms to serve as advisors in matters related to the administration of

1	this chapter. At least one of the initial appointments shall be less than a five-
2	year term.
3	(2) A certified peer support provider serving as an advisor shall:
4	(A) have at least three years' experience as a peer support provider

8	(C) remain actively engaged in the practice of peer support in this
9	State during incumbency.
10	(3) A certified recovery support specialist serving as an advisor shall:
11	(A) be certified as a recovery support specialist in Vermont at the
12	time of appointment and during incumbency; and
13	(B) remain actively engaged in the practice of recovery support
14	services in this State during incumbency.
15	(b) The Director shall seek the advice of the advisor appointees in carrying
16	out the provisions of this chapter. Advisors who are not employed by the State
17	shall be entitled to compensation and necessary expenses in the amount
18	provided in 32 V.S.A. § 1010 for attendance at any meeting called by the
19	Director for this purpose.
