4	(2)(A) A health insurance plan shall provide the same reimbursement
5	rate for services billed using equivalent procedure codes and modifiers, subject
6	to the terms of the health insurance plan and provider contract, regardless of
7	whether the service was provided through an in-person visit with the health
8	care provider or by audio-only telephone.
9	(B) The provisions of subdivision (A) of this subdivision (2) shall not
10	apply in the event that a health insurer and health care provider enter into a
11	value-based contract for health care services that include care delivered by
12	audio-only telephone.
13	(c) A health insurance plan may charge an otherwise permissible
14	deductible, co-payment, or coinsurance for a health care service delivered by
15	audio-only telephone, provided that it does not exceed the deductible, co-
16	payment, or coinsurance applicable to an in-person consultation.
17	(3)(d) A health insurance plan shall not require a health care provider to
18	have an existing relationship with a patient in order to be reimbursed for health
19	care services delivered by audio-only telephone.
