Americans who do not want people with mental illness in their workplaces

50%

Employers reluctant to hire someone with a past psychiatric history

70%

Employers reluctant to hire someone currently taking antipsychotic medications

25%

Employers who would fire someone who had not disclosed a mental illness

# Legislative Activism



#### Criminal Justice Council

 Expanded membership of State Commission that oversees law enforcement to include a psychiatric survivor

### Law Enforcement Use of Force

- Deadly force as a last resort
- Must consider individual's mental impairment in deciding how much force to use, if any
- Deadly force prohibited if subjects are threatening only themselves

#### Sexual consent law

- Vermont's current law implies that people with psychiatric and developmental disabilities are unable to consent to sex
- MadFreedom successfully advocated for disability neutral consent law

# Competency to stand trial and insanity as a defense

- Ensured defendants receive copy of competency evaluation
- Ensured defendants receive timely examination of their mental state at time of alleged crime, if applicable

# Legislative Priorities



#### Warrants for Emergency Examination

- Stop expansion of coercion in the mental health system
- End coercion in the mental health system

#### Marriage

 Repeal prohibition forbidding individuals with severe psychiatric disabilities from marrying (18 VSA § 5142)


#### **Peer Certification**

 Adequate funding for implementation of statewide mental health peer worker certification (Governor's Budget Proposal includes \$187.5K to support credentialing)

# Competency to stand trial and insanity as a defense

- Competency restoration models that do no include forced drugging
- Stop conflation of mental illness and criminality and violence
