- 4 Services" respectfully reports that it has considered the same and recommends
- 5 that the House propose to the Senate that the bill be amended by striking out all
- 6 after the enacting clause and inserting in lieu thereof the following:
- 7 Sec. 1. FINDINGS AND PURPOSE
- 8 (a) Since its establishment in 1970, Vermont's Agency of Human Services
- 9 <u>has grown significantly in both size and scope.</u> In its current form, the Agency
- is composed of six departments: the Department for Children and Families;
- the Department of Corrections; the Department of Disabilities, Aging, and
- 12 Independent Living; the Department of Health; the Department of Mental
- Health; and the Department of Vermont Health Access, along with several
- divisions and many offices, boards, and councils. The Agency's budget
- comprises more than half of the overall State budget, and the programs and
- benefits administered by the Agency and its departments have an impact on the
- 17 lives of all Vermonters.
- 18 (b) The purpose of this act is to create a meaningful process through which
- 19 <u>the Agency, its departments, and the individuals and organizations with whom</u>
- they engage most can collaborate to identify opportunities to build on past
- successes and to make improvements for the future.

1	Sec. 2. REENVISIONING THE AGENCY OF HUMAN SERVICES;
2	REPORT
3	(a) The Secretary of Human Services, in collaboration with the
4	commissioner of each department within the Agency of Human Services and in
5	consultation with relevant commissions, councils, and advocacy organizations;
6	community partners; individuals and families impacted by the Agency and its
7	departments; and other interested stakeholders, shall consider options for
8	reenvisioning the Agency of Human Services, such as restructuring the
9	existing Agency of Human Services or dividing the existing Agency of Human
10	Services into two or more separate agencies.
11	(b) The Secretary of Human Services and the other stakeholders identified
12	in subsection (a) of this section shall evaluate the current structure of the
13	Agency of Human Services, identify potential options for reenvisioning the
14	Agency and engage in a cost-benefit analysis of each option, and develop one
15	or more recommendations for implementation.
16	(c) The Agency shall solicit open, candid feedback from the stakeholders
17	identified in subsection (a) of this section to inform the evaluation,
18	identification of options, and development of recommendations. To the extent
19	feasible, the Agency shall engage existing boards, committees, and other
20	channels to collect input from individuals and families who are directly
21	impacted by the work of the Agency and its departments.

1	(d) On or before February 1, 2025, the Secretary shall present to the House
2	Committees on Government Operations and Military Affairs, on Health Care,
3	and on Human Services and the Senate Committees on Government
4	Operations and on Health and Welfare an update on the status of the
5	stakeholder process and development of recommendations as set forth in this
6	section.
7	(e) On or before November 1, 2025, the Secretary shall provide the
8	recommendations developed by the Secretary and stakeholders to the House
9	Committees on Government Operations and Military Affairs, on Health Care,
10	and on Human Services and the Senate Committees on Government
11	Operations and on Health and Welfare, including the following:
12	(1) the rationale for selecting the recommended option or options;
13	(2) the likely impact of the recommendations on the departments within
14	the Agency and on the Vermonters served by those departments, including
15	Vermonters who are members of historically marginalized communities;
16	(3) how the recommendations would center the needs of and lead to
17	better outcomes for the individuals and families served by the Agency and its
18	departments and make the Agency more accountable to the Vermonters whom
19	it serves;
20	(4) how the recommendations could improve collaboration, integration,
21	and alignment of the services currently provided by the Agency and its

1	departments and how they could enhance coordination and communication
2	among the departments and with community partners;
3	(5) how the recommendations could address the workforce and
4	personnel capacity challenges that the Agency and its departments encounter;
5	(6) how the recommendations could address the facility challenges that
6	the Agency and its departments encounter;
7	(7) how the recommendations could strengthen the use of technology to
8	improve access to programs and services, increase accountability, enhance
9	coordination, and expand data collection and analysis;
10	(8) a transition and implementation plan for the recommendations that is
11	designed to minimize confusion and disruption for individuals and families
12	served by the Agency and its departments, as well as for Agency and
13	departmental staff;
14	(9) a proposed organizational chart for any recommended
15	reconfigurations; and
16	(10) the estimated costs or savings associated with the
17	recommendations.
18	Sec. 3. EFFECTIVE DATE
19	This act shall take effect on passage.
