17	(C)(iii) Abuse abuse to children as defined in 33 V.S.A. chapter 49,	
18	subchapter 2-;	
19	(D)(iv) Stalking stalking as defined in 12 V.S.A. § 5131(6): or	
20	(E)(v) Sexual sexual assault as defined in 12 V.S.A. § 5131(5)-; or	

1	(B) coercive controlling behavior between family or household

3	(2)(A) "Coercive controlling behavior" means a pattern of conduct that		
4	has the purpose or effect of causing a reasonable person:		
5	(i) to fear for the plaintiff's safety or the safety of a family		
6	member; or		
7	(ii) to suffer substantial emotional distress.		
8	(B) "Coercive controlling behavior" does not include:		
9	(i) conduct between a child under 18 years of age and the child's		
10	parent or guardian involving the exercise of a parent's constitutional right to		
11	the care, custody, and control of the parent's child;		
12	(ii) conduct taken by a plaintiff to protect themselves, the		
13	plaintiff's family or household members, or an animal that is connected to the		
14	family from the risk of present or future harm; or		
15	(iii) constitutionally protected activity.		
16	(3) "Household members" means persons who, for any period of time,		
17	are living or have lived together, are sharing or have shared occupancy of a		
18	dwelling, are engaged in or have engaged in a sexual relationship, or minors or		
19	adults who are dating or who have dated. "Dating" means a social relationship		
20	of a romantic nature. Factors that the court may consider when determining		
21	whether a dating relationship exists or existed include:		

1	(A) the nature of the relationship;	
2	(B) the length of time the relationship has existed;	
3	(C) the frequency of interaction between the parties; and	
4	(D) the length of time since the relationship was terminated, if	
5	applicable.	
6	(3)(4) A "foreign abuse prevention order" means any protection order	
7	issued by the court of any other state that contains provisions similar to relief	
8	provisions authorized under this chapter, the Vermont Rules for Family	
9	Proceedings, 33 V.S.A. chapter 69, or 12 V.S.A. chapter 178.	
10	(4)(5) "Other state" and "issuing state" shall mean any state other than	
11	Vermont and any federally recognized Indian tribe, territory or possession of	
12	the United States, the Commonwealth of Puerto Rico, or the District of	
13	Columbia.	
14	(5)(6) A "protection order" means any injunction or other order issued	
15	for the purpose of preventing violent or threatening acts or harassment against	
16	or contact or communication with or physical proximity to, another person,	
17	including temporary and final orders issued by civil and criminal courts, other	
18	than support or child custody orders, whether obtained by filing an	
19	independent action or as a pendente lite order in another proceeding so long as	
20	provided that any civil order was issued in response to a complaint, petition, or	
21	motion filed by or on behalf of a person seeking protection.

3	§ 1101a. LEGISLATIVE INTENT; COERCIVE CONTROLLING	
4	<u>BEHAVIOR</u>	
5	(a) It is the intent of the General Assembly to recognize that coercive	
6	controlling behavior is a form of abuse.	
7	(b) The inclusion of coercive controlling behavior within the definition of	
8	"abuse" in section 1101 of this title and the language included in that section is	
9	derived from the 2022 Model Code on Domestic and Family Violence issued	
10	by the National Council of Juvenile and Family Court Judges.	
11	(c) As identified in the model code, coercive controlling behavior may	
12	include a pattern of any of the following:	
13	(1) monitoring or surveilling the plaintiff's daily personal activities;	
14	(2) manipulating the plaintiff's mental health status to the detriment of	
15	the plaintiff;	
16	(3) isolating the plaintiff from family or friends or the opportunity to	
17	participate in a faith community, employment, education, or other support	
18	networks;	
19	(4) repeatedly humiliating, threatening, or intimidating the plaintiff;	
20	(5) threatening to harm or abduct the plaintiff or the plaintiff's children;	

1	(6) committing or threatening to commit harm to an animal that is		
2	connected to the family;		
3	(7) threatening deportation or to contact local or federal authorities		
4	based on actual or perceived immigration status of the plaintiff or the		
5	plaintiff's family or threatening to jeopardize the immigration application		
6	status of the plaintiff or the plaintiff's family;		
7	(8) depriving the plaintiff of the means needed for independence,		
8	resistance, or escape, such as denying or impeding the plaintiff's access to a		
9	vehicle, banking services, or the plaintiff's own identification documents;		
10	(9) controlling, regulating, or monitoring the plaintiff's finances or		
11	economic resources; or		
12	(10) controlling the reproductive autonomy of the plaintiff through		
13	force, threat of force, or intimidation, including placing unreasonable pressure		
14	on the plaintiff to become pregnant, deliberately interfering with the plaintiff's

16	coercive tactics to control or attempt to control pregnancy outcomes.
