Retail Theft Using Criminal Court Data

This memo addressed the questions on retail theft charge and case processing from 2018-2023. The data comes from the Judiciary and is maintained in CRG databases.

Summary

- The 2023 retail theft charge filings are consistent with pre-Covid years. There is an increase in the number of felony retail theft charges filed.
- Most felony retail theft charges are disposed as a felony.
- Case backlogs can occur at all stages of the process, including apprehension, scheduling, and disposition.
- 57.6% of repeat retail theft offenders re-offend with a new retail theft offense within 30 days of their first offense.
- Restitution is ordered in approximately 8% of all retail theft cases.
- Straight sentences were the most common sentence for both misdemeanor and felony retail theft. The average minimum time for misdemeanor retail theft was .03 years (~ 11 days) and for felony was .64 years (~ 7.6 months).

How many charges of retail theft were filed from 2018-November 2023?

Is the increase of felony charges due to overcharging in hopes of plea bargaining?

Probably not. In the pre-Covid period of 2018-2019 there were a total of 60 felony retail charges that were disposed (charges are not necessarily disposed of in the same year they were filed). Eight (13%) of those charges were reduced to a misdemeanor and eventually were found guilty or referred to an alternative disposition (diversion or treatment court). Figure 1 shows the flow of felony retail theft charges.

In the post-Covid disposition years of 2022- 2023, there were 69 original felony retail theft charges disposed. Eight (11%) were reduced to misdemeanors. Figure 2 shows the flow of felony retail theft charges post-Covid.

How long are retail theft charges taking to resolve (post-Covid)?




Fig.3: Average Days to Dispostion from Offense Date by County




Fig. 4: Average Days to Dispostion from Arraignment by County

Figure 3 shows the average days to disposition from the date of the offense, for those offenses committed in 2022 or 2023. All counties are disposing of cases within 1 year of the offense. There is a difference however, between the the average disposition times from the offense and the arraignment. Figure 4 shows the average disposition times from arraignment. Addison county is able to dispose of cases in under 100 days after arraignment, compared to the almost 200 days to dispose of the case from the offense. This indicates that the delay could be in apprehending the offender or scheduling the first arraignment.

How many charges have an order of restitution?

Statewide, only about 8% of retail theft charges have an order of restitution. Charges are not cases, and it is possible that ordered restitution is entered in only one charge in a case. However, as most cases are only one charge, the 8% is probably an accurate reflection of the use of restitution. Restitution usage varies by county, Essex had only 1 case during the time period and restitution was ordered. Lamoille and Windsor counties used restitution the most at 48.9% and 24% respectively.



How many people are repeat retail theft offenders in the cohort and when did they re-offend?

There were 526 unique individuals who committed a retail theft charge in 2018 or later where the charge was disposed of by November 2023. These individuals were charged with 3,458 charges of retail theft. Of the 526 individuals, 303 (57.6%) had a new offense within 31 days of their first offense during the study period. Most of the new offenses were within 10 days of the first offense.



What are the sentences for retail theft?

Straight sentences were the most common sentence for both misdemeanor and felony retail theft. The average minimum time for misdemeanor retail theft was .03 years (\sim 11 days) and for felony was .64 years (\sim 7.6 months).

What does an equity analysis indicate?

White defendants had a higher average number of retail theft charges filed on the same day against them (1.32 for white defendants vs 1 for all other races).

Female defendants had a higher average number of retail theft charges filed on the same day against them than men. Women had 1.75 charges filed against them vs. 1.15 for men.

Women were 39% of the defendants for retail theft. This is higher than the overall percentage of female offenders which hovers between 20 and 30%.
