| 10 | or sealing of the criminal history record related to the conviction if: |
| 11 | (A) the person was convicted of a qualifying crime or qualifying |
| 12 | erimes arising out of the same incident or occurrence; |
| 13 | (B) the person was convicted of an offense for which the underlying |
| 14 | conduct is no longer prohibited by law or designated as a criminal offense; |
