Figure 1: Number of Relevant Felony Charges Disposed by Year 2017-November 2023

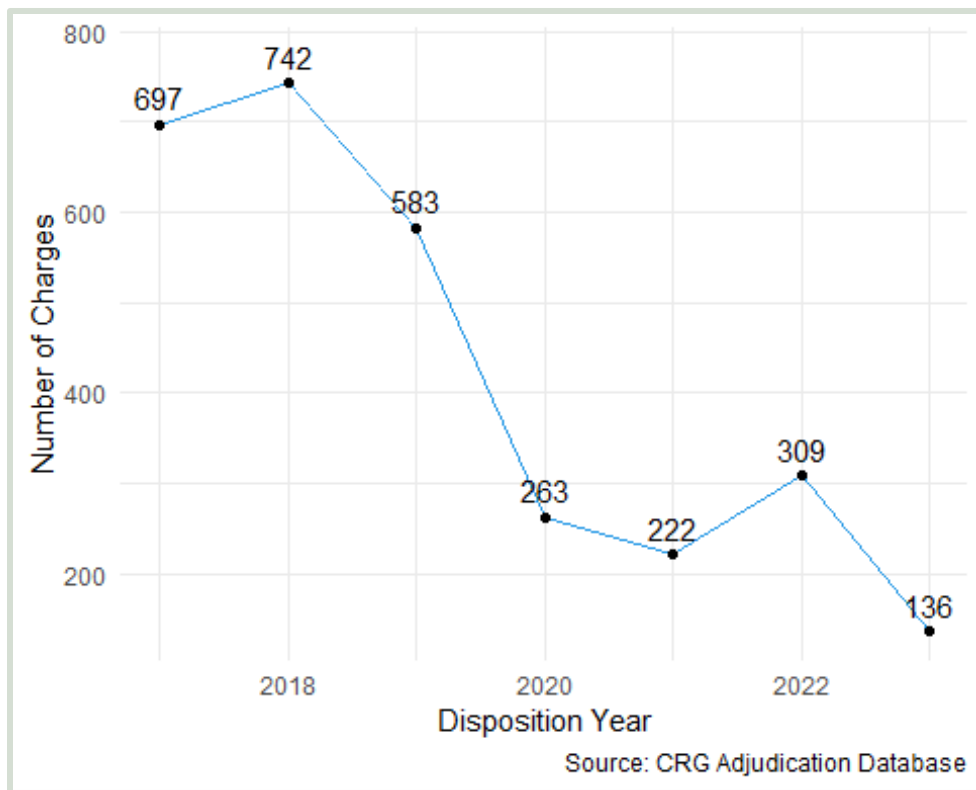
