An urban transportation solution scaled for rural Vermont

Community Rides Vermont is an on-demand ride service using electric vehicles to address unmet transportation needs along the back roads and between the small villages of Central Vermont.

An anti-poverty and climate justice initiative, this innovative service weaves together public funding and market-rate revenue to provide reliable and clean transportation that's accessible to lowincome Vermonters.

unmet transportation needs

the problem

Low population density makes traditional public transit inefficient and expensive in rural America.

Low-income Vermonters struggle to access basic needs such as healthcare, jobs, and educational opportunities compared to those with adequate, reliable transportation.

Quality of life is impacted by limited public transportation options.



Well, basically, I can't do pretty much anything. The most I can use [the local bus service] for is doctor appointments. The bus only runs from 10:30 to 2:30, so that doesn't give you a lot of hours Monday through Friday... so I can't go to church, I can't go to a movie, I can't go to dinner or a community dinner... I can't go any place. My whole life is basically just going to the doctor and going food shopping. I feel like my life is very limited because of the limited amount of transportation there is in Vermont."

We're bridging public and private sectors to solve public transportation needs.

Community Rides Vermont is a new service at the intersection of nonprofit, government, private pay ride hail and private businesses, merging resources across sectors with emerging technologies to solve the transportation needs of rural Vermonters.



the solution

We're serving those with limited transportation options.

MTI-funded local market research has revealed that the most common barriers for not utilizing current public transit options are that it **takes too long** and **it's too complicated**.

Common barriers for not using taxis or ride-hail services are that they're **too expensive**, and **not accessible at the rider's home**.

Common barriers for those not owning a car are a **lack of driver's license** and it's **too expensive to own and maintain a vehicle.** (15% of survey respondents live in a zero-car household.)

Launching with a fleet of 4-8 electric vehicles, Community Rides Vermont will provide flexible rides via a mobile app and phone center.
