2024 Transportation Bill (H.868) Report

Section 13 – Plan for Reporting Delays; Report

The Agency of Transportation tracks project schedules using critical path methodology. All project schedules track multiple tasks through the life cycle to include: conceptual design plans, preliminary planning, final engineering plans, advertisement and contract administration, and construction activities. Preliminary plan completion is the critical first point in project development that provides enough granularity on the scope of the project to reasonably account for inherent uncertainties and determine the cost and timelines to complete the project.

Currently, the Agency captures the anticipated construction advertisement on January 1 for the coming year and tracks the performance of meeting those advertising dates for each project. Performance is reported out annually to the Senate and House Transportation Committee's for the prior year. The Agency also provides the statutorily directed 10G reports annually to the Senate and House Transportation Committees. These reports indexes: (1) projects that will be shown in the Transportation Capital Program for the first time; (2) projects which are coming off the Transportation Capital Program; and (3) the projects which have increased in cost at a designated threshold. This plan for reporting delays will complement these other reports.

The Agency intends to, annually, at the time that the Transportation Program is developed, produce a report on projects which have reached the completion of the preliminary plan design phase. The report will include the project name and number, the date that preliminary plans were completed, the anticipated advertising date, at the time preliminary plans were completed and any change in the anticipated advertising date greater than 12 months from the initial date. An example of the report is shown below:
