10	shall be deposited in the Sports Wagering Fund.

13	Ninth: In Sec. 1, 31 V.S.A. chapter 25 (sports wagering), by striking out

17	(a) The Sports Wagering Fund is established. It shall consist of all

2	to and paid from the Fund based on generally accepted accounting principles.
3	§ 1341a. PROBLEM GAMBLING PROGRAM
4	(a) The Department of Mental Health shall establish and administer the
5	Problem Gambling Program to:
6	(1) provide support to agencies, organizations, and persons that provide
7	education, assistance, awareness, treatment, and recovery services to persons
8	and families experiencing difficulty as a result of addictive or problematic
9	gambling;
10	(2) promote public awareness of and provide education concerning
11	gambling addiction;
12	(3) establish programs to certify addiction counselors;
13	(4) promote public awareness of assistance programs for gambling
14	addiction; and
15	(5) fund a helpline with text messaging and online chat capabilities.
16	(b) On or before January 15 of each year, the Department of Mental Health
17	shall submit to the General Assembly a report detailing the expenditures
18	related to the Problem Gambling Program in the preceding fiscal year and
19	summarizing the programs and activities supported by those expenditures.

2	striking out all after the section heading and inserting in lieu thereof the
3	following:
4	(a) The following sums are appropriated from the Sports Wagering Fund to
5	the Department of Mental Health for purposes of establishing and
6	administering the Problem Gambling Program:
7	(1) in fiscal year 2024, \$250,000.00; and
8	(2) in fiscal year 2025, \$500,000.00.
9	(b) In fiscal year 2024, \$550,000.00 is appropriated from the Sports
10	Wagering Fund to the Department of Liquor and Lottery. This appropriation is
11	made in anticipation of receipts from sports wagering operator fees.
