5	that it has considered the same and recommends that the bill be amended by
6	striking out all after the enacting clause and inserting in lieu thereof the
7	following:

10	(a) As used in this subchapter:

12	(11) "Member" means any employee included in the membership of the
13	Retirement System under section 457 of this title.

15	(F) "Group G member" means:
16	(i) the following employees who are first employed in the
17	positions listed in this subdivision (F)(i) on or after July 1, 2023, or who are
18	members of the System as of June 30, 2022 and make an irrevocable election
19	to prospectively join Group G on or before June 30, 2023, pursuant to the
20	terms set by the Board: facility employees of the Department of Corrections,

as Department of Corrections employees who provide direct security and

1	treatment services to offenders under supervision in the community, as
2	employees of a facility for justice-involved youth, or as and employees of the
3	Vermont State Psychiatric Care Hospital employees or as employees of its
4	successor in interest, who provide direct patient care; and
5	(ii) the following employees who are first employed in the
6	positions listed in this subdivision (F)(ii) or first included in the membership or
7	the System on or after January 1, 2025, or who are members of the System as
8	of December 31, 2024 and make an irrevocable election to join Group G on or
9	before December 31, 2024, pursuant to the terms set by the Board:
10	(I) all sheriffs; and
11	(II) deputy sheriffs who:
12	(aa) are employed by county sheriff's departments
13	that participate in the Vermont Employees' Retirement System;
14	(bb) have attained Level II or Level III law

18	as the primary function of their employment; and
19	(dd) are not full-time deputy sheriffs compensated

7	(i) for facility employees of the Department of Corrections,
8	Department of Corrections employees who provide direct security and

11	Psychiatric Care Hospital or its predecessor or successor in interest, who
12	provide direct patient care, who were first included in the membership of the

2	(b) Normal retirement allowance.
3	* * *
4	(6)(A) Upon normal retirement pursuant to subdivisions
5	455(a)(13)(E)(i) and, (iii), (iv), and (vi) of this chapter, a Group G member
6	shall receive a normal retirement allowance equal to two and one-half of a
7	percent of the member's average final compensation times years of
8	membership service in Group G. The maximum retirement allowance shall be
9	50 percent of average final compensation.
10	(B) Upon normal retirement pursuant to subdivision subdivisions
11	455(a)(13)(E)(ii) and (v) of this chapter, a Group G member shall receive a
12	normal retirement allowance equal to two and one-half of a percent of the
13	member's average final compensation times years of membership service in
14	Group G. The maximum retirement allowance shall be 60 percent of average
15	final compensation.

19	(4)(A) Upon early retirement, a Group G member who was previously a
20	Group F member first included in the membership of the System on or before
21	June 30, 2008, and who elected to transfer into Group G on July 1, 2023

pursuant to the terms set by the Board, shall receive an early retirement
allowance that shall be equal to the normal retirement allowance reduced by
the lesser of (i) one-half of one percent for each month equal to the difference
between the 240 months and the member's months of creditable service, or (ii)
an amount that shall be the actuarial equivalent of the normal retirement
allowance computed under subsection (b) of this section.
(B) Upon early retirement, a Group G member who was previously a
Group F member first included in the membership of the System on or after
July 1, 2008, and who elected to transfer into Group G on July 1, 2023
pursuant to the terms set by the Board, shall receive an early retirement
allowance that shall be equal to the normal retirement allowance reduced by
the lesser of (i) five-ninths of one percent for each month equal to the
difference between the 240 months and the member's months of creditable
service, or (ii) an amount that shall be the actuarial equivalent of the normal
retirement allowance computed under subsection (b) of this section.

§ 489. BENEFITS
Persons who become members of the Vermont State Retirement System
under this subchapter and on behalf of whom contributions are paid as

provided in this subchapter shall be entitled to benefits under the Vermont

1	State Retirement System as though they were employees of the State of
2	Vermont. These employees shall be considered "Group F members" as
3	defined in subdivision 455(a)(11)(E) of this title, except that:
4	(1) elected municipal employees shall not be subject to mandatory
5	retirement requirements; and
6	(2) sheriffs and those deputy sheriffs who meet the requirements
7	pursuant to subdivision 455(a)(11)(F)(ii)(II) of this chapter shall be considered
8	members of Group G.
9	Sec. 4. ONE-TIME IRREVOCABLE ELECTION FOR SHERIFFS AND
10	CERTAIN DEPUTY SHERIFFS
11	(a) On or before September 1, 2024, the Department of State's Attorneys
12	and Sheriffs, in consultation with the Department of Human Resources and the
13	Office of the State Treasurer, shall establish a list of positions newly eligible
14	for Group G of the Vermont State Employees' Retirement System, which shall
15	be limited to the following:
16	(1) all sheriffs; and
17	(2) deputy sheriffs who:
18	(A) are employed by county sheriff's departments that
19	participate in the Vermont State Employees' Retirement System;
20	(B) have attained Level II or Level III law enforcement
21	officer certification from the Vermont Criminal Justice Council;

1	(C) are required to perform law enforcement duties as the
2	primary function of their employment; and
3	(D) are not full-time deputy sheriffs compensated by the State
4	of Vermont whose primary function is transports as defined in 24
5	V.S.A. § 290(b) and eligible for Group C pursuant to 3 V.S.A.
6	§ 455(9)(B).
7	(b) In establishing any new deputy sheriff position on and after January 1,
8	2025, the Department of State's Attorneys and Sheriffs, in consultation with
9	sheriff's departments, shall identify that position as eligible for either Group C
10	membership or Group G membership pursuant to the criteria as set forth in
11	subsection (a) of this section.
12	(c)(1) A sheriff or deputy sheriff who qualifies for Group G membership
13	shall have a one-time option to transfer to Group G on or before December 1,
14	2024. For a sheriff or deputy sheriff who qualifies for Group G membership
15	who is first employed on or after December 1, 2024, election to join Group G
16	under this subsection shall be made as soon as possible but shall be within 30
17	days from the employee's date of hire.
18	(2) Election to join the Group G plan under this subsection shall be
19	irrevocable.
20	(d) The effective date of participation in a new group plan for those
21	employees covered under this section and who elect to transfer to Group G

1	shall be January 1, 2025. All past service accrued through the date of transfer
2	shall be calculated based upon the plan in which it was accrued, with all
3	provisions and penalties, if applicable, applied.
4	(e) The Department of State's Attorneys and Sheriffs shall notify the Office
5	of the State Treasurer of changes in a deputy sheriff's eligibility for Group G
6	within 30 days of the change in eligibility, pursuant to 3 V.S.A.
7	§ 455(11)(F)(ii)(II).
8	(f) Nothing in this section shall be read to extend postretirement health or
9	other insurance benefits to Group G deputy sheriffs who work for county
10	sheriff's departments.

13	30% for any sheriff whose law enforcement officer certification is permanently
