H.828 – Personal Income Tax Surcharge

Overview

- H.828 would place a 3% surcharge on adjusted gross income above \$500,000.
- The surcharge would be levied on adjusted gross income (AGI) and be adjusted for inflation each year.
- The tax would be effective retroactively for tax year 2024.

Personal income tax data, 2022

- 1,059 returns with AGI of \$1 million or more represented
 2,752 exemptions or individuals
- 1,059 returns with AGI of \$1 million or more accounted for
 - 0.32% of all VT tax returns
 - 11.3% of all VT AGI
 - 20.0% of all net VT personal income tax paid



Personal income tax data, 2022

- 3,560 returns with AGI of \$500,000 or more represented
 9,347 exemptions or individuals
- 3,560 returns with AGI of \$500,000 or more accounted for
 - 1.1% of all VT tax returns
 - 16.7% of all VT AGI
 - 34.8% of all net VT personal income tax paid








\$500K+ Returns






\$500K+ VT AGI

Tax Year 2024 Revenue Estimate

- January 2024 consensus forecast estimates a 5.7% decrease in personal income revenues in FY2024 and a 0.5% decrease in FY2025.
- JFO's preliminary estimate for FY2025 is \$71.4 million pending updated data.
