Vermont's Child Care Financial Assistance Program

- The Child Care Financial Assistance Program (CCFAP) is administered by the Child Development Division (CDD) within the Department for Children and Families.
- CCFAP provides some or all the cost for early childhood education and child care for eligible families with children, ages 6 weeks to 13 years (19 years for those with special needs).
- The design of the Child Care Financial Assistance Program reflects requirements of the federal Child Care Development Fund (CCDF) grant requirements related to:
 - Who is eligible
 - How much they are eligible for
 - How much to pay programs
 - How program integrity is maintained



Child Care Financial Assistance Program funding currently totals \$62.75M.

- State Funds (\$36.1M)
- Federal Funding (\$25.8M)
 - Child Care Development Block Grant (CCDBG)
 - Temporary Aid to Needy Families Social Services Block Grant (TANF SSBG)
 - Family Service Division Federal Funding (support for children in our custody or otherwise eligible for Family Services Division services; IV-E (foster care eligibility) and IV-B (child welfare services of the social security act)
 - Global Commitment (\$847K)
- Key points
 - Federal funding sources are being fully utilized.
 - This does not include family payments, Head Start grants, or Universal Prekindergarten funding.



Families are eligible for CCFAP for many different reasons.

- To be eligible for Child Care Financial Assistance, a family must:
 - Meet income guidelines
 - Be a Vermont Resident
 - Child receiving care must be a legal resident of United States
 - Have a reason for child care
 - have a job,
 - self-employed
 - looking for work
 - attending school or training
 - participating in Reach Up
 - has a special health need and need help caring for their child(ren)
 - have a child with significant health or specialized development needs
 - an open case with Family Services or
 - the family is experiencing significant stress)

CCFAP for Families

Parent or guardian submits CCFAP application to CCCSA

 Reach Up and Protective Services authorizations bypass the application process. The family's worker submits an authorization for eligibility. Eligibility Specialist (ES) at the CCCSA reviews the application, typically within 7 days of application submission.

 If supporting documentation is needed (pay stubs, training schedule, documentation of special health need, etc.), the ES informs the applicant of missing items due in 10 days. Application is processed when all documentation to support eligibility requirements is received.

- Application is denied if missing items are not received or eligibility requirements are not met.
- Decisions are typically made within 30 days of application submission.
- Families can reapply at any time if they are denied.

Eligible families receive a Statement of Eligibility that includes:

- Family Share (paid directly to provider)
- Eligible hours and dates
- Assistance amounts that will be paid to the chosen provider(s) for each child in care

Applications are redetermined on an annual basis.

CDD pays CCFAP directly to child care providers on families' behalf.

- The CDD has a set cap on what the state will pay on behalf of a family. The state pays the capped rate or the provider's rate, whichever is less, after subtracting the family share (if any).
- Current payment rates are set at the 75 percentile of the 2019 Market Rate Survey the amount that would cover tuition at 75% of programs. This is a CCDF standard.
- The portion the State will pay for an eligible family will depend on:
 - 1. the family's application
 - 2. the provider's rate agreement
 - 3. the State's capped rates, and
 - 4. the amount the family is obligated to pay (family share).

CCFAP for Providers


To receive CCFAP payments, providers must:

- 1. Be registered, licensed, or an Approved Relative Child Care (ARCC) provider
- 2. Complete a W-9
- 3. Complete a Financial Services Agreement

When a family is found eligible, the provider receives a CCFAP Certificate for each child that contains:

- The Family's Share
- Eligible hours and dates
- Assistance amounts that will be paid to provider

Attendance is entered into CDDIS for biweekly service periods



 Payments are received as soon as nine days after service period ends, depending on mail and bank services. Payments are made earlier when a holiday could impact payment timeline.

Child Care Financial Assistance State's Capped Rates Effective July 3, 2022

The State's capped rates are the maximum amount the State will pay to a child care provider on behalf of a family receiving child care financial assistance. The State will pay the lesser of the two: up to the provider's rate or the State's capped rate. To receive the maximum amount the State pays, a child care provider may need to increase their rates. Authorized Hours of Care: Full-Time Weekly – 26 to 50 hours a week Part-Time Weekly – 1 to 25 hours a week Extended Time – more than 50 hours a week Child's Age

Infant – birth up to 24 months old Toddler – 2 up to 3 years old Preschool – 3 up to 5 years old School Age – 5 up to 12 years old (19 if child has special needs)

Head Start - Eligibility

- Head Start primarily serves 3- and 4-year-old children. Early Head Start serves infants, toddlers, and pregnant women.
- Children and families can be Income Eligible or Categorically Eligible:
 Income Eligibility
 - At or below 100% federal poverty line
 - Below 130% FPL if space available (not more than 35% enrollment)

Categorical Eligibility

- Families receiving public assistance (TANF/Reach-Up; SSI; SNAP)
- Children in foster care (Kinship Care also prioritized)
- Children/families experiencing homelessness

Head Start in Vermont – An Overview


7 Head Start/Early Head Start recipients offer programming via center-based programs, family child care, home-based models.

- 65 sites currently offering center-based/family child care Head Start or Early Head Start Services.
 - 41 are licensed Head Start centers and 7 are Child Care Partnerships offering a total of **763 slots** for children.
 - 24 sites offer Early Head Start, 9 of which are Early Head Start Child Care Partnerships, and combined offer **357 slots for children or pregnant women**.
- 11 sites offer home-based services
 - **Early Head Start** home-based services are offered in Caledonia, Essex, Orleans, Franklin & Grand Isle, Chittenden, Addison, Lamoille, Orange, Washington, and Windham counties.
 - Head Start home-based services are offered in Franklin & Grand Isle, Chittenden and Addison.

Head Start in VT – Intersections with CCFAP

Office of Head Start – Head Start Collaboration Office - Priority Area:

Partner with state child care systems to promote access to comprehensive services and high-quality full-day, full-year early care and education for at-risk children and families.



5 Head Start/Early Head Start recipients currently participate in the Child Care Financial Assistance Program.

Head Start – Comparison with CCFAP

1. Eligibility:

Both CCFAP and Head Start serve low-income families with young children. Families may be eligible for both programs, depending on their income and other eligibility criteria.

2. Funding:

The Child Care Development Block Grant, which funds CCFAP, is federal to state. Head Start is federal to local.

3. Services:

Both CCFAP and Head Start provide access to early childhood education and care. However, Head Start must also meet federal Head Start Program Performance Standards and offer comprehensive services, including health, nutrition, and family support services.


4. Providers:

CCFAP is used to pay for care provided by licensed child care centers or home-based providers, while Head Start is provided through a network of grant recipients that may include community-based organizations, schools, or local government agencies.


5. Coordination:

CCFAP and Head Start programs may work together to coordinate services and ensure that eligible families receive the support they need.

Licensed child care capacity has been steady over last six years.




The licensed capacity is the number of children a program is licensed to care for at any moment in time. This is not the same as the number the program would like to serve.

Reported (desired) capacity has been up and down over last six years.

The reported capacity data represents the number of spaces a program self reports offering for each age group, this is sometimes called desired capacity.

The # of Family Child Care programs has declined over the last six years; other program types held fairly steady.



FCCH – Family Child Care Home CBCCPP – Child Based Child Care and Preschool Program Non-recurring – child care services to non-recurring clientele
