The Goal: High quality, accessible Early Care and Education

- Use RAND Schedule 2 to illustrate a high-quality, accessible program
 - Maintain CCFAP features
 - No copay for families with income up to 150% FPL (family of 3: \$37,290; family of 4: \$45,000)
 - Weekly copay starts at \$25 for incomes just above 150% FPL through 175% FPL, etc.
 - Family copay no more than 10% of income up to 350% FPL
 - CCFAP eligibility continues to 500% FPL (RAND)
- Gap in funding for Schedule 2
 - About \$260 million in 2022 dollars; adjusting for inflation, about \$288 million in 2024 dollars



New investments needed

- High quality, accessible early care and education
 - Perhaps achieved over 4-5 years
 - \$288 million divided by 4 implies about \$72 million additional investment in each of 4 years
 - One-time administrative startup funds for the Dept. of Children and Families, and also perhaps for the Dept. of Taxes
 - One-time readiness payments and grants for early care and education providers
- Public PreK (Education Fund)
 - Likely need a few years to enable changes in physical capacity across the state
 - One-time administrative payments and grants for the Agency of Education and supervisory unions, school districts
 - One-time readiness payments and grants for local schools

To start the revenue discussion

- On-going investments
 - Early care and education, rising over 4-5 years
 - Public PreK, to begin in FY 2027?
- One-time spending
 - Prep for early care and education in FY 2024?
 - Prep for Public PreK prior to FY 2026?
 - Perhaps startup for new tax structure?
- Revenue sources
 - House FY 2024 Budget, early care in base: \$50 million
 - House FY 2024 Budget, one-time for early care: \$21 million
 - Additional tax type or add-on for early care?
 - Additional property tax revenue for Public PreK?
