Background – universal service charge

- Created in 1994 to increase telecommunications access for VT households – 30 V.S.A. Chapter 18
- Who pays?
 - Imposed on all retail telecommunications service provided to a Vermont address – to be collected by provider
 - Imposed on all retail sales of prepaid wireless telecommunications service subject to sales and use tax – as of January 1, 2020
- Current Charge = 2.4%
 - 2.0% to the Universal Service Fund (USF)
 - 0.4% to the VT Community Broadband Fund (As of FY 2022)



Background – universal service fund

- Also created in 1994
- Managed by a fiscal agent (Solix).
- Primary revenue source is universal service charge
- After paying fiscal agent, USF dollars support multiple programs:
 - VT telecommunications relay service
 - VT Lifeline program
 - Enhanced 911 Services
 - Connectivity Fund



- VT telecommunications relay service (TRS)
 - Free service for all Vermonters to connect individuals who are deaf, deafblind, hard-of-hearing, or have a speech disability to users of standard telephones
 - Fiscal agent sends \$ from USF to the State to pay for TRS administration
 - Current TRS program administrator: Sprint
- VT Equipment Distribution Program (VTEDP)
 - Grant program administered by VT Center for Independent Living to provide telecommunications equipment to low-income Vermonters
 - Falls under the umbrella of TRS

- Lifeline program
 - Lifeline is a FCC program to assist low-income consumers with communications services
 - Offers discounts for monthly telephone service, broadband internet service, or bundled packages from participating providers
 - Vermont offers an additional discount on telephone service only funded through the USF

- Enhanced 9-1-1 program
 - System of devices that can determine location and identity of caller that summons emergency assistance
 - Program managed by a Board and staff
 - Largest annual expenditure of USF dollars
 - Fiscal agent sends \$ from USF to the State for deposit in the Enhanced 911 special fund
 - USF revenues have not been sufficient to fully fund E911 in recent years E911 has ended last two fiscal years in deficit
 - One-time General Fund transfer to E911 Fund in FY23 \$1,300,000



- Connectivity Initiative
 - Program to provide broadband capable of 100 Mbps symmetrical to each service location in Vermont
 - Administered by VT Community Broadband Board previously housed within Dept. of Public Service
 - Receives 55% of any remaining USF dollars each year as determined by fiscal agent
- High-Cost Program
 - Program to fund telecommunications build-out in high-cost areas of the state
 - Receives 45% of any remaining USF dollars each year as determined by fiscal agent





- Prior to State FY 2015 USC rate set by Public Service Board (now Public Utility Commission) through docket
- Rate was 1.6%, 1.82% and 1.8% in three years prior to FY15 years started on Sept. 1 and ended on Aug. 31
- Rate set in statute at 2.0% starting July 1, 2015
- Rate increased to 2.4% starting July 1, 2019
 - The extra 0.4% went to the Connectivity Fund for two years
 - **As of July 1, 2021, the 0.4% now goes to the VT Community Broadband Fund this raised \$758k in FY22 that is not included in USF revenue charts below**
- If Prepaid wireless transactions subject to sales and use tax, now subject to USC – as of January 1, 2020







USF Expenses


- As noted above, several programs receive USF funding
- The largest program (by cost) is E 9-1-1 however as USC revenues have declined so have transfers to E 9-1-1 fund
- Administrative costs and telecom relay service costs have been relatively stable
- Lifeline expenses have declined over time
- Transfers to connectivity fund have been sporadic; big transfers in FY17-18 due to USF end-of-year balances
- As of FY22 VT Community Broadband Fund now gets some of USC





Takeaways

- USF managed by fiscal agent, not by State State does receive dollars from USF for certain programs
- USC revenues have been in decline people dropping cable service and land lines; bundling services
- Internet is a no-go for USC federal preemption
- E 9-1-1 fund not receiving sufficient transfers from USF A one-time transfer of \$1.3m from General Fund was included in Act 185 of 2022
- Bright spot significant federal funding for broadband has reduced pressure on USF for connectivity/high-cost funding
