The Vermont Fire Service Training Council maintains rules pertaining to fire service training requirements, standards for courses, issuance of certifications, and waivers related to the training requirements for firefighters. This rule filing makes corrections to typographical errors, clarifies the annual date by which the Council may modify recertification requirements, and eases the requirements for granting firefighter certification through reciprocity from applicants who received their certification from other states.

15. EXPLANATION OF WHY THE RULE IS NECESSARY:

This filing is an amendment to an existing rule. The revisions make corrections to typographical errors, clarified when the Council may make changes to firefighter recertification requirements, and eases the requirements for recognizing equivalent firefighter certifications issued by out of state accredited training entities. This rule change will create an easier path to Vermont certification for firefighters who received their initial certifications in other states.

16. EXPLANATION OF HOW THE RULE IS NOT ARBITRARY:

The rule is not arbitrary as it has been developed based on facts gathered by the Council using significant stakeholder input. This input brings forth experiences from the stakeholders that are rationally connected to the situations impacted by the rule. The decisions made by the Council in the development of the

rule make sense to a reasonable person as they have been proposed and endorsed by the stakeholders. The intent of the rule is to positively influence firefighter safety and proficiency in the interest of public safety.

This proposed rule change provides a positive economic impact. The rule change eases the requirements for firefighters who gain equivalent certification outside of Vermont to obtain reciprocal certification in Vermont without undergoing knowledge and skills examinations when properly credentialed. This removes a known barrier to recruitment and hiring firefighters from out of state and lessens the burden of filling vacant firefighter positions in both career and volunteer fire departments.

Vermont Fire Service Training Council EXPLANATION OF PROPOSED RULE REVISIONS

Section 3

This section contains numerous grammatical and typographical corrections. There is no change the content or intent of this section from the previous adoption.

Section 5.2.1

A correction was made to the statutory citation of Title 20 to fix a typographical error in the previous adoption.

Section 5.3.2

The Vermont Fire Service Training Council changed the standard expiration date of all certifications to June 30 from December 31 since the last rule revision. A correction was made to the language of this section to clarify the intent that changes to recertification requirements must be made in a manner that allows for adequate notice to be made to certification holders with respect to the start of a new certification term.

Section 5.3.4

A correction was made to the title of referenced NFPA standards within the rule.

Section 5.5.1.3

The currently adopted rule allows for firefighter certifications that were issued by accredited out of state entities to be recognized reciprocally within three years of the certification being issued. This section is modified to allow for reciprocal recognition of accredited out of state certifications regardless of the time elapsed since issuance, provided the applicant has met or exceeded the Vermont firefighter recertification requirements each year since earning initial certification.

Section 5.5.1.5

This is a new section that establishes a process for applying for reciprocity using approved forms and identifies how an applicant provides proof of continued training since earning initial certification. This section was added to provide guidance and clarity to the process.

Section 5.5.1.6

This is a new section that authorizes denial of reciprocity for any applicant who is found to have intentionally submitted fraudulent or inaccurate documentation of previous training records.

Section 5.5.2

This section is modified to clarify the allowance for reciprocity to be granted for the fulfillment of prerequisite training requirements when required for upper-level training programs and not for Vermont certification. This allows an individual who has previous training to participate in a higher-level training program without the burden of providing proof of continued training since earning initial certification.

Section 5.5.2.3

This section is deleted to encourage tenured firefighters to seek upper-level training. Under the currently adopted rule, some tenured firefighters were prohibited from attending upper-level training because their original certifications were not recognized due to their age. This restriction was determined to be unnecessary due to Vermont's recertification requirements which promotes certified firefighters to remain current with their knowledge and skills.

Section 5.5.3

The language used in this section was modified to add clarity. There is no change in content or intent.


2:02 p.m. meeting called to order, welcome and introductions.

- Review and approval of <u>minutes from the October 9</u>, 2023 meeting.
- No additions/deletions to agenda. Agenda approved as drafted.
- Note the following emergency rules were supported by ICAR Chair:
 - On 10/23/23: Emergency Housing Transition Benefit, by the Agency of Human Services,
 Department for Children and Families
 - This emergency rule is necessary to continue providing emergency housing assistance in accordance with Act 81.
 - Act 81 established an emergency housing transition benefit that provides continued housing in a hotel or motel for households that were housed through the pandemic-era General Assistance Emergency Housing Program as of June 30, 2023. Under Act 81, the transition benefit ends April 1, 2024. This emergency rule maintains the eligibility criteria initially established in 23-E05, with the following changes: 1) language clarifying that a household must accept and maintain a hotel or motel housing placement for the duration of the eligibility reassessment period to maintain eligibility for the transition benefit; 2) not including "upon expiration of the eligibility reassessment period" from rule 2652.5(D)(i) to align with the requirement in Act 81 that eligibility terminate upon noncompliance with the criteria established in the Act; 3) new definition of misconduct; 4) language addressing hospital-level care and short-term alternative housing placements; and 5) language addressing notice and appeal rights.
 - On 10/23/23: Expansion of Eligibility Criteria for Temporary Housing Assistance, by the Agency
 of Human Services, Department for Children and Families
 - This emergency rule is necessary to continue providing temporary housing assistance to families with children under 18 years of age and calculating the income contribution based on average or current daily motel rate.
 - Temporary housing assistance under the General Assistance program provides up to 84 or 28 days of housing in a hotel or motel. Households that are without housing due to a catastrophic situation may be eligible for up to 84 days. Households that are ineligible under catastrophic criteria may be eligible for up to 28 days if the household has a member belonging to a vulnerable population. This rule maintains categorical eligibility for 28 days of housing for families with children under 18 years of age or who are 18 or 19 years of age and attending school, as initially established in 23-E05. This rule also maintains the update to the basic needs standard chart in rule 2652.4 and the methodology for calculating the 30 percent income contribution in rule 2652.4, as



initially established in 23-E05. This rule adds language addressing lodging licensing violations. Criteria related to the Act 81 transition benefit are not included in this rule and will be included in a separate emergency rule.

Firefighters and fire departments will be impacted and see economic benefits from this rule. The proposed amendment eases the requirements for recognizing firefighter certifications that were issued by accredited out of state entities. This saves the expense of having new hires re-tested and reduces obstacles to hiring out of state candidates. This

amendment will make it easier to hire out of state applicants into vacant firefighter positions by removing barriers to recognizing existing certifications, saving municipal fire departments the expense of overtime due to vacancies.

Local fire departments have estimated that \$500 to \$1,000 will be saved per out-of-state new hire because their previous certifications will be recognized and they will not have to be re-tested upon gaining employment in Vermont. It is also estimated that in some cases, newly hired firefighters could gain \$500 to \$2,000 in extra wages during their first year by on-boarding sooner than they would under the current rule.

The need for a rule revision was presented to the Fire Service Training Council by the Vermont Fire Academy Chief of Training and stakeholder groups at the Council meeting on November 10, 2022. Following that public meeting, the Council was actively engaged in soliciting feedback from stakeholders regarding the need for a rule change to addresss concerns posed by the current rule.

Feedback was received from the Vermont Career Fire Chiefs Assocation and discussed in an open public meeting on April 6, 2023. This feedback consisted of written recommendations from a number of Vermont Fire Chiefs. At this meeting, the Council Chair appointed a committee consisting of one Council member, one Fire Chief, and the Vermont Fire Academy Chief of Training to further analyze the problems and formulate potential solutions in the form proposed rule revisions. This issue was further warned, reported on, and discussed at a Council meeting on June 8, 2023. At this meeting,

As President of the Professional Firefighters of Vermont, I feel it paramount to weigh in on this change. As we struggle to fill vacancies in the State for career Firefighters, this change would make it easier for a candidate from outside Vermont obtain employment. We have seen a large number of candidates come from outside of Vermont with certification from other States. One challenge we have faced is obtaining Vermont certification via the reciprocity route. This change would remove some of the barriers that departments have faced, streamlining the process. This would also put us in line with what neighboring States have adopted and use for reciprocity. I feel that the challenges of recruitment will only become more challenging moving forward and this will make Vermont departments better positioned to entice and recruit people from outside of the State.

1. INTRODUCTION

- 1.1 Adoption
- 1.1.1 These rules are adopted pursuant to 20 V.S.A. Chapter 179.
- 1.2 Purpose
- 1.2.1 The Vermont Fire Service Training Council provides standards for training and certification of firefighters.
- 1.3 Appointments to Council
- 1.3.1 The Governor appoints members of the Council in accordance with 20 V.S.A. § 3152.

2. **DEFINITIONS**

- 2.1 The definitions set out at 20 V.S.A. § 3151 shall be applicable for these rules:
- 2.1.1 "Council" means the Vermont Fire Service Training Council.
- 2.1.2 "Fire Service" means activities related to fire prevention, investigation, suppression or other fire related activities.
- 2.1.3 "Firefighter" means a member of a state, county, or municipal fire department or a privately-owned fire department, which is responsible for fire suppression, prevention, investigation or other fire related activities.
- 2.1.4 "Full-Time Firefighter" means a firefighter who receives compensation for performing fire service duties of a predictable and continuing nature more than 32 hours per week and more than 25 weeks per year.
- 2.1.5 "Chief Fire Service Training Officer" is appointed by the Commissioner of Public Safety and has the duties and powers specified in 20 V.S.A. §3154.
- 2.2 For the purpose of these rules, the term "Firefighter" shall include any member of the "Fire Service" as defined in section 2.1.2 of these rules.

3. COUNCIL PROCEDURES

3.1 Meetings

- 3.1.1 The Council shall meet at least twice a year as required by 20 V.S.A. § 3152. The date, time and place of such meetings shall be set by notice as provided in this section.
- 3.1.2 Special meetings may be called at any time by the Cehair or upon written request of seven (7) Council members. The time, date and place shall be set by notice as provided in this section.
- 3.1.3 The Cehief Ffire Service Ttraining Oefficer shall give notice of any regular or special meeting in writing to each Council member in compliance with the specific requirements of Vermont's Open Meeting law. The notice shall include the time, date and place of the meeting and an agenda. Copies of any available documents that pertain to items on the agenda shall be included.
- 3.1.4 The Cehief Ffire Service Ttraining Oofficer, with advice of the Chair, shall prepare the agenda of any meeting. The agenda shall include any business required by statute to be conducted by the Council, any business to be conducted at a special meeting, any action to be taken on old business, and any matter appropriate for Council action as new business. Any member present may raise additional agenda items at the meeting.
- 3.1.5 Council members may appoint a person to act as his or her alternate in their absence. The alternate serves at the pleasure of the member and shall be appointed by letter to the Cehair of the Council. The appointment shall be valid for the remainder of the term of the Council member and conveys full membership status in the absence of the member. The ehair Chair for good cause may grant exceptions to this procedure.
- 3.1.6 A majority of the members of the Council shall constitute a quorum. The Council shall act only by vote of a majority of its members present and voting at a meeting at which there is a quorum. Council members may fully participate in the meeting by electronic or other means without being physically present at the designated meeting location and be counted as a present member toward a quorum in accordance with 1 V.S.A. § 312(a)(2).
- 3.1.7 The meetings of the Council shall be presided over by the <u>chairChair</u> or, in his or her absence, by the <u>Vvice-chairChair</u>. In the event neither the <u>chairChair</u> nor <u>Vvice-chairChair</u> is present at the meeting, the Council may elect from its members there present a <u>chairChair</u> pro tempore who shall preside at the meeting.
- 3.1.8 Regular and special meetings shall be conducted under the committee provisions of Robert's Rules of Order, unless otherwise noted.
- 3.1.9 All meetings shall be open to the general public unless an executive session is invoked under 1 V.S.A., Chapter 5. Minutes of each meeting shall be kept and made part of the public record, except portions of such minutes that are exempted by Vermont law. The Cehief Ffire Service Ttraining Oefficer shall be responsible for the keeping of all Council minutes, and for their timely preparation and dissemination to all Council members following each meeting.

- 3.1.10 Any Council meeting may be recessed or adjourned on the majority vote of the members or alternates present, subject at all times to the requirements of Vermont Law.
- 3.1.11 The means of voting at any meeting shall be determined by the presiding officer.

3.2 Officers

- 3.2.1 The general conduct of the duties and responsibilities of the Council shall be vested in its ehairChair who shall preside over all meetings. The ehairChair shall have the authority to act on behalf of the Council in all matters that have been previously approved by vote of its members.
- 3.2.2 In the event the <u>chairChair</u> is unable for any reason to discharge his or her duties, the vice <u>chairChair</u> shall serve as the <u>chairChair</u>.

- 3.2.4 A vacancy is created in the positions of ehairChair or vice-ehairChair whenever either officer ceases to be a member of the Council, ceases to hold the position in government that initially qualified him or her for Council membership or upon unavailability, for any reason, for a period of six (6) months.
- 3.2.5 In the event the position of chair Chair becomes vacant, the balance of his or her term shall be discharged by the Vvice-chair Chair. A new Vvice-chair Chair shall be elected in the manner provided in this section for the balance of the term. Should both the positions of the chair Chair and Vvice-chair become vacant, a new election for each office shall be held to complete the term of the officer.

3.3 Committees

3.3.1 The Chair Chair, with the approval of the Council, may appoint such standing and special committees as necessary to assist it in conducting its business. Any eonnote-committee appointed shall have a written charge that describes the scope and responsibilities of the committee and the method of appointing members of the committee.

4. TRAINING

- 4.1 Approval of Fire Service Training
- 4.1.1 The Council shall approve programs of instruction that result in certification.

- 4.1.2 Before the Council approves a program of instruction it shall review and approve the curriculum and any prerequisites required.
- 4.1.3 In reviewing curriculum, the Council should compare the proposed curriculum with applicable Vermont Occupational Safety and Health Administration (VOSHA) regulations, NFPA Standards and other nationally recognized programs.
- 4.1.4 It shall be the responsibility of the Chief Fire Service Training Officer to inform the Council of new or updated courses.

4.2 Instructors

4.2.1 The Chief Fire Service Training Officer may approve instructors for delivery of Council approved programs that are currently certified at a minimum as a Fire Instructor I or equivalent. Fire Service Training Specialists may be appointed to assist in the delivery of courses based on subject matter expertise.

5. CERTIFICATIONS

- 5.1 Standards for certification of firefighters.
- 5.1.1 Procedures for testing for certification shall be approved by the Council consistent with applicable nationally recognized accreditation bodies.
- 5.1.2 The Council shall approve prerequisites for certification exams.
- 5.1.3 Passage of a written and, if appropriate, other approved testing methodologies based on the curriculum specified in section 4 of these rules with a minimum grade of 70%.
- 5.2 Minimum basic certification for full-time firefighters
- 5.2.1 The minimum basic certification for a full-time firefighter in accordance with 20 V.S.A. § 3153(a)(12)(A) shall be Firefighter I. This certification shall be obtained within 12 months of a firefighter meeting the definition of full-time firefighter in section 2.1.4 of these rules.
- 5.2.2 A waiver of section 5.2.1 of these rules may be requested in writing to the Chief Fire Service Training Officer by the fire chief of a fire department within 12 months of a full-time firefighter's date of hire. A waiver request must include the reason why section 5.2.1 of these rules cannot be met and a plan by which the firefighter will obtain certification.
- 5.2.3 The Chief Fire Service Training Officer is delegated by the council to rule on a waiver request and issue a waiver after determining that reasonable circumstances exist. A waiver shall not exceed 24 months from a full-time firefighter's date of hire.
- 5.3 Standards for maintaining Vermont certifications issued by the Vermont Fire Academy
- 5.3.1 All Vermont certified firefighters shall successfully complete a minimum number of

hours of training per certification term to maintain certification. The minimum number of hours per certification term shall be based on the level of certification and shall be prescribed by the Council. Failure to complete this required training shall result in loss of Vermont certification.

- 5.3.2 The Council may only change the number of hours required for Vermont certification maintenance at the last regular meeting of the calendar year and the effective date of those changes shall <u>not</u> be <u>greater sooner</u> than the start of the next certification term. one year from the date of approval.
- 5.3.3 The Vermont Fire Academy may issue Vermont certifications for a term not to exceed three (3) years.
- 5.3.4 All training used to maintain Vermont certifications shall be based on the job performance requirements, requisite knowledge, requisite skills, or objectives outlined in the applicable National Fire Protection Association Standard for Professional Qualifications Accreditation and Certification Systems for the level(s) of the certification held. The Council may require mandatory training topics for any Vermont certification level.
- 5.3.5 Firefighters who hold Vermont certifications at multiple levels shall be required to successfully complete training within all certification levels that they hold, but the total number of training hours required for the maintenance of Vermont certifications shall be determined by their highest level of Vermont certification.
- 5.4 Standards for reestablishing expired certifications issued by the Vermont Fire Academy.
- 5.4.1 Firefighters who fail to recertify may do so by obtaining the prescribed training hours per year within 2 years of their Vermont certification expiration date or by passing the approved challenge exam for the applicable level of certification in accordance with section 5.6 of these rules. This period shall be extended for firefighters who are members of the national guard, state guard, or reserve component and were activated or deployed in accordance with 20 V.S.A. §368.

5.5 Reciprocity

- 5.5.1 The Chief Fire Service Training Officer may issue reciprocal Vermont certification(s) to individual(s) who meet the requirement of sections 5.5.1.1 through 5.5.1.4 of these rules.
- 5.5.1.1 The applicant shall be currently affiliated with a Vermont Fire Department.
- 5.5.1.2 The applicant's certification shall be accredited by Pro Board, International Fire Service Accreditation Congress (IFSAC), or the United States Department of Defense (DOD).
- 5.5.1.3 The applicant's certification was issued within the current certification term, or was issued within the previous 3 years and the applicant has shall have applicable training that meets or exceeds the current recertification requirements in accordance with section 5.35 of these rules.

- 5.5.1.4 The applicant shall meet any additional training requirements specified as prerequisite for certification at the applicable level as required by the Council.
- 5.5.1.5 The applicant shall apply for reciprocity using forms approved by the Council and provide proof of continued training as prescribed in 5.5.1.3 of these rules. Acceptable proof of continued training shall be specified on the approved forms and may include training transcripts, affidavits from previous fire departments, training providers, or employers, or other forms as approved by the Council. Said documents are to be signed by a representative of the attesting organization and the applicant.
- 5.5.1.6 Any applicant who is found to have submitted intentionally fraudulent or inaccurate documentation of previous training records may result in immediate denial of reciprocity.
- 5.5.2 The Chief Fire Service Training Officer may deem a certification as equivalent for course or program prerequisite purposes, but not for Vermont certification to individual(s) who meet the requirements of section 5.5.2.1 through 5.5.3 of these rules.
- 5.5.2.1 The applicant shall be currently affiliated with a Vermont Fire Department or applying to attend a Vermont Fire Academy course or program that requires recognition of prerequisite certifications.
- 5.5.2.2 The applicant's certification shall be accredited by Pro Board, International Fire Service Accreditation Congress (IFSAC), or the United States Department of Defense (DOD).
- 5.5.2.3 The applicant's certification shall be compliant with the current or previous 2 editions of the applicable National Fire Protection Association Standard for Professional Qualifications Accreditation and Certification Systems.
- 5.5.3 <u>Certification Reciprocity</u> or equivalency shall only be issued <u>through reciprocity</u> for certification levels that are authorized by the Council.
- 5.6 Challenge Certification Exams
- 5.6.1 Individuals who have not completed an approved Vermont Fire Academy sanctioned program or who's certification has expired may obtain certification through the challenge certification exam process.
- 5.6.2 The Council shall approve the certification levels for which certification can be granted through the challenge certification exam process.
- 5.6.3 An individual shall only be allowed to attempt the challenge certification exam process once every five years per certification level.

6. REVOCATION OF FIREFIGHTER CERTIFICATION

- 6.1 In addition to decertification as a result of not completing continuing annual training as required by these rules the Council may revoke a firefighter certification for any of the following grounds:
- 6.1.1 The holder of the certification obtained such certification through fraud or

misrepresentation of material fact.

- 6.1.2 The holder of the certification is convicted of a crime, provided that the acts involved are found by the Council to have a direct bearing on the person's fitness to serve the public in the capacity of a firefighter.
- 6.1.3 The holder of the certification is convicted of violating any section of V.S.A. Title 13, Chapter 11: Arson and Burning.
- 6.2 No revocation of a certification shall occur without an investigation and notice and opportunity for hearing.

7. HEARINGS AND APPEALS

7.1 Any decision relating to certification, decertification or revocation of certification may be appealed in accordance with this section.

7.2 Procedures

- 7.2.1 The appeal shall be filed with the Chief Fire Service Training Officer within thirty (30) calendar days of the final decision that is being appealed.
- 7.2.2 The Chief Fire Service Training Officer shall notify the Council of the appeal at the next Council meeting after receiving the appeal.
- 7.2.3 The appeal shall be in writing and contain, as a minimum, the following elements.
- 7.2.3.1 The name of the firefighter submitting the appeal.
- 7. 2.3.2 The decision being appealed.
- 7. 2.3.3 A statement of facts supporting the appeal referenced to these rules.
- 7. 2.3.4 The requested remedy.
- 7.2.4 The Council shall conduct a hearing in accordance with this section within forty-five days of receiving the notice of appeal.
- 7.2.5 Any hearing before the Council in accordance with these rules shall be conducted in accordance with the contested case procedures of the Administrative Procedures Act. At the sole discretion of the Council the appeal may be heard by the full Council or a Committee of the Council.
- 7.2.6 The decision of the Council shall be considered a final decision.

8. SEVERABILITY

The Chief Fire Service Training Officer shall be responsible for the keeping of all Council minutes, and for their timely preparation and dissemination to all Council members following each meeting.

- 3.1.10 Any Council meeting may be recessed or adjourned on the majority vote of the members or alternates present, subject at all times to the requirements of Vermont Law.
- 3.1.11 The means of voting at any meeting shall be determined by the presiding officer.

3.2 Officers

- 3.2.1 The general conduct of the duties and responsibilities of the Council shall be vested in its Chair who shall preside over all meetings. The Chair shall have the authority to act on behalf of the Council in all matters that have been previously approved by vote of its members.
- 3.2.2 In the event the Chair is unable for any reason to discharge his or her duties, the vice Chair shall serve as the Chair.
- 3.2.3 The Chair and Vice-Chair shall be elected for a term of one (I) year upon the vote of the members at the last regular meeting of the calendar year. Nominations for Chair or Vice-Chair may be made from the floor or by letter of any Council member filed with the chief fire service training officer on or before the date of such election. A nomination in either manner shall be required to have a second, and the person receiving the most votes of the members present and voting shall be declared the Chair or Vice-Chair respectively.
- 3.2.4 A vacancy is created in the positions of Chair or vice-Chair whenever either officer ceases to be a member of the Council, ceases to hold the position in government that initially qualified him or her for Council membership or upon unavailability, for any reason, for a period of six (6) months.
- 3.2.5 In the event the position of Chair becomes vacant, the balance of his or her term shall be discharged by the Vice-Chair. A new Vice-Chair shall be elected in the manner provided in this section for the balance of the term. Should both the positions of the Chair and Vice-Chair become vacant, a new election for each office shall be held to complete the term of the officer.

3.3 Committees

3.3.1 The Chair, with the approval of the Council, may appoint such standing and special committees as necessary to assist it in conducting its business. Any committee appointed shall have a written charge that describes the scope and responsibilities of the committee and the method of appointing members of the committee.

4. TRAINING

- 4.1 Approval of Fire Service Training
- 4.1.1 The Council shall approve programs of instruction that result in certification.
- 4.1.2 Before the Council approves a program of instruction it shall review and approve the curriculum and any prerequisites required.

- 4.1.3 In reviewing curriculum, the Council should compare the proposed curriculum with applicable Vermont Occupational Safety and Health Administration (VOSHA) regulations, NFPA Standards and other nationally recognized programs.
- 4.1.4 It shall be the responsibility of the Chief Fire Service Training Officer to inform the Council of new or updated courses.

4.2 Instructors

4.2.1 The Chief Fire Service Training Officer may approve instructors for delivery of Council approved programs that are currently certified at a minimum as a Fire Instructor I or equivalent. Fire Service Training Specialists may be appointed to assist in the delivery of courses based on subject matter expertise.

5. CERTIFICATIONS

- 5.1 Standards for certification of firefighters.
- 5.1.1 Procedures for testing for certification shall be approved by the Council consistent with applicable nationally recognized accreditation bodies.
- 5.1.2 The Council shall approve prerequisites for certification exams.
- 5.1.3 Passage of a written and, if appropriate, other approved testing methodologies based on the curriculum specified in section 4 of these rules with a minimum grade of 70%.
- 5.2 Minimum basic certification for full-time firefighters
- 5.2.1 The minimum basic certification for a full-time firefighter in accordance with 20 V.S.A. § 3153(a)(1)(A) shall be Firefighter I. This certification shall be obtained within 12 months of a firefighter meeting the definition of full-time firefighter in section 2.1.4 of these rules.
- 5.2.2 A waiver of section 5.2.1 of these rules may be requested in writing to the Chief Fire Service Training Officer by the fire chief of a fire department within 12 months of a full-time firefighter's date of hire. A waiver request must include the reason why section 5.2.1 of these rules cannot be met and a plan by which the firefighter will obtain certification.
- 5.2.3 The Chief Fire Service Training Officer is delegated by the council to rule on a waiver request and issue a waiver after determining that reasonable circumstances exist. A waiver shall not exceed 24 months from a full-time firefighter's date of hire.
- 5.3 Standards for maintaining Vermont certifications issued by the Vermont Fire Academy
- 5.3.1 All Vermont certified firefighters shall successfully complete a minimum number of hours of training per certification term to maintain certification. The minimum number of hours per certification term shall be based on the level of certification and shall be prescribed by the Council. Failure to complete this required training shall result in loss of Vermont certification.

- 5.3.2 The Council may only change the number of hours required for Vermont certification maintenance at the last regular meeting of the calendar year and the effective date of those changes shall not be sooner than the start of the next certification term.
- 5.3.3 The Vermont Fire Academy may issue Vermont certifications for a term not to exceed three (3) years.
- 5.3.4 All training used to maintain Vermont certifications shall be based on the job performance requirements, requisite knowledge, requisite skills, or objectives outlined in the applicable National Fire Protection Association Standard for Professional Qualifications for the level(s) of the certification held. The Council may require mandatory training topics for any Vermont certification level.
- 5.3.5 Firefighters who hold Vermont certifications at multiple levels shall be required to successfully complete training within all certification levels that they hold, but the total number of training hours required for the maintenance of Vermont certifications shall be determined by their highest level of Vermont certification.
- 5.4 Standards for reestablishing expired certifications issued by the Vermont Fire Academy.
- 5.4.1 Firefighters who fail to recertify may do so by obtaining the prescribed training hours per year within 2 years of their Vermont certification expiration date or by passing the approved challenge exam for the applicable level of certification in accordance with section 5.6 of these rules. This period shall be extended for firefighters who are members of the national guard, state guard, or reserve component and were activated or deployed in accordance with 20 V.S.A. §368.

5.5 Reciprocity

- 5.5.1 The Chief Fire Service Training Officer may issue reciprocal Vermont certification(s) to individual(s) who meet the requirement of sections 5.5.1.1 through 5.5.1.4 of these rules.
- 5.5.1.1 The applicant shall be currently affiliated with a Vermont Fire Department.
- 5.5.1.2 The applicant's certification shall be accredited by Pro Board, International Fire Service Accreditation Congress (IFSAC), or the United States Department of Defense (DOD).
- 5.5.1.3 The applicant shall have applicable training that meets or exceeds the current recertification requirements in accordance with section 5.3 of these rules.
- 5.5.1.4 The applicant shall meet any additional training requirements specified as prerequisite for certification at the applicable level as required by the Council.
- 5.5.1.5 The applicant shall apply for reciprocity using forms approved by the Council and provide proof of continued training as prescribed in 5.5.1.3 of these rules. Acceptable proof of continued training shall be specified on the approved forms and may include training transcripts, affidavits from previous fire departments, training providers, or employers, or other forms as approved by the Council. Said documents

are to be signed by a representative of the attesting organization and the applicant.

- 5.5.1.6 Any applicant who is found to have submitted intentionally fraudulent or inaccurate documentation of previous training records may result in immediate denial of reciprocity.
- 5.5.2 The Chief Fire Service Training Officer may deem a certification as equivalent for course or program prerequisite purposes, but not for Vermont certification to individual(s) who meet the requirements of section 5.5.2.1 through 5.5.3 of these rules.
- 5.5.2.1 The applicant shall be currently affiliated with a Vermont Fire Department or applying to attend a Vermont Fire Academy course or program that requires recognition of prerequisite certifications.
- 5.5.2.2 The applicant's certification shall be accredited by Pro Board, International Fire Service Accreditation Congress (IFSAC), or the United States Department of Defense (DOD).
- 5.5.3 Certification or equivalency shall only be issued through reciprocity for certification levels that are authorized by the Council.

5.6 Challenge Certification Exams

- 5.6.1 Individuals who have not completed an approved Vermont Fire Academy sanctioned program or who's certification has expired may obtain certification through the challenge certification exam process.
- 5.6.2 The Council shall approve the certification levels for which certification can be granted through the challenge certification exam process.
- 5.6.3 An individual shall only be allowed to attempt the challenge certification exam process once every five years per certification level.

6. REVOCATION OF FIREFIGHTER CERTIFICATION

- 6.1 In addition to decertification as a result of not completing continuing annual training as required by these rules the Council may revoke a firefighter certification for any of the following grounds:
- 6.1.1 The holder of the certification obtained such certification through fraud or misrepresentation of material fact.
- 6.1.2 The holder of the certification is convicted of a crime, provided that the acts involved are found by the Council to have a direct bearing on the person's fitness to serve the public in the capacity of a firefighter.
- 6.1.3 The holder of the certification is convicted of violating any section of V.S.A. Title 13, Chapter 11: Arson and Burning.

6.2 No revocation of a certification shall occur without an investigation and notice and opportunity for hearing.

7. HEARINGS AND APPEALS

7.1 Any decision relating to certification, decertification or revocation of certification may be appealed in accordance with this section.

7.2 Procedures

- 7.2.1 The appeal shall be filed with the Chief Fire Service Training Officer within thirty (30) calendar days of the final decision that is being appealed.
- 7.2.2 The Chief Fire Service Training Officer shall notify the Council of the appeal at the next Council meeting after receiving the appeal.
- 7.2.3 The appeal shall be in writing and contain, as a minimum, the following elements.
- 7.2.3.1 The name of the firefighter submitting the appeal.
- 7. 2.3.2 The decision being appealed.
- 7. 2.3.3 A statement of facts supporting the appeal referenced to these rules.
- 7. 2.3.4 The requested remedy.
- 7.2.4 The Council shall conduct a hearing in accordance with this section within forty-five days of receiving the notice of appeal.
- 7.2.5 Any hearing before the Council in accordance with these rules shall be conducted in accordance with the contested case procedures of the Administrative Procedures Act. At the sole discretion of the Council the appeal may be heard by the full Council or a Committee of the Council.
- 7.2.6 The decision of the Council shall be considered a final decision.

8. SEVERABILITY

8.1 The provisions of these rules are severable. If any provision of a rule is invalid, or if any application thereof to any person or circumstances is invalid, the invalidity shall not affect other provisions for applications which can be given effect without the invalid provision or application.

9. EFFECTIVE DATE

These rules shall become effective. All prior certificates and approvals issued on behalf of the Council shall continue in full force and effect except as otherwise provided.

Chapter 179: Vermont Fire Service Training Council

(Cite as: 20 V.S.A. § 3153)

§ 3153. Powers and duties

- (a) The Council shall:
 - (1) Establish by rules adopted pursuant to 3 V.S.A. chapter 25:
- (A) Minimum basic training courses for full-time firefighters and minimum basic training courses that shall be made available, on a voluntary basis, to other firefighters. Courses for persons who are not full-time firefighters shall be reasonable in terms of length, cost, location, and availability in light of the rural nature of the State and the high percentage of volunteer participation in fire service. They shall incorporate any distinct or limited functions performed by such firefighters.
- (B) Standards for approval of fire service training courses, certification of instructors, and the grounds for revocation of approval or certification.
 - (C) Training requirements for certification and recertification of firefighters.
- (D) Standards for recertification of firefighters who have not maintained their certification.
- (E) Standards relating to waivers of the training requirements of section 3155 of this title.
- (2) Encourage local governmental units to participate in the training programs established under this chapter and aid in the establishment of adequate training facilities.
- (3) Serve as the lead agency for hazardous chemical or substance incident training provided to fire service personnel statewide. All State agencies providing such training to fire service personnel shall coordinate the training with the Vermont Fire Service Training Council.

- (b) The Council may:
- (1) subject to the provisions of 32 V.S.A. § 5, accept contributions, capital grants, gifts, services, and funds from any source;
- (2) sell hats, shirts, and other memorabilia. Proceeds from these sales shall be retained by the Council to support the purposes of this chapter; and
- (3) perform such acts as may be necessary or appropriate to carry out the purposes of this chapter. (Added 1987, No. 164 (Adj. Sess.), § 2; amended 1993, No. 194 (Adj. Sess.), § 12, eff. June 14, 1994; 1995, No. 63, § 73, eff. May 4, 1995; 1997, No. 74 (Adj. Sess.), § 1; 1999, No. 49, § 195; 2007, No. 8, § 2.)
