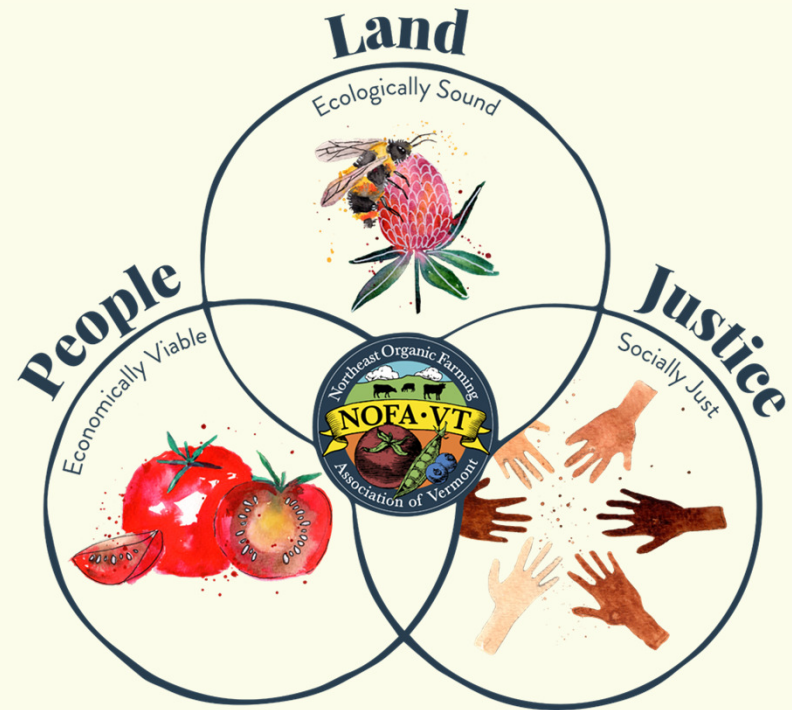

The Northeast Organic Farming Association of Vermont (NOFA-VT) is a member-driven 501(c)(3) non-profit organization promoting organic practices to build a food system in Vermont that is economically viable, ecologically sound, and socially just.

NOFA-VT was founded in Putney, VT in 1971, making it one of the oldest organic farming associations in the United States.



History & Why does it matter now?

NOFA-VT was founded by a group of farmers who believed agriculture could be done in a way that kept people and planet healthy.

We remain farmer-led, with a majority farmer board and farmer-populated committees.

Our core values of stewardship, care, relationship, equity, and ecology are more needed than ever.

We stand in a critical moment.

- Corporate consolidation in the food system
- Intensification of climate change and ecological challenges
- Demand for VT farmland at record highs
- Aging (and shrinking) farmer population

Our vision of a thriving, verdant, and just food system offers the solutions we need today.

Farmer Services

Vermont Organic Farmers

Vermont Organic Farmers (VOF) is an LLC owned by NOFA-VT. Since 1985, VOF has served as a third-party verification of organic food production and has been accredited by the USDA National Organic Program since 2002.

VOF currently certifies over 750 farms and producers around Vermont including vegetable, dairy, livestock, and maple producers.



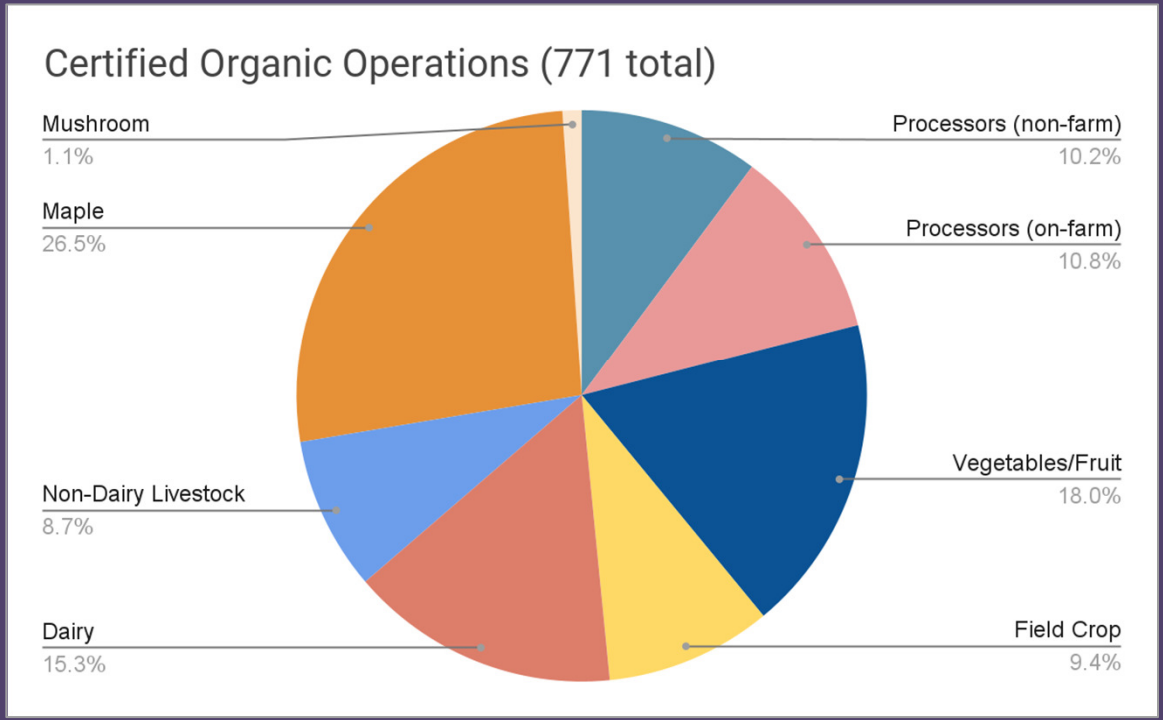
VOF Statistics | 2022

Policy Priorities

Action Needed this Session

- Securing permanent funding and support for the **Local Foods Incentive Grant** that provides a financial incentive to school districts and supervisory unions to purchase local food for their school meal programs, as well as permanent funding and support for Universal Meals.
- Securing a clear, time-bound and funded commitment to **stop contamination of soils with microplastics and PFAS**, and establishing funding and other support mechanisms for farmers whose land is found to be contaminated.
- Securing immediate relief and long-term support for **organic dairies in crisis**.
- Reinvesting tax revenue from cannabis sales into communities disproportionately harmed by cannabis prohibition, and improving access to the cannabis market for growers.

Big Picture Issues we Champion

- Streamlining access to agricultural programs, grants and services.
- Dramatically **reducing pesticide use** in agriculture.
- Increasing support for **organic agriculture as a climate solution**, including as a means of meeting emissions reductions targets set by the Global Warming Solutions Act.
- Increasing access to **affordable healthcare & childcare**.
- Improving access to **land, housing, and nourishing food** for historically marginalized populations.
- Continued engagement on **Payment for Ecosystem Services** models to ensure they center farmer needs, social justice outcomes, and holistic ecosystem function.
