1	TO THE HONORABLE SENATE:
2	The Committee on Government Operations to which was referred House
3	Bill No. 585 entitled "An act relating to amending the pension system for
4	sheriffs and certain deputy sheriffs" respectfully reports that it has considered
5	the same and recommends that the Senate propose to the House that bill be
6	amended by striking out all after the enacting clause and inserting in lieu
7	thereof the following:

21	terms set by the Board: facility employees of the Department of Corrections,

1	as Department of Corrections employees who provide direct security and
2	treatment services to offenders under supervision in the community, as
3	employees of a facility for justice-involved youth, or as and employees of the
4	Vermont State Psychiatric Care Hospital employees or as employees of its
5	successor in interest, who provide direct patient care; and
6	(ii) the following employees who are first employed in the
7	positions listed in this subdivision (F)(ii) or first included in the membership of
8	the System on or after January 1, 2025, or who are members of the System as
9	of December 31, 2024 and make an irrevocable election to join Group G on or

10	subsection (a) of this section.
11	(c)(1) A sheriff or deputy sheriff who qualifies for Group G membership
12	pursuant to this act and that has a current Level II or Level III law enforcement
13	officer certification from the Vermont Criminal Justice Council shall have a
14	one-time option to transfer to Group G on or before December 1, 2024.
15	Sheriffs and deputy sheriffs without a current Level II or Level III law
16	enforcement officer certification from the Vermont Criminal Justice Council
17	shall not be eligible to transfer to Group G. For a sheriff or deputy sheriff who
18	qualifies for Group G membership who is first employed on or after December
19	1, 2024 but before January 1, 2025, election to join Group G under this
20	subsection shall be made as soon as possible but shall be within 30 days from
21	the employee's date of hire.

1	(2) Election to join the Group G plan under this subsection shall be
2	irrevocable.
3	(d) The effective date of participation in a new group plan for those
4	employees covered under this section and who elect to transfer to Group G
5	shall be January 1, 2025. All past service accrued through the date of transfer
6	shall be calculated based upon the plan in which it was accrued, with all
7	provisions and penalties, if applicable, applied.
8	(e) The Department of State's Attorneys and Sheriffs shall notify the Office
9	of the State Treasurer of changes in a deputy sheriff's eligibility for Group G
10	within 30 days of the change in eligibility, pursuant to 3 V.S.A.
11	§ 455(11)(F)(ii)(II).
12	(f) Nothing in this section shall be read to extend postretirement health or
13	other insurance benefits to Group G deputy sheriffs who work for county
14	sheriff's departments.

16	Sec. 5. LEGISLATIVE INTENT; SHERIFF COMPENSATION
17	It is the intent of the General Assembly that a sheriff's compensation shall
18	correlate with the sheriff's level of law enforcement officer certification to
19	properly reflect a sheriff's capability to perform the various duties required to
20	effectively and efficiently manage a law enforcement agency that is the office
21	of sheriff.
