2	The Committee on Judiciary to which was referred Senate Bill No. 27
3	entitled "An act relating to reducing the imposition of cash bail" respectfully
4	reports that it has considered the same and recommends that the bill be
5	amended by striking out all after the enacting clause and inserting in lieu
6	thereof the following:
7	Sec. 1. 13 V.S.A. § 7551 is amended to read:
8	§ 7551. IMPOSITION OF BAIL, SECURED APPEARANCE BONDS, AND
9	APPEARANCE BONDS
10	(a) Bonds; generally. A bond given by a person charged with a criminal
11	offense or by a witness in a criminal prosecution under section 6605 of this
12	title, conditioned for the appearance of the person or witness before the court
13	in cases where the offense is punishable by fine or imprisonment, and in
14	appealed cases, shall be taken to the Criminal Division of the Superior Court
15	where the prosecution is pending and shall remain binding upon parties until
16	discharged by the court or until sentencing. The person or witness shall appear
17	at all required court proceedings.
18	(b) Limitation on imposition of bail, secured appearance bonds, and
19	appearance bonds.
20	(1) Except as provided in subdivision (2) of this subsection, no No bail,
21	secured appearance bond, or appearance bond may be imposed:

1	(A) at the initial appearance of a person charged with a misdemeanor
2	if the person was cited for the offense in accordance with Rule 3 of the
3	Vermont Rules of Criminal Procedure; or
4	(B) at the initial appearance offense or upon the temporary release
5	pursuant to Rule 5(b) of the Vermont Rules of Criminal Procedure of a person
6	charged with a violation of a misdemeanor offense that is eligible for
7	expungement pursuant to subdivision 7601(4)(A) of this title.
8	(2) In the event, except where the court finds that imposing bail is
9	necessary to mitigate the risk of flight from prosecution for a person charged
10	with a violation of a misdemeanor offense that is eligible for expungement
11	pursuant to subdivision 7601(4)(A) of this title, the court may impose bail in a

9	Sec. 2. PROPOSAL TO ELIMINATE CASH BAIL
10	(a)(1) The Vermont Sentencing Commission, in consultation with the
11	entities designated in subdivision (2) of this subsection, shall identify the
12	conditions that would be required to move toward the elimination of the use of
13	cash bail for the purpose of mitigating risk of flight from prosecution and
14	develop a proposal to eliminate cash bail in Vermont.
15	(2) The Commission shall solicit input from:
16	(A) the Vermont Network Against Domestic and Sexual Violence;
17	(B) the Community Justice Unit of the Office of the Attorney
18	General;
19	(C) Vermont Legal Aid;
20	(D) the Vermont Office of Racial Equity;
21	(E) the Vermont chapter of the American Civil Liberties Union;

1	(F) the Vermont Freedom Fund; and
2	(G) national experts on bail reform.
3	(b) The Commission shall report its findings and recommendations to the
4	General Assembly on or before December 1, 2023.
5	Sec. 3. JUDICIARY; NOTICES OF HEARINGS
6	(a) To reduce the instances of failure to appear by persons who are charged
7	with a criminal offense, on or before July 1, 2025, the Judiciary shall establish
8	and implement a system to electronically notify such persons of upcoming
9	required court appearances.
10	(b) On or before December 1, 2023, the Judiciary shall report to the
11	General Assembly any requests for legislation or monies necessary to fund the
12	system identified in subsection (a) of this section.
13	(c) On or before December 1, 2026, the Judiciary shall report to the
14	General Assembly on the efficacy of the notification system.
15	Sec. 4. EFFECTIVE DATES
16	(a) This section and Secs. 2 and 3 shall take effect on passage.
17	(b) Sec. 1 shall take effect on July 1, 2025.
