# **Vermont National Guard FY2022 Accomplishments**

Recognizing the roles, the National Guard fills in the State of Vermont, it's important to share the many accomplishments of our Soldiers and Airmen during FY2022. All these training and development activities directly contribute to the readiness of our soldiers and airmen meeting their federal, state and community mission.

#### Air Guard:

- The 158<sup>th</sup> Fighter Wing exited conversion on schedule at the end of 2021, making 2022 their first year as a fully operational F-35 Fighter Wing and the first in the Air National Guard.
  - o In just three months from exiting conversion, they were tasked with a short notice deployment to Germany to support ongoing NATO Air Policing missions.
    - They deployed eight aircraft flown by the Vermont Air National Guard's 134th Expeditionary Fighter Squadron, along with more than 200 Airpersons to Spangdahlem Air Base, Germany.
    - Over the course of the three-month deployment, they flew more than 450 sorties totaling more than 2,000 flying hours. They were regularly joined on these flying missions by aircraft from other NATO countries and landed in a few of them for further integration, including Romania, Bulgaria, Estonia and North Macedonia, meeting with civilian and military leadership to highlight relations between the NATO members.
  - o 81% of approximately 400 aircraft maintainers have completed advanced F-35 qualification training (5 level-Journeymen/7 level-Craftsmen)
  - O More than 160 Airpersons successfully completed a 5-day Mission Support Group Exercise at Camp Johnson practicing mission essential tasks and performing ready airman and multi-capable airperson training resulting in a trained force prepared to function in a contested and deployed environment.
  - o 33 pilots are fully F-35 qualified, 16 of whom are instructor pilots, which is the highest percentage of any F-35 operational squadron in the Air Force. The wing's first female F-35 pilot arrived on station in September of 2022 and a second female pilot, who is a former Thunderbird pilot and F-35 instructor pilot, was hired in October 2022.
- For the past several years, the 158<sup>th</sup> Fighter Wing has received outstanding unit awards and the Wing was just notified from the efforts in 2021 they received the Meritorious Unit Award for participation in Retrograde Operations from Afghanistan, Operation ALLIES REFUGE and Operation ALLIES WELCOME.
  - The 158<sup>th</sup> Civil Engineer Squadron received the Col William Deneke ANG Outstanding Civil Engineer Unit Award, and the SMSgt Gerald J. Stryzak Award.
    - The Deneke Award winner is presented to the top Air National Guard civil engineer unit based upon installation and expeditionary engineering, emergency services, environmental leadership and community support.
    - The Stryzak Award is for the best Air Force Civil Engineer Explosive Ordnance Disposal Flight.

- The Wing Public Affairs team received the Air Force Director's Excellence Award for Innovation for their outstanding photo and video products documenting the historic F-35 Round Robin Low Approaches to assure Baltic Allies during the Wing's NATO deployment.
- In 2022 four airpersons from 158<sup>th</sup> Fighter Wing non-flying combat support sections returned from deployments in CENTRAL COMMAND and INDO-PACIFIC COMMAND. 16 airpersons remain deployed; 13 deployed in support of CENTCOM and the other 3 deployed in support of CYBERCOM.
- The Vermont Air National Guard Fire Department is the primary fire and emergency response unit at Burlington International Airport. The VTANG FD routinely provides fire and emergency response support to many neighboring communities at no cost. In the past year the Fire Department responded to 244 mutual aid emergencies and 107 airfield emergencies.

#### **Army Guard:**

- <u>Recruiting:</u> Hired 14 New recruiters effectively growing field production force to 28 recruiters and partnered with VT State Police and VT Game Wardens to conduct the first Green Mountain Guardians physical fitness challenge event with high schools from across the state. RRB accessed 8 New Americans in to the VTARNG and assisted with their expedited citizenship packets.
- <u>Military Funeral Honors</u>, during February of 2022 hosted a two-week course to train Soldiers in every detail of conducting proper honors to our deceased veterans. The course was attended by Soldiers from across the country. Over a dozen Soldiers met the stringent standards and graduated with a Level 2 certification.
  - The VT MFH team conducted over 400 separate honors events across not only Vermont, but also sections of Northern New York.
- <u>86 IBCT (MTN)</u> welcomed over 1,000 Vermont Soldiers back from three separate mobilizations to Europe, Africa, and the Middle East. Our Soldiers conducted security and stability operations across 7 countries for a nearly year-long deployment. All units performed remarkably well, and some were recognized with the Army's Meritorious Unit Citation for their work during the evacuations in Afghanistan.
  - The 86 IBCT (MTN) deployed over 100 Soldiers in May 2022 for a three-week training exercise, Swift Response 2022, to our state partner North Macedonia. Swift Response 2022 was the largest ever military exercise in North Macedonia and was a combined effort of multiple countries (USA, UK, N. Macedonia, Italy, Montenegro) aimed at increasing security in the region and cooperation between partners in the region.
  - o 2022 also highlighted efforts to prepare three of Vermont's aviation units for Federal mobilizations as well as our cyber unit, which departed in February 2023.
  - O Three of our Companies conducted training at Camp Dodge, Iowa, the premier logistics training center in the nation for their two-week annual training. A total of over 100 Soldiers trained on maintenance operations, medical operations, and commodity distribution operations. This training greatly enhanced the capabilities of our Soldiers to conduct their federally assigned missions, but also prepared them well for future Domestic Operations inside the State of Vermont.

- Garrison Support Command:
  - o The 40th Army Band completed 32 different missions (concerts, parades, ceremonies, funerals) for an audience count of 24,000 in FY-22.
  - O Civil Support Team (CST) conducted 44 real world support missions, putting them in the top 20% of teams nationally in OPTEMPO, and conducted joint readiness training with the FBI. They received one of the highest External Evaluation Scores ever given to a CST by ARMY NORTH. In addition, the CST conducted 4 missions in support of Vermont's partner countries (2 in Vermont and 2 abroad), serving as the Defense Threat Reduction Agency (DTRA) evaluation team for both Senegalese and North Macedonian Weapons of Mass Destruction (WMD) teams.
  - O Det 1 supported over 140,000 man-days of through put at Ethan Allen Training Site. Many of those were by out of state units.
- Regional Training Institute's new 30 million-dollar Army Mountain Warfare school building was completed, increasing the capacity of the schoolhouse to conduct Mountain Warfare training for US Army, US Marines, Federal Agencies, and foreign partners.
- Received \$38.7M in FY22/23 federal funding for Military Construction Projects; \$18M for Bennington Armory, \$16M for Biathlon Training Facility upgrades, \$4.7M Family Services Facility.

#### Joint:

- Within the Service Member Support Directorate, J-9, initiated the implementation of the Integrated Primary Prevention Team. The team's charter is to assist the commands in implementing and evaluating suicide, domestic, sexual, and workplace violence prevention efforts.
- On September 11<sup>th</sup> the first ever joint Vermont National Guard Open House was hosted at the 158<sup>th</sup> Fighter Wing, welcoming more than 6,000 military and civilian guests on base to showcase our airpersons, soldiers, and equipment.
- The State Counterdrug Team, in addition to having personnel imbedded in various agencies to provide analytical support, provided aerial support on a total of 9 missions (Aerial Observation 7, Training to Law Enforcement 1, Search and Rescue 1).
- Vermont was selected to become the State Partnership Program affiliate for Austria. This selection formalized the history of cooperation between Austria's military and the Vermont National Guard that dates to the 1980s.
- Four Vermont National Guard member represented the United States as Biathletes in the 2022 Winter Olympics. They were SPC Sean Doherty, SPC Leif Nordgren, SGT Deedra Irwin and SPC Vaclav Cervenka. SGT Irwin placed overall 7<sup>th</sup> in the Women's 15K Biathlon individual race, which is the best individual result for a US Biathlete in Olympic history.

#### **Domestic Operations / Support to Civil Authorities:**

- More than 250 Soldiers and Air persons contributed to the multi-year state Covid-19 mission which concluded in the summer of 2022.
  - Our initial Covid-19 response included delivering more than 3 million meals, stood up a triage operation at UVMMC, worked at Covid testing facilities throughout the state and constructing a 400-bed alternate health facility in four days at a local exposition center.
  - O During the response, VTNG members administered more than 80,000 vaccinations, distributed more than 13.6 million pieces of personal protective equipment, shipped more than 1.7 million test kits and participated in the contact tracing mission, notifying more than 13,000 Covid-19 positive close contacts.
- The VTARNG responded to a call for assistance in the National Capital Region in February 2022 in preparation for the expected Trucker Convoy.
- In December 2022, the VTARNG opened five armories for use as emergency warming centers in response to the severe weather event just before Christmas.

#### **Task Force Avalanche:**

In this image below, Soldiers depart from Kabul, Afghanistan on the last U.S. C-17 aircraft following withdrawal of Afghans as part of Kabul Airlift during "Operation Allies Refuge". #### **Functions Performed by the Military Department:**

The Military Department's Narrative has in-depth information on the 5 Major Programs that make up this budget: Administration, Air Services, Army Services, Building Maintenance, and Veterans Affairs. These programs support the Missions of the Vermont National Guard (VTNG). Listed below is the state support to our core mission:

- 1. Provide command and control for the Vermont National Guard to insure it is prepared to respond to State and Federal activation.
- 2. Provide and alternate Emergency Operations Center, personnel and equipment support for Vermont emergencies.
- 3. Provide security for 4 VTNG facilities (Ethan Allen Firing Range, Camp Johnson, Army Aviation Support Facility, and Vermont Air National Guard), and firefighter support to the Burlington International Airport and surrounding communities.
- 4. Provide support services to Vermont Veterans.
- 5. Provide STEM education opportunities to Vermont children though the STARBASE program.
- 6. Maintain VTNG buildings and property; to include 17 armories and roughly 12,000 acres throughout the State.
- 7. Provide engineering, environmental and energy efficiency oversight.
- 8. Administer contracting services to VTNG.
- 9. During State Fiscal Year 2023, the Military Department employs 167 personnel, 148 receive Federal Funding and only 17 are 100% State Funded.
- 10. During Federal Fiscal Year 2022, the VTNG employed approximately 902 full-time personnel and 2,915 part-time personnel, totaling \$147M in federal payroll. Total VTNG spending was \$290M federal dollars in pay, Operations & Maintenance, and Military Construction.

# **Performance Measures:**

The Military Department's performance is measured by the ability of the VT National Guard to accomplish its state and federal missions. The VTNG Joint Leadership Council has established three (3) strategic goals for the total VTNG. Those goals are:

- 1. Ready: Increase forces available to achieve state and federal missions
- 2. Reliable: Enhance our professional workforce's capability to support state and federal missions
- 3. Relevant: Seek emerging missions for which we are uniquely suited

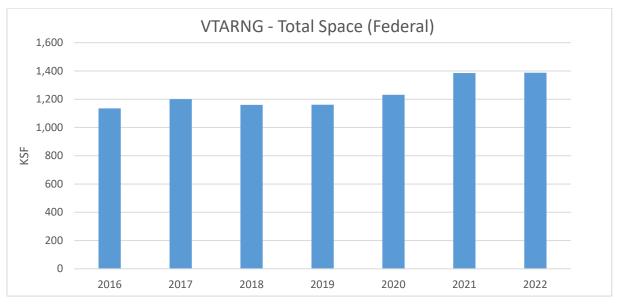
Progress towards accomplishing these goals is measured by the VTNG strategic planning office, based on performance standards established and assessed by Army and Air Guard leadership. To meet the TAG's objectives, we provide facilities, ranges and airfield readiness.

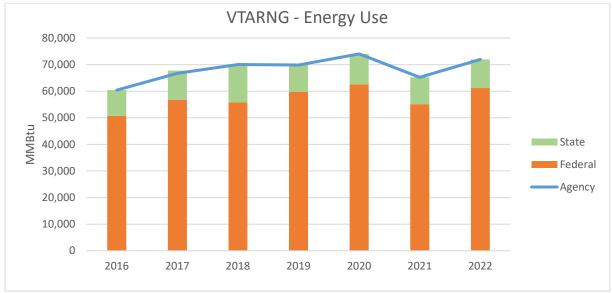
# **Performance Management Outcomes:**

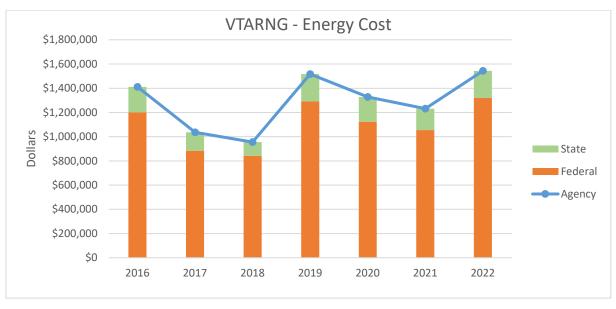
The Military Department submitted three items as part of the Results-Based Accountability (RBA) process:

(1) Energy Management is an ongoing priority for the Vermont National Guard and the Military Department. The Department has gained nearly 300K square feet of Army facility space over the last seven years. Although the overall energy consumption has increased marginally, the state share of total energy consumption continues to remain around 2015-2016 levels. This is attributed to maximizing the federal match to upgrade heating systems to include geo-thermal,

wood chip, natural gas, upgrading electrical systems to incorporate solar power, and converting lighting to LED. Additionally, there have been many facilities upgrades to include new insulation, windows, and doors. All new construction meets Leadership in Energy and Environmental Design (LEED) standards.

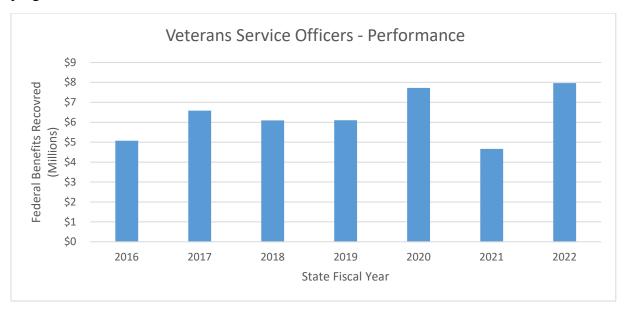






(2) State Veterans Service Officer (VSO) Performance Activities: State VSOs are part of the Office of Veterans Affairs. Their function is to provide outreach to over 40,000 veterans currently living in Vermont and to advocate on their behalf regarding benefit claims to the federal government. They also conduct workshops for veterans and veterans' groups to connect them to available resources. Salaries/benefits for the 4 VSO positions total approximately \$360K annually and is paid from the General Fund. As represented in performance measures; they are doing great work helping veterans receive their benefits which in-turn reduces hardships to our veterans. Their caseload in FY22 was 574 claims, and they helped veterans recover over \$7.9 Million in federal benefits. This generates a return on investment of \$22 of Federal benefits for every \$1 of State funding which pays for the VSO salaries/benefits.

As discussed above, the Military Department is seeking funding for two additional VSO positions to support the increased volume of claims we are already experiencing as a result of the PACT Act. As Veterans needs for services continue to grow, it is critical to recognize the Veterans Service Officers perform an invaluable service in support of our veterans, relieving many burdens and financial hardships while also reducing their dependence on state benefit programs.



(3) Joint Enlistment Enhancement Program (JEEP): During Fiscal Year 2021 the Military Department piloted a new program to incentivize non-recruiters to become a recruiting assistant by supporting the enlistment of Soldiers and Airmen into the Vermont National Guard. Eligible participants receive an inventive payment of \$500-\$1,000 once their referral enlists into the VTNG and ships to initial entry training. There have been 76 total enlistments through this program, 28 for Army and 48 for Air, for a total General Fund cost of \$59K since FY21.

# **Federal Funding:**

Federal funding is provided to the Military Department through Master Cooperative Agreements with the National Guard Bureau to accomplish the various programs mentioned above. Many of these programs are funded with 100% federal dollars, while others such as the Air and Army facilities programs are funded with a combination of state and federal dollars.

Total Military Department expenditures in FY22 were \$52M: \$45M of Federal Funds, \$5M General Funds, \$313K Special Funds, \$1.5M Capital Construction, and \$193K in support of VTNG COVID response efforts. Spending on military operations alone totaled \$49M, of which \$45M was federally reimbursable, leaving the state with \$3.5M or about 7% of the total cost. This represents \$13.30 of federal reimbursement for every \$1 of General Funds spent.

The department continues to see a rise in overall federal spending for ongoing design and construction efforts for several Major Military Construction projects, including the Army Mountain Warfare School in Jericho, VT and a new readiness center in Bennington, VT. Spending for these projects totaled nearly \$19M of Federal Funds in FY22.

#### **Single Audit**

The Military Department received a single audit of the Master Cooperative Agreements program for FY 2021 which resulted in no findings.

#### **Grants:**

Several grants are administered by the Military Department through legislative language:

- Under E.215 \$1.32M of General Fund will go to VSAC for scholarships to support the Vermont National Guard Tuition Benefit Program.
  - In FY22, VSAC executed \$760K under the Tuition Benefit program. Effective for the current academic year, scholarships are now available to students completing second bachelor's degrees, master's degrees, and certificate programs. Of the 74 participants this academic year, there are 4 students utilizing this benefit for master's degree programs, 2 for second bachelor's programs, and 4 for certificate programs.
- Under E.219 In the Veterans Affairs division, Fiscal Year 2024 appropriates \$7,500 for the Veterans Day Boy Scouts parade; \$1,000 for Veterans Medals; \$10,000 to the American Legion in support of VT Boys and Girls State; \$4,800 for the expenses of the Governor's Veterans' Advisory Council.
- Under B.1100 (a)(9) One-time General Fund Appropriations:
  - \$10,000 for granting to the USS Vermont Support Group, a non-profit organization supporting military members serving on the USS Vermont (SSN 792) and their families.
  - \$10,000 for granting to North Country Honor Flight, an organization that sponsors an escorted trip for veterans to visit the various war memorials on the National Mall, to cover the expenses of ten Vermont resident attendees.

#### **Summary of Key FY 2024 Issues and Highlights:**

The Military Department FY24 budget represents an overall increase from FY23 of 3% with only two exceptions:

- (1) Effective in Fiscal Year 2023, the Military Department has been recognized as an agency as opposed to a large department, resulting in salary increases for two positions within the Administration appropriation. Reflected in Attachment B. of the budget request is a line-item increase of \$50,777, representing the cost above and beyond a standard 3% increase for those positions.
- (2) Within the Office of Veterans Affairs are four Veterans Service Officer (VSO) positions. VSO's help coordinate Veterans benefits through outreach and assistance with completing various benefit applications. The Department has historically held three VSO positions and was fortunate to have gained the fourth position in FY23 to help address the workload and growing backlog of claims. This team recovers anywhere from \$4M to \$8M of new Federal benefits for Vermont veterans on an annual basis.

In 2022, US Congress passed a new law in support of veterans who were exposed to toxic substances during military service. The Honoring our Promise to Address Comprehensive Toxics Act of 2022 (PACT Act) significantly expands health benefits to veterans exposed to burn pits, Agent Orange and other toxic substances. With the passing of this law, the Department anticipates a rise in claims through the Office of Veterans affairs as Vermont veterans and their survivors apply for federal benefits.

Included in the Governor's Recommended Budget for FY24 is funding for two additional Veteran Service Officer positions totaling \$171,610. Funding for these positions is essential for the State to provide the required service in support of Vermont veterans and their survivors. These positions have been reallocated from other vacant positions within the Military Department's existing position pool and are ready to be recruited should funding be made available.

The department anticipates that some federal funding will flow into the state within the next fiscal year to support the Veteran Service Officer program following the enactment of the PACT Act. It is not currently clear the timeline or amount of funding that can be expected, but we will continue to seek guidance as it becomes available.

Wages and benefits for the Military Department are budgeted at a total of \$15.8M for FY2024, of which the State's share is \$2.6M; \$1.7M of General Fund is dedicated to military operations and \$940K to Veterans Affairs. 148 of the department's 167 positions receive varying levels of Federal Funding averaging at about 94%. 17 positions are 100% State Funded; 7 are dedicated to military operations and the other 10 to the Office of Veteran's Affairs. 1 position is fully funded through the Vermont Veterans Cemetery Special Funds.

Operating costs continue to rise across the board as much of our General Fund appropriation supports utilities and maintenance of military facilities. In addition to rising inflation, more stringent "Buy American" requirement will further increase the cost of projects utilizing federal and state dollars.

#### **Budget Development Form:**

In FY24 the Military Department's total budget increased \$403,662 or 6.7% from FY2023.

The Administration realized overall General Fund increases of 5.6%, made up of pay and benefit increases for 7 state funded positions and increases to Internal Service Funds (ISFs), which are nearly all housed within the Administration appropriation. Apart from Workers Compensation, ISFs are considered overhead costs and are not allocable to the Master Cooperative Agreement, making them ineligible for federal reimbursement. Also in this appropriation is funding for the Vermont National Guard Tuition Benefit Program, for which \$1.3M is requested in FY24, level to the FY23 budget request.

Air Services General Funds will support 20-25% of the Facilities Operations & Maintenance (O&M) Program at the VTANG Fighter Wing and 25% of the VTANG Environmental Program. General Funds increase by 4.6% for pay and benefit costs for 18 positions as well as increased operating costs. Changes in personnel costs include regular pay and benefit increases as well as a savings of \$7,500 due to the elimination of a part-time temporary administrative position. Federal Funds support 75-80% of the Facilities O&M Program, 75% of the Environmental Program and 100% of the Security, Fire Protection and STARBASE programs. Federal Funds will increase in line with GF as personnel and operating costs rise. The department took on a new 100% federally reimbursable program in FY23 for Sustainment, Restoration and Modernization of VTANG facilities, resulting in a large increase to other personal services.

The Army Services appropriation funds several Army National Guard Programs including Facilities O&M, Environmental, Training, Security and more. The majority of Army programs are 100% federally funded, with the exception of Facilities O&M which ranges from 50-75-100% federally funded depending on the facility. State match for this program can be found in the Building Maintenance appropriation. Federal funding will remain elevated in the coming years due to anticipated awards for Military Construction projects. In FY24 the department expects to award construction contracts for a new Family Services Center at Camp Johnson (\$4.7M), improvements to the Biathlon at the Ethan Allen Training Site (\$16M), as well as several other design projects totaling around \$7.5M. These projects will be 100% Federally funded through Military Construction Cooperative Agreements.

Building Maintenance provides the state share of the facilities program under the Army Services appropriation, including 50% of all maintenance and operating expenses for State Armories. There is a minimal increase for pay and benefits for 19 full time positions, as several retirements by long-term staff have created some savings for FY24. Operational costs rise to support increased cost of utilities, fuel, and overall rising cost of inflation.

The Veterans Affairs appropriation funds 13 full time employees at the Office of Veterans affairs and Veterans Memorial Cemetery. 10 positions are 100% General Fund, including the 2 additional Veteran Service Officer positions requested in this budget (\$171,610). Veterans Affairs has also experienced several retirements by long-term employees recently, creating a significant savings in pay and benefits in FY24 and providing some offset to the cost of the additional VSO positions. Operating costs include Fee for Space for the Office of Veterans Affairs, travel and training for staff, and several grants mentioned in the section below.

Included in this appropriation is the Special Cemetery Fund for maintenance and operation of the Vermont Veterans Memorial Cemetery. Funding is provided by the Department of Veterans Affairs for internments at the cemetery. Lastly, federal dollars fund payroll and expenses for an Educational Officer position, who audits compliance with the Post 9/11 GI bill at colleges and universities in Vermont.
