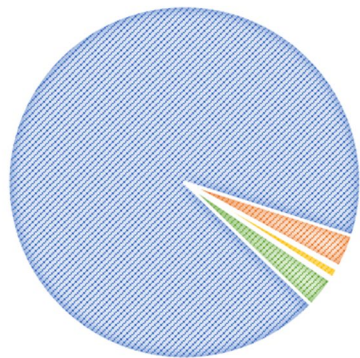

## FY 2024 SUMMARY & HIGHLIGHTS

### Priorities

### Correctional Services 3480004000

- ❖ **\$3,591,029.15** General Fund – This total includes funding as follows:
  - **\$777,170.00** of Justice Reinvestment II funds from Out of State Bed savings. These funds currently sit within the Correctional Services appropriation but will be moved to the new Justice Reinvestment II appropriation through the FY23 BAA.
  - **\$958,470.00** of general fund dollars from use of Emergency Rental Assistance Program (ERAP) funds. These funds will be applied toward one-time permanent housing initiatives in line with the Governor’s broader permanent housing goals.
  - The balance of general fund totaling **\$1,855,389.15** has been approved for Pay Act needs in FY23.
- ❖ **\$4.52** – Corrections Donations Fund – These funds remain from a donation received in FY12 from United Way for the Hometown Heroes program. These funds cannot be spent and should be swept by Finance and Management. Included in FY23 BAA proposal to move to the General Fund.

### Correctional Facilities Recreation Fund 3480005000

- ❖ **\$378,685.85** Inmate Recreation Fund has historically been self-funded, largely by commissions from Incarcerated Individual (I/I) purchases through the facility commissary system and telephone usage. This fund is self-sustaining but relies on the ability to carry forward the fund balance annually. The fund use is restricted by statute to the following purposes:
  - I/I postage;
  - Staff costs for Facility Recreation Coordinators;
  - Oversight and accounting of I/I cash accounts;
  - I/I recreation activities;
  - Voluntary I/I contributions that promote restoration of crime victims or communities

**Corrections Out of State Beds 3480006000**

- ❖ **\$1,982,246.88** General Fund – Per Sec. E.335.1 of Act 154, this remaining balance is to be carried forward to be used for Justice Reinvestment II (JRII). FY23 BAA will move this into the JRII Appropriation 3480007000.

**DOB Body Cameras 3480892201 – One Time Appropriation**

- ❖ **\$1,000,000.00** General Fund – These funds were appropriated in FY21 to implement the departments Body Worn Camera program. Request for Proposals was issued in April 2022, Contract awarded in November 2022.

#### Sentenced Statuses:

- Sentenced: convicted of crime(s)
- Sentenced/Detained: convicted of crime(s) and held pre-trial for other crime(s)
- Sentenced W/Hold: convicted of crime(s) and held for US Marshals or other jurisdiction
- Sentenced/Detained W/Hold: (rare) convicted of crime(s), held pre-trial for other crime(s), and held for US Marshals or other jurisdiction

#### Detained Statuses:

- Detained: awaiting conviction for crime(s)
- Detained W/Hold: awaiting conviction for crime(s) and held for US Marshals or other jurisdiction

#### Hold Status:

Hold: being held for US Marshals or other jurisdiction

**NOTE: Individuals in each booking status are considered in the custody of the Commissioner of Corrections. The Commissioner has authority to make release decisions for incarcerated individuals with a "sentenced only" booking status consistent with the law and when taking public safety into consideration. All other booking statuses require action by another authority (e.g. the court) to release a person from incarceration.**

### Crime Types

Incarcerated individuals are classified into different Crime Types based on the most serious crime for which they are sentenced, detained, or held. For example, 01:Fel./Serious. The number (e.g., 01) indicates the severity of the crime ranked from 01-11 from most severe to least severe. Next, the Crime Type displays whether the most serious crime was a felony (Fel.) or misdemeanor (Misd.). Finally, the category of crime is provided (e.g., Serious). See below for examples of each Crime Type. Each individual is counted once in the crime type data.

#### Crime Type Examples:

- 01:Fel./Serious:** Aggravated Assault, Aggravated Sexual Assault, Murder
- 02:Fel./Person:** Assault and Robbery, Lewd and Lascivious
- 03:Fel./Property:** Burglary Occupied, Grand Larceny, Arson
- 04:Fel./Drug:** Dealing, Trafficking, Possession and Sale
- 05:Fel./MotorV:** DUI 3 or more
- 06:Fel./Other:** Obstruction of Justice, Fugitive
- 07:Misd./Person:** Domestic Assault, Simple Assault
- 08:Misd./Property:** Unlawful Trespass, Retail Theft
- 09:Misd./Drug:** Possession of drugs
- 10:Misd./MotorV:** Careless and Negligent Operation
- 11:Misd./Other:** Violations Conditions of Release

- Some Other Race/ Unknown: "Other/ Unknown"

Some race categories are combined due to the low number of individuals who identify with these races. In some instances, individuals who identify as American Indian/Alaskan Native, Asian, Black or African American, and/or Pacific Islander were combined and indicated by the acronym "BIPOC", which means Black, Indigenous, and people of color. Some Other Race and Unknown were collapsed as neither provide information of the race with which the individual identifies.

Hispanic, Latinx, or Spanish Identification is captured with a separate yes/no identification.

Both Race and Hispanic, Latinx, or Spanish Identification require a selection.

## Gender Data:

In this report, gender data are categorized as follows:

- Cisgender Female: Sex female, identifies female ("Female")
- Cisgender Male: Sex male, identifies male ("Male")
- Transgender Female: Sex male, identifies female ("Transgender")
- Transgender Male: Sex female, identifies male ("Transgender")
- Intersex: A term referring to people who have physical markers that differ from the medical definitions of male or female ("Intersex")
- Other: Individuals who do not identify with any of the above gender categories ("Other")

NOTE: Transgender Female, Transgender Male, and Other were combined into one category: "Transgender/Other" for this report due to low numbers of individuals who identify with these genders. 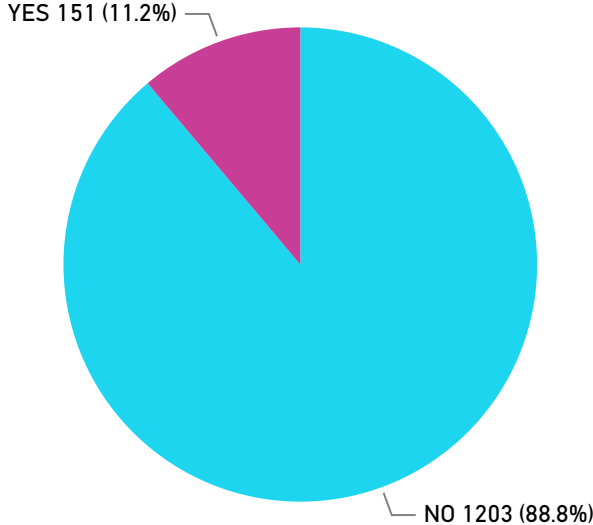

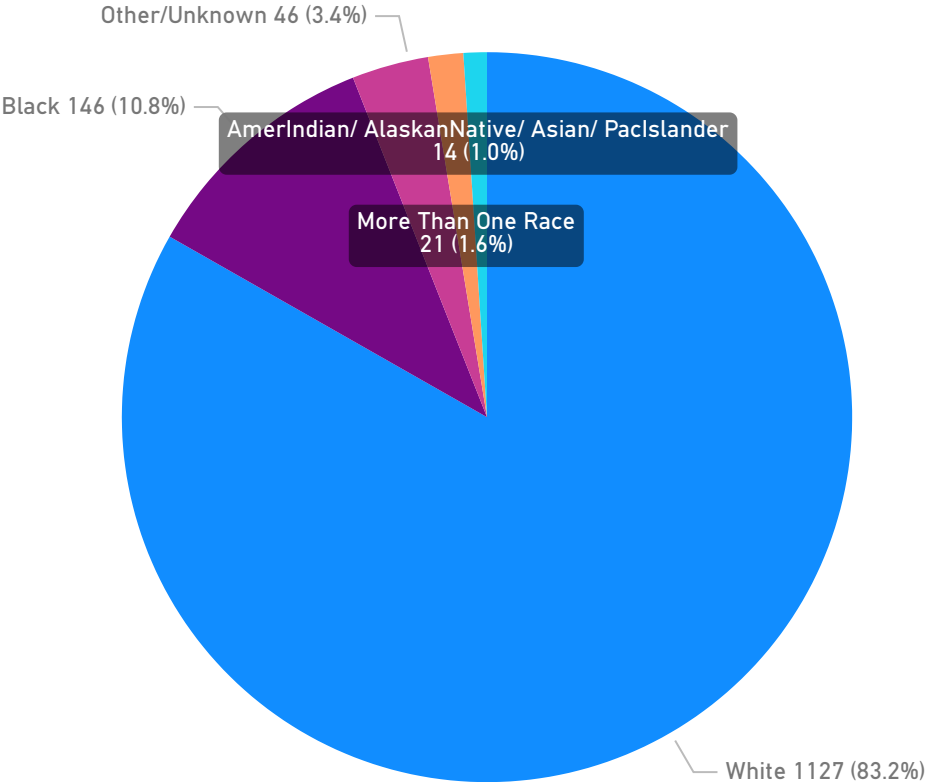

### Incarcerated Population by Hispanic/Latinx/Spanish Identification

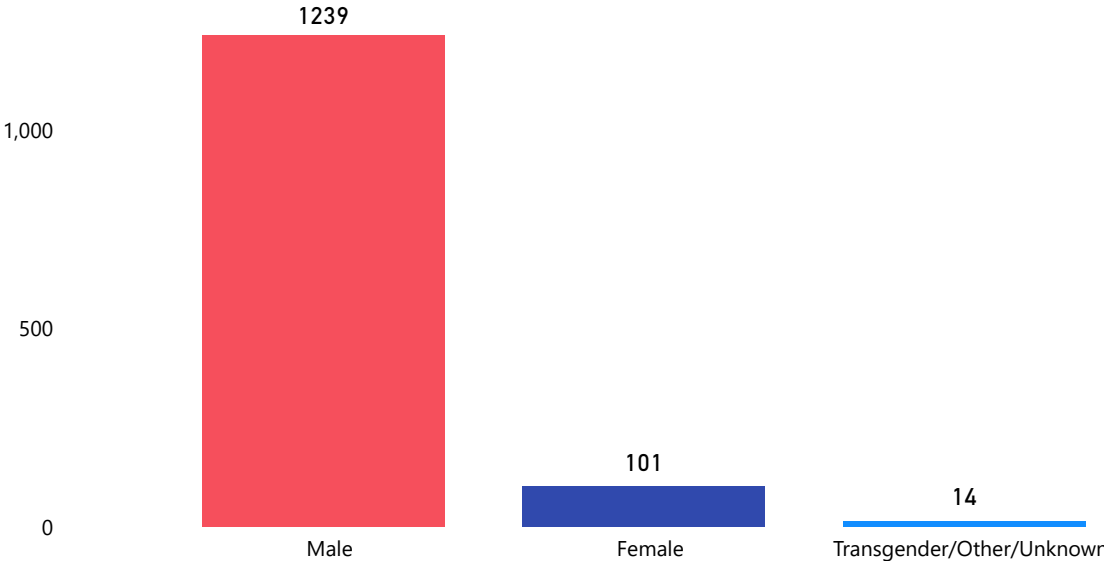

### Incarcerated Population by Race | N= 1354

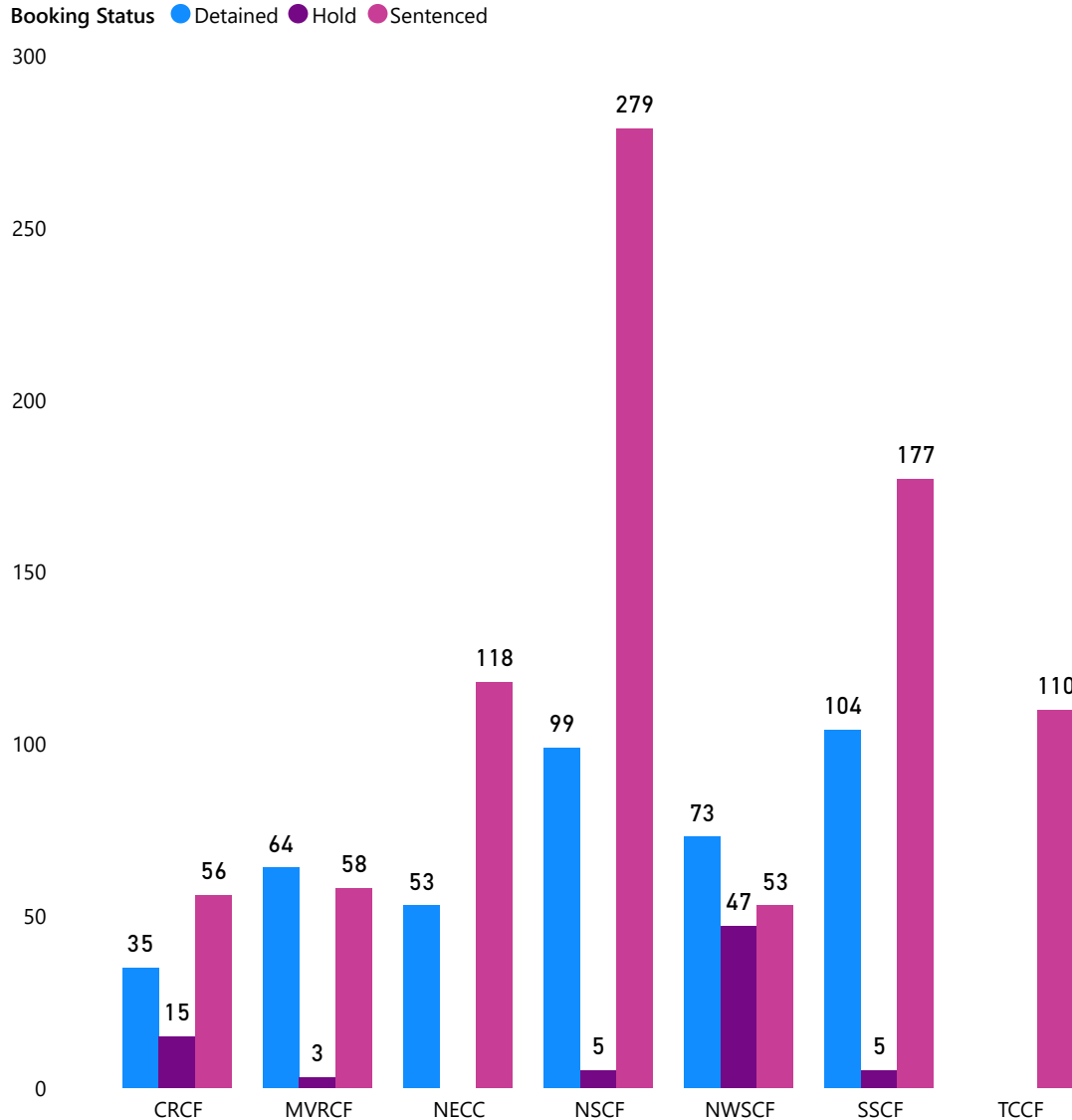


### Incarcerated Population by Gender | N= 1354

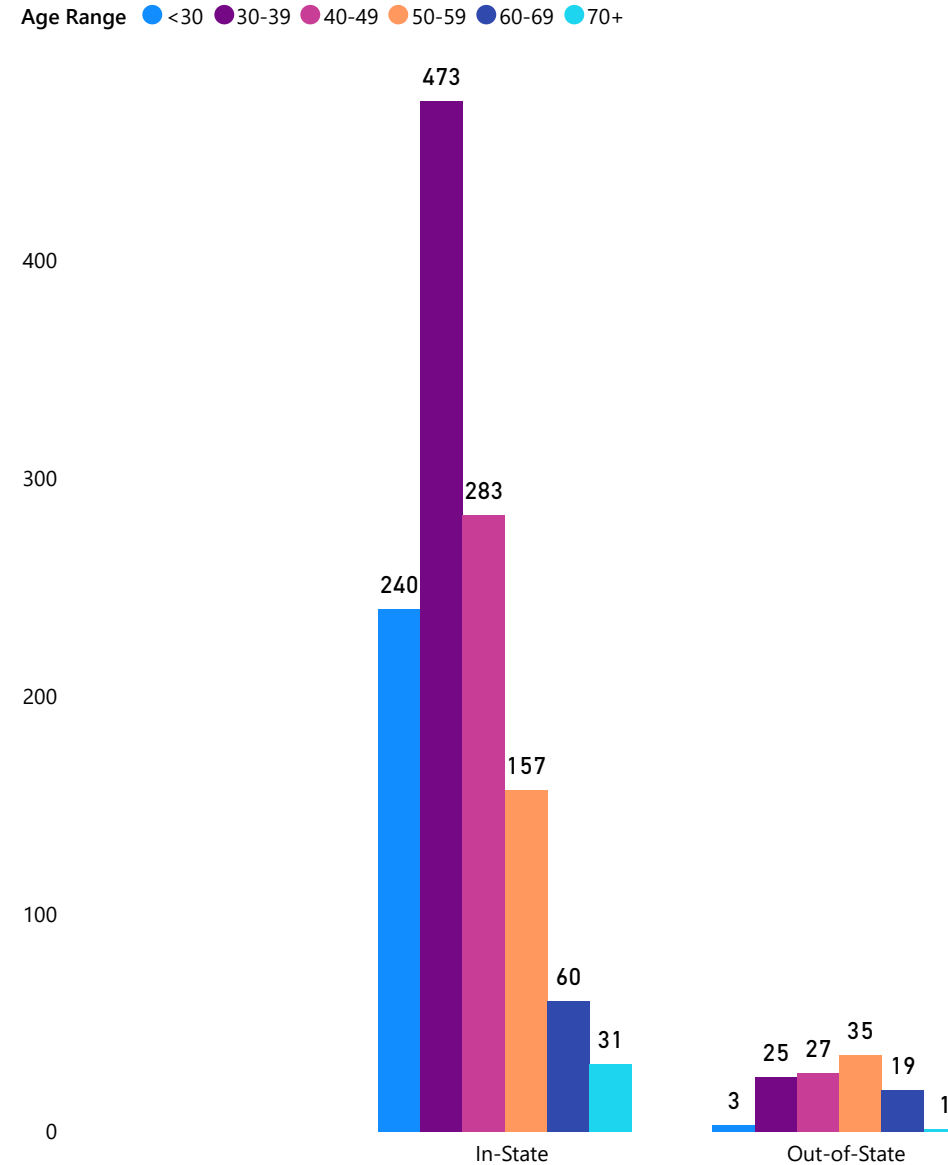

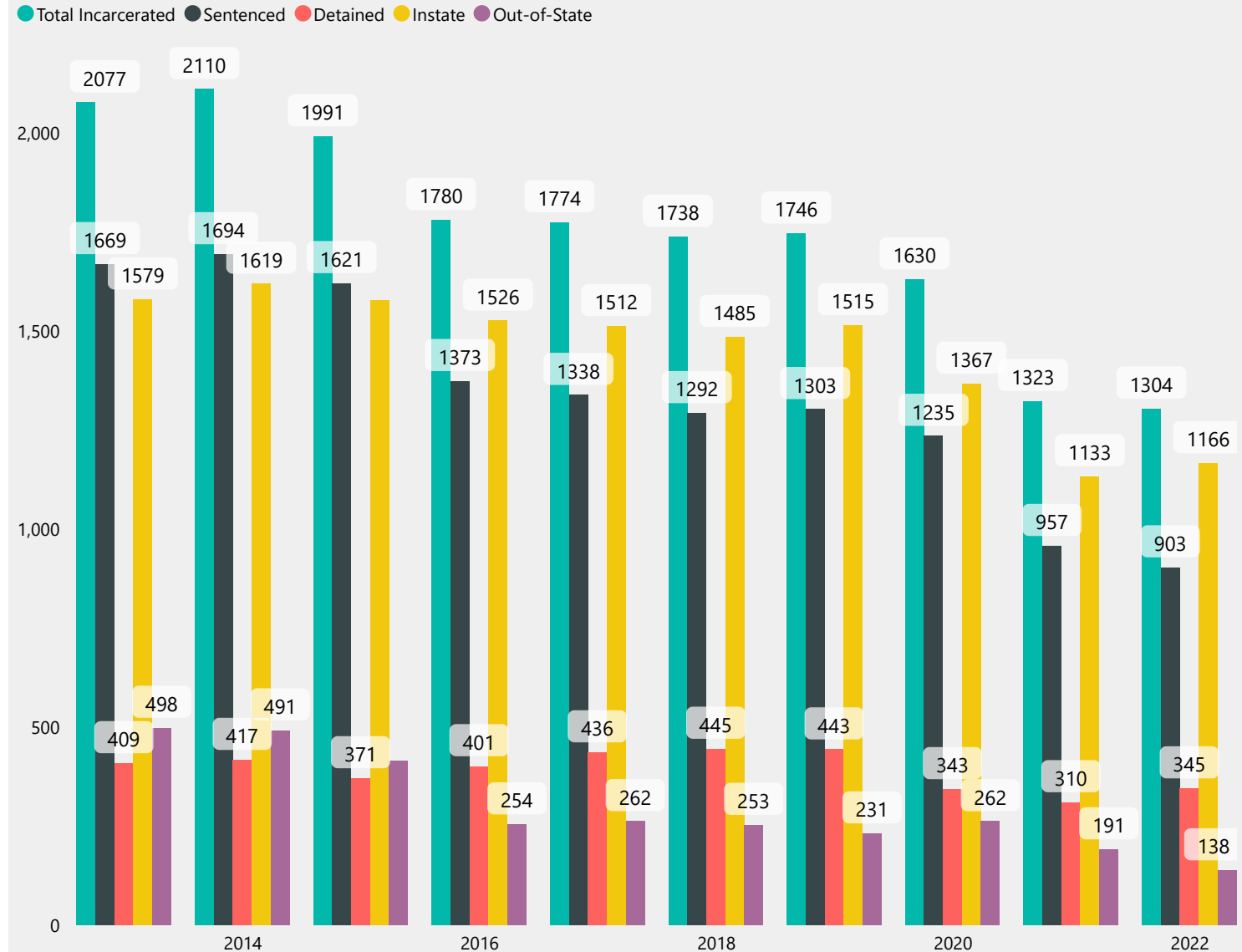

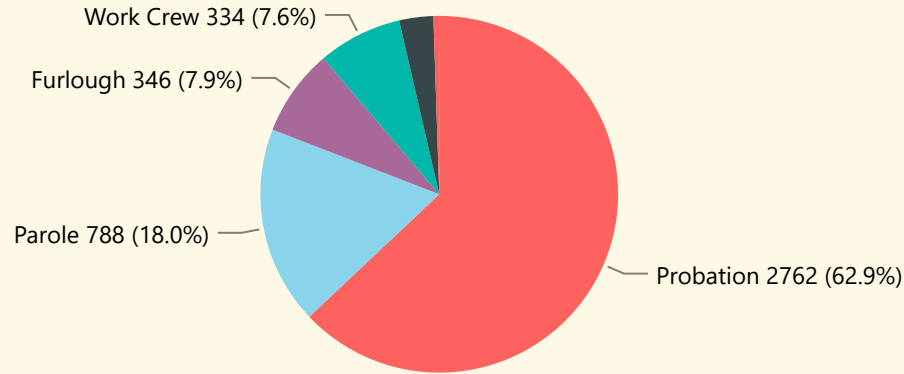

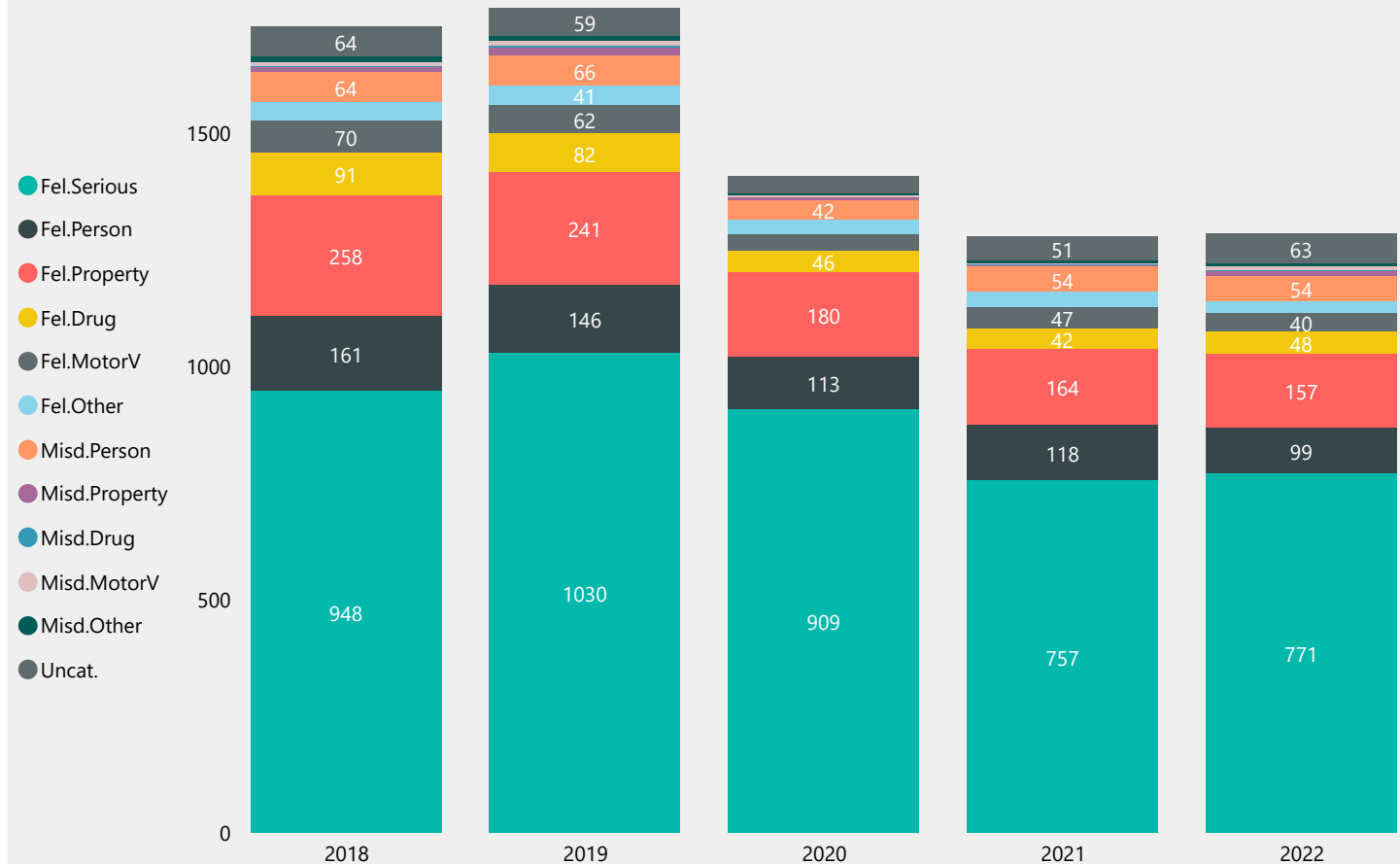

Figure 4: FY22 Returns to Incarceration from Community Supervision by Reason for Return

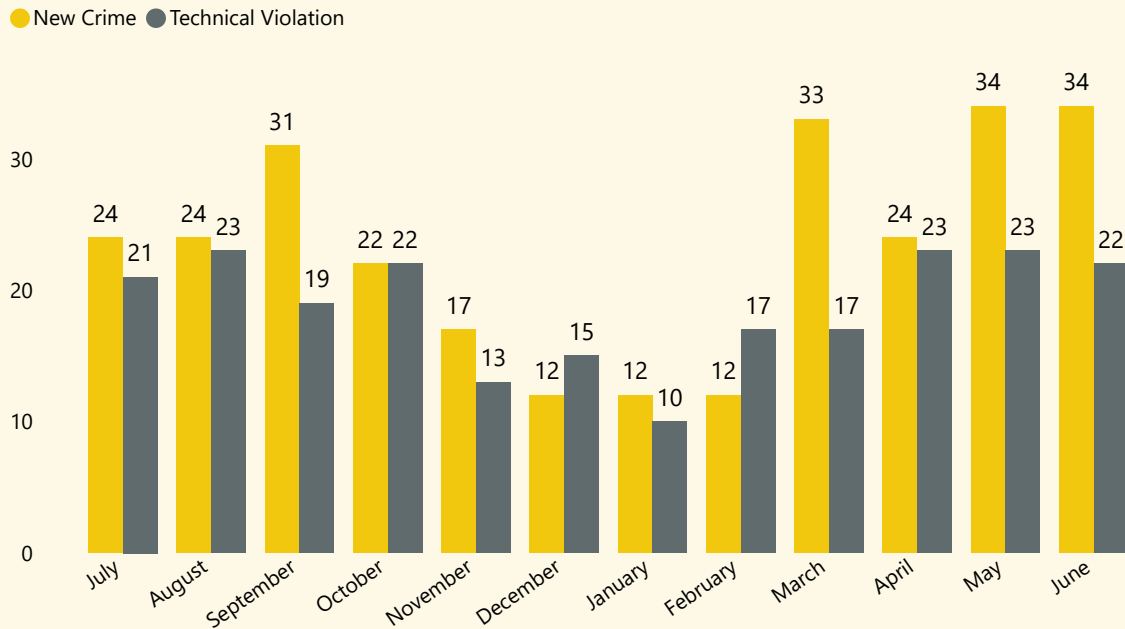
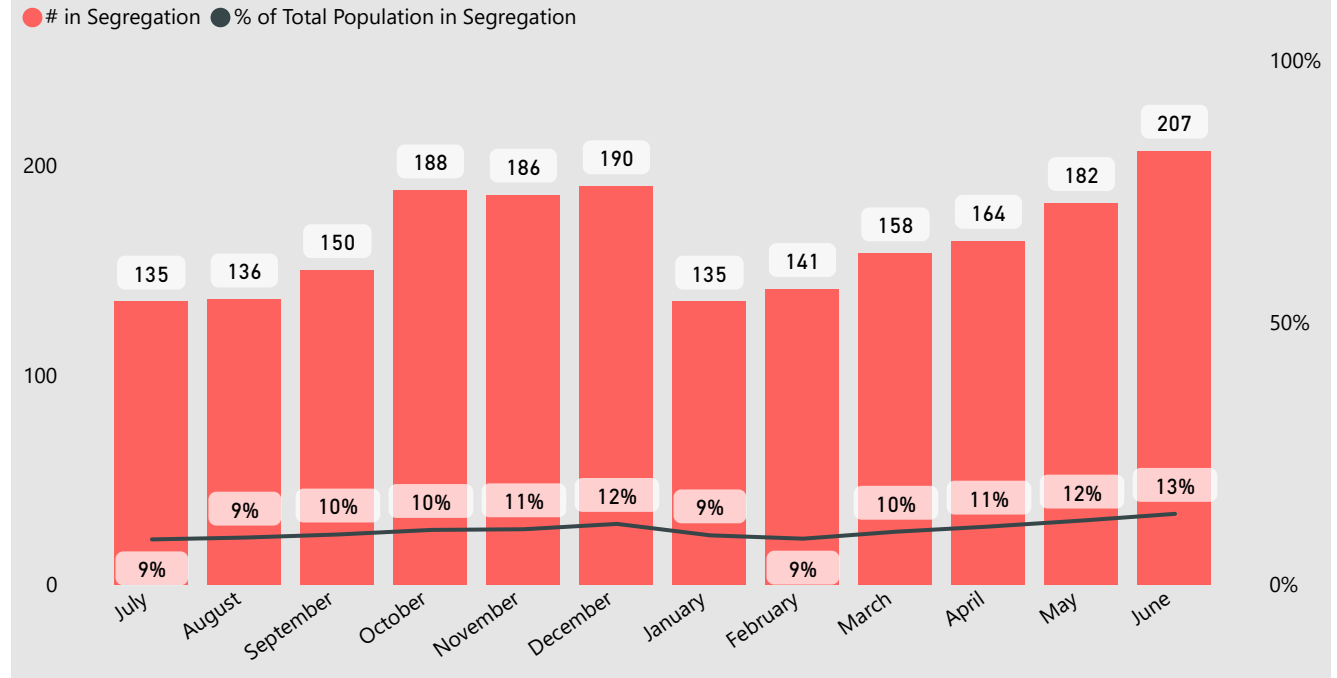


Figure 5: FY22 Monthly Totals and Percent of Incarcerated Population in Segregation

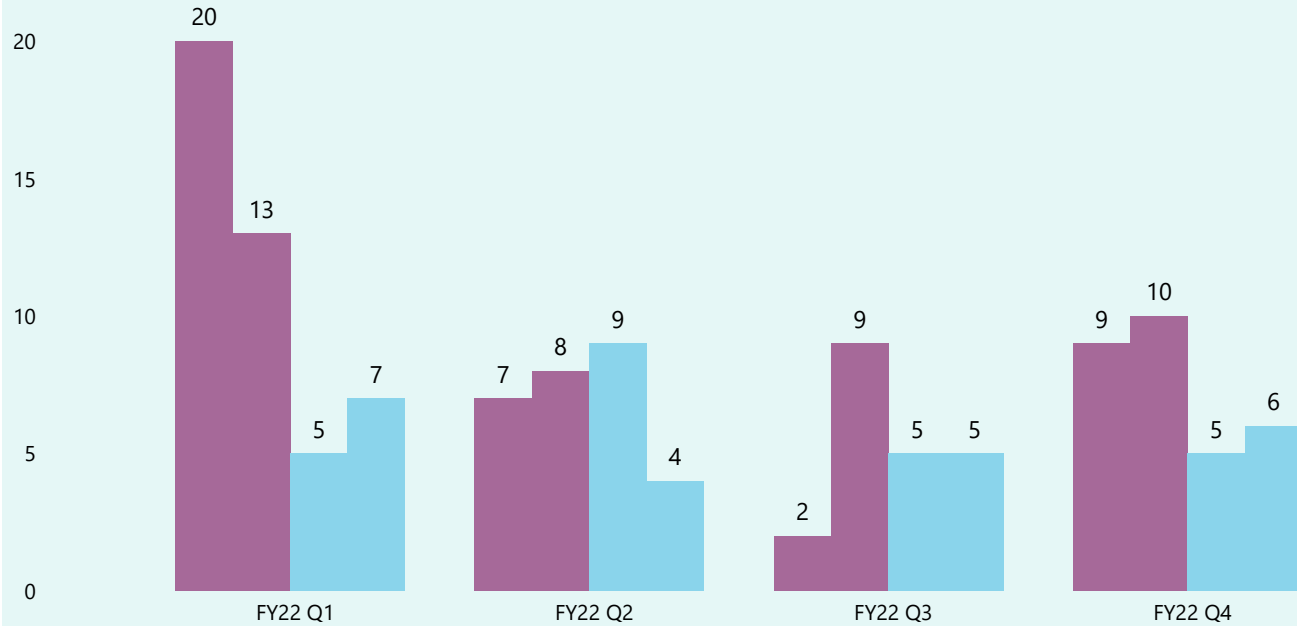

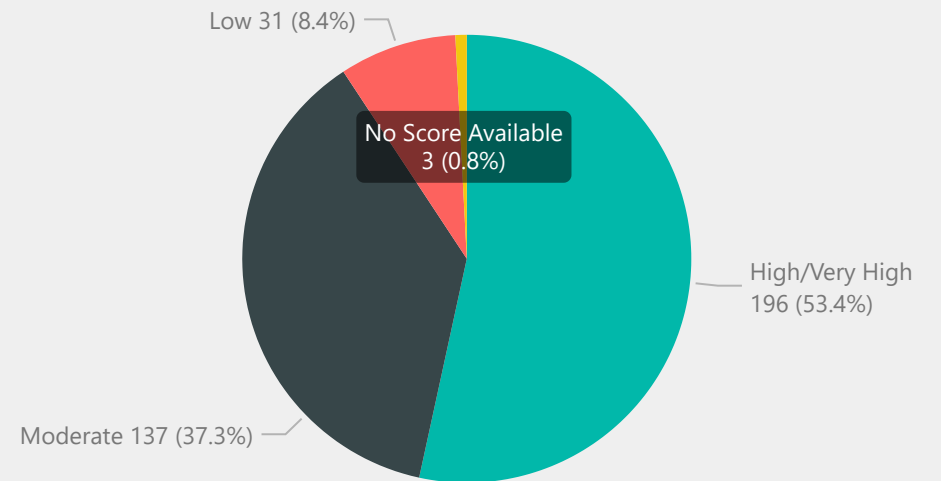

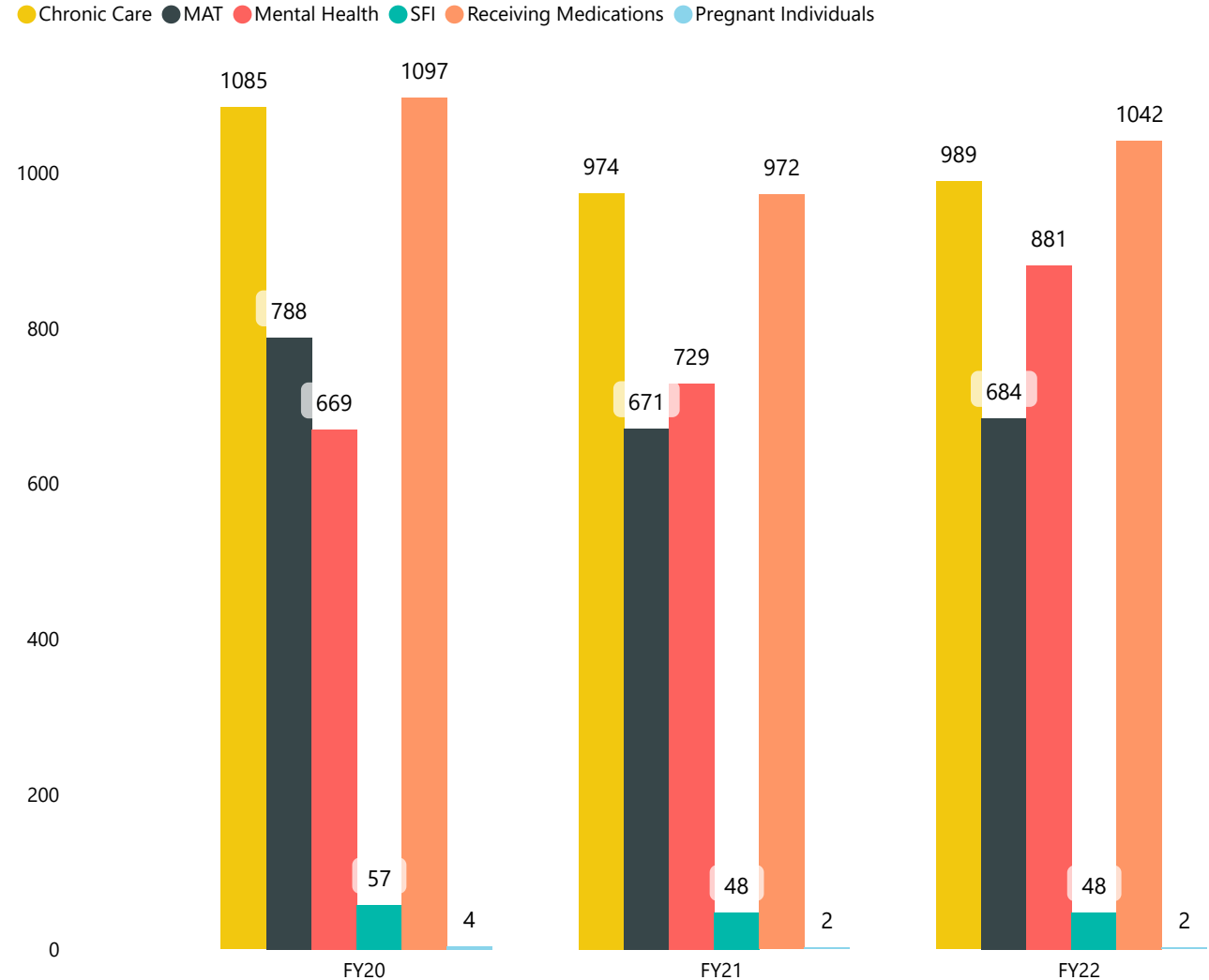

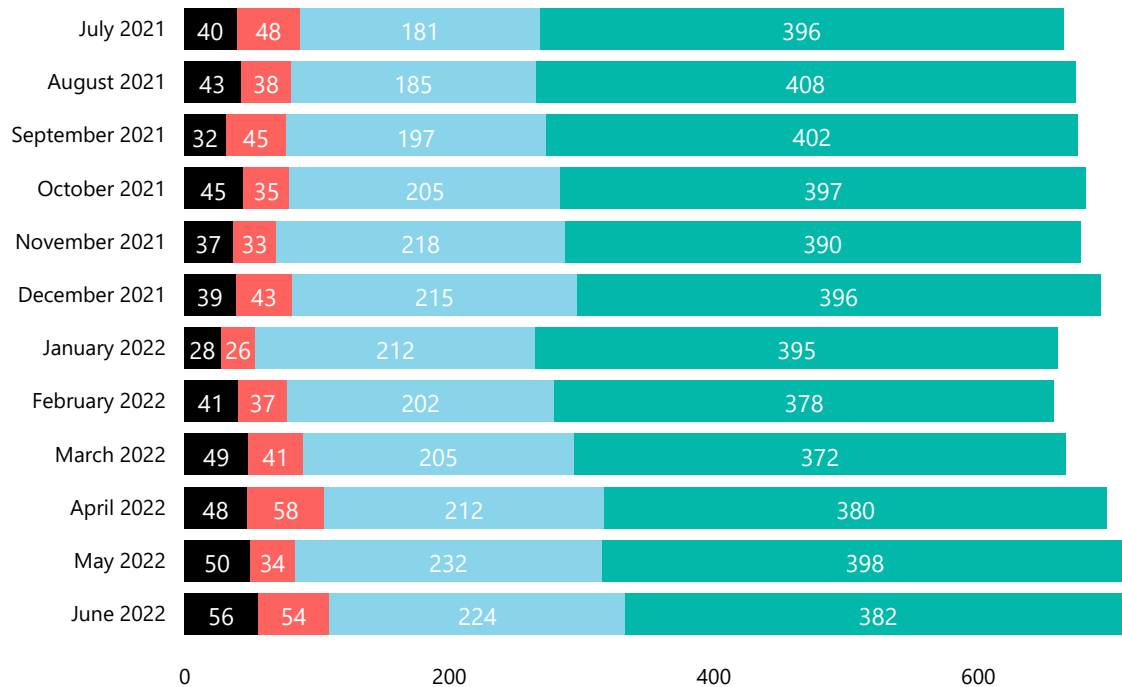
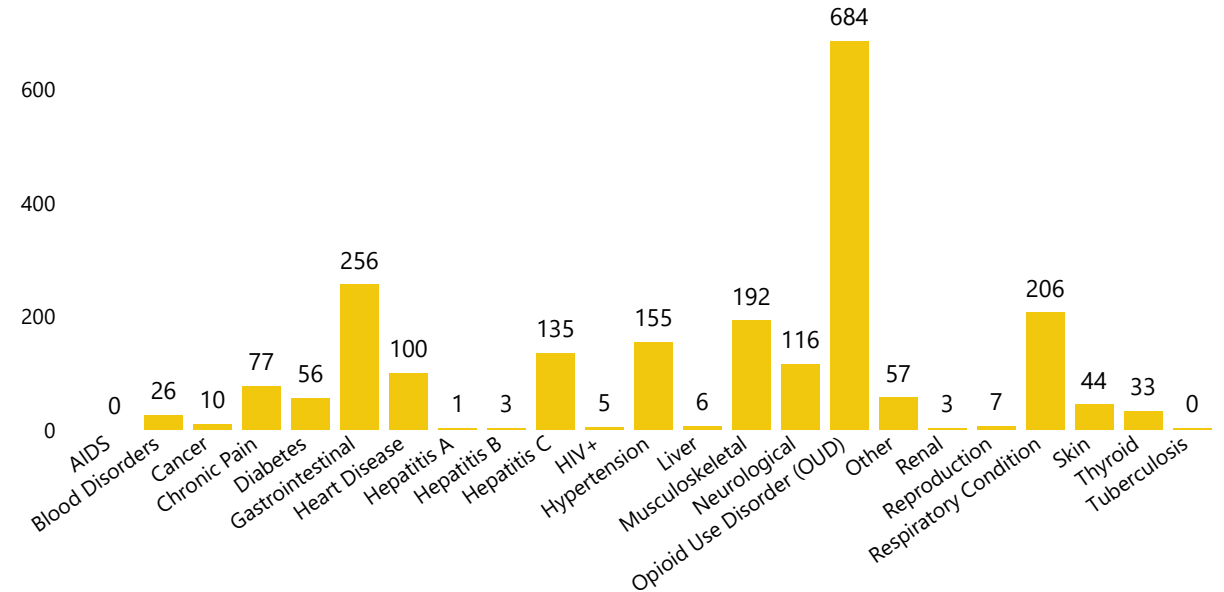


Figure 10: FY22 Average Monthly Incarcerated Individuals Receiving Chronic Illness Care by Condition

Figure 12: Emergency Room Visits By Month in FY22

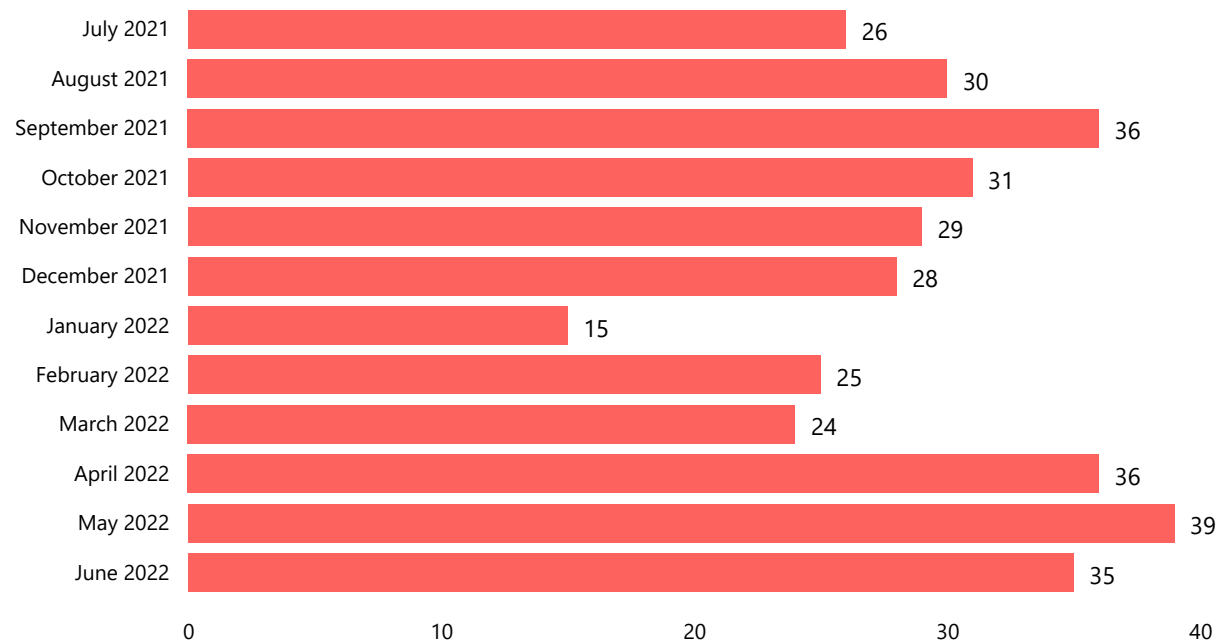
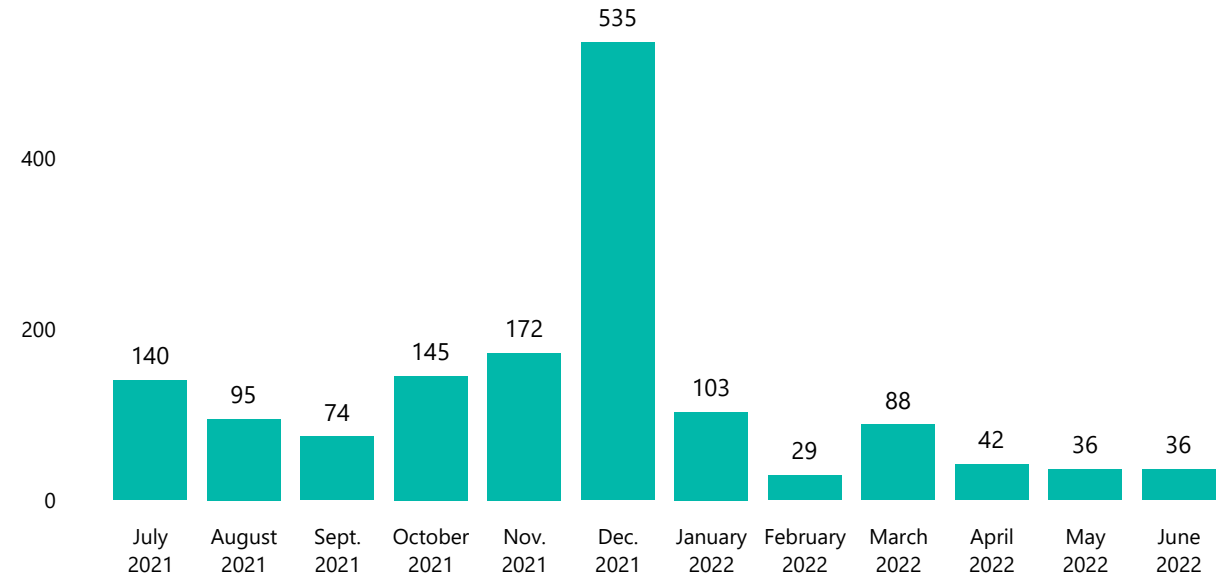


Figure 13: Total Vaccinations by Month in FY22

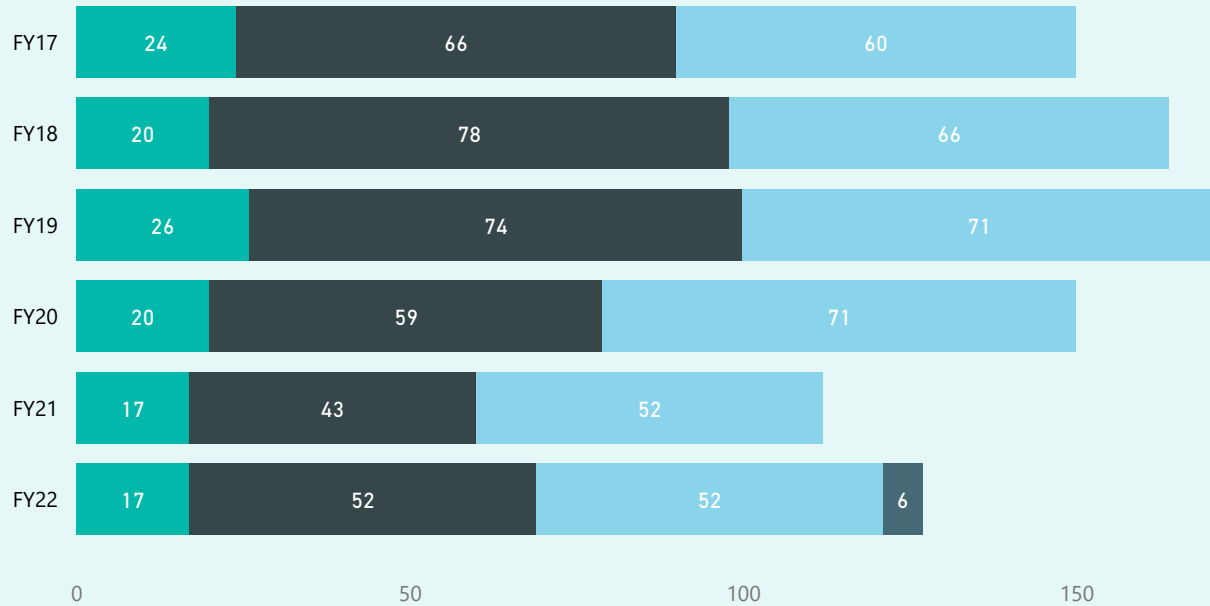

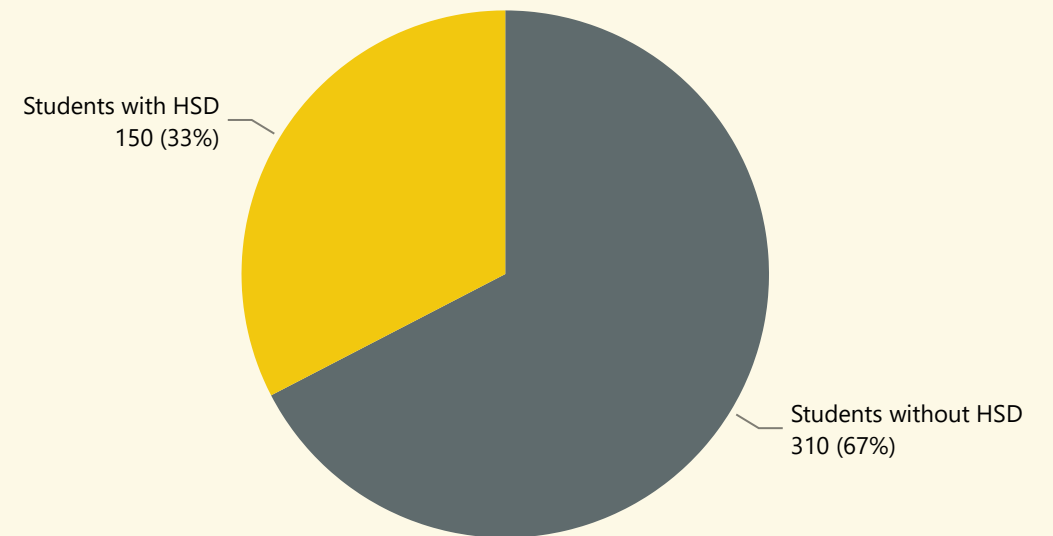

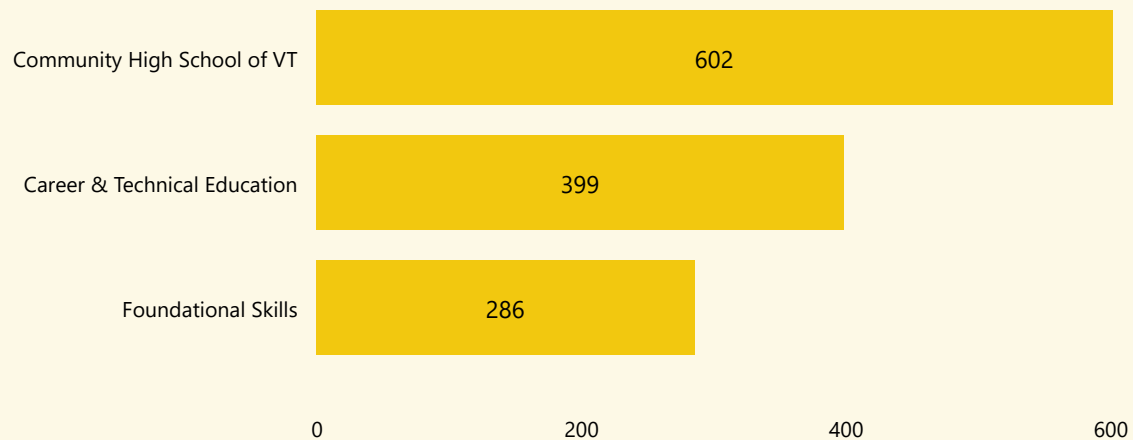

Figure 16: FY22 Course Registrations



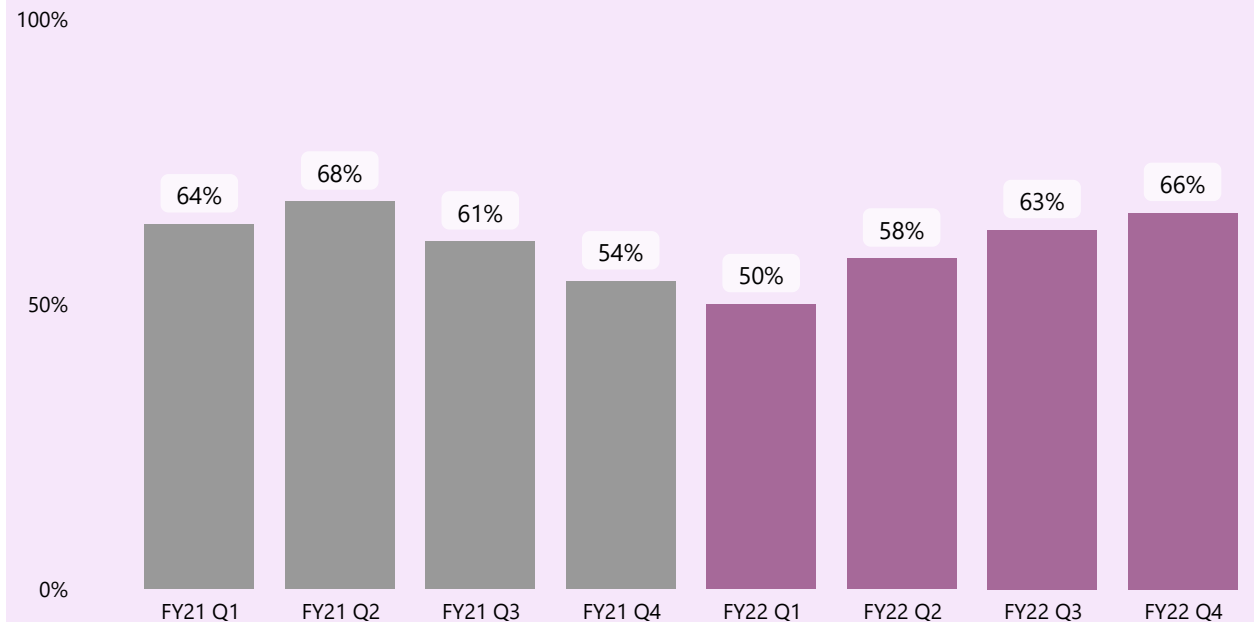

Figure 17: FY21 & FY22 Transitional Housing Quarterly Bed Utilization



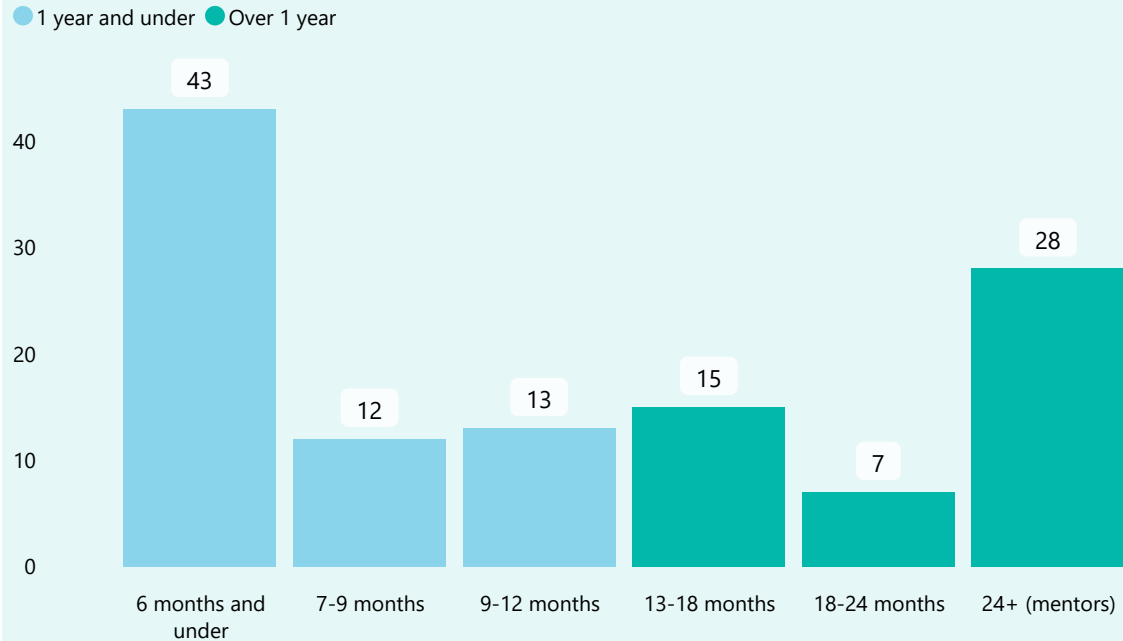

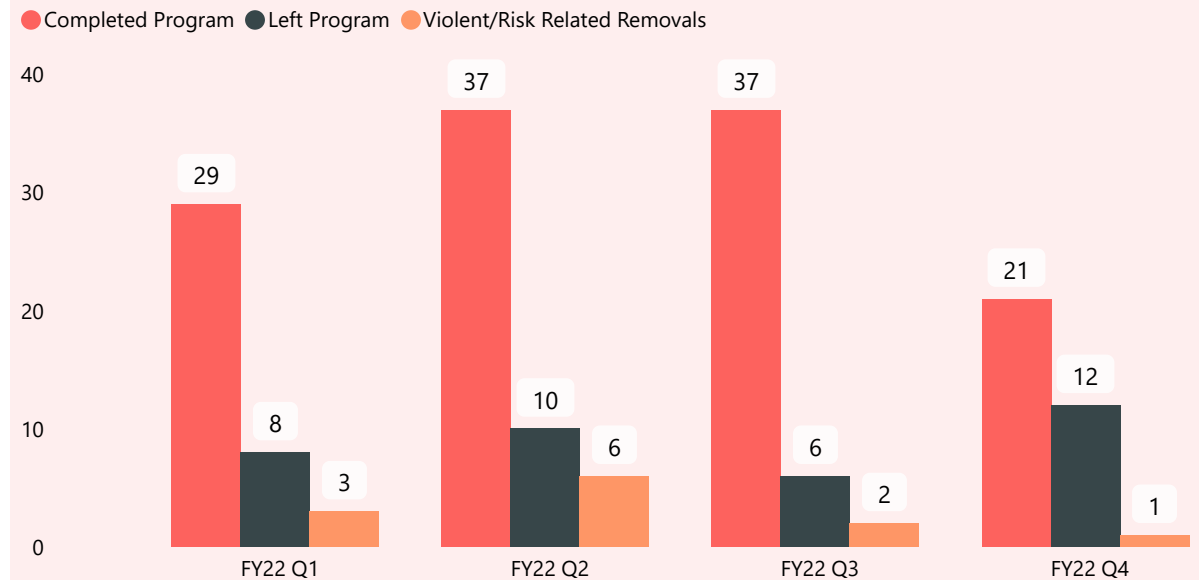

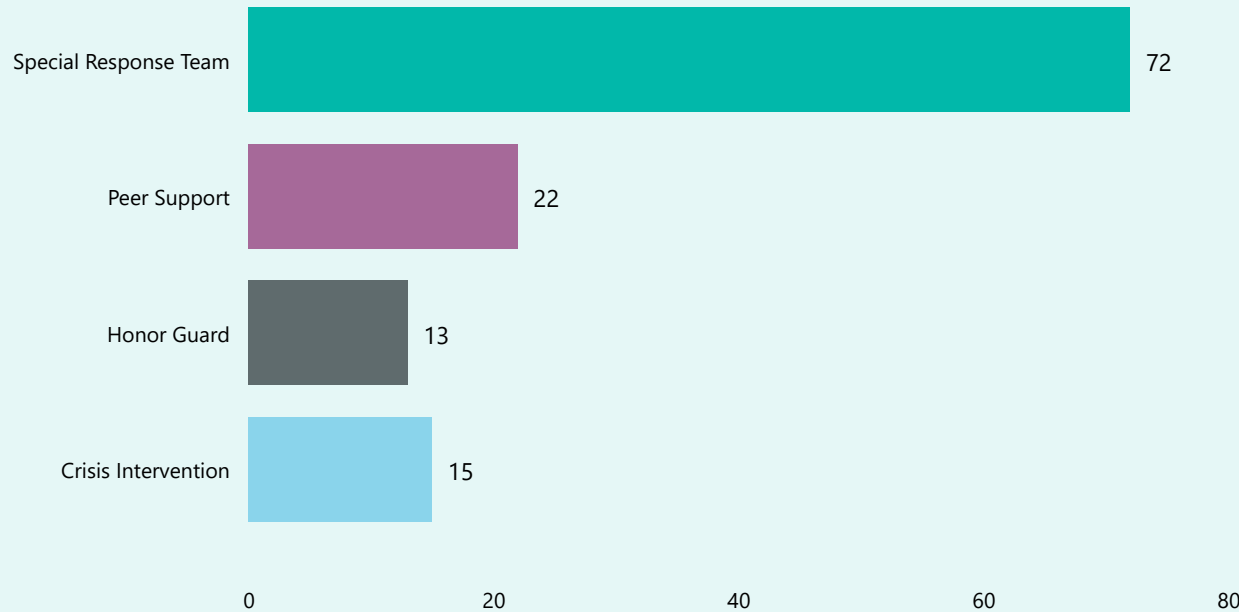

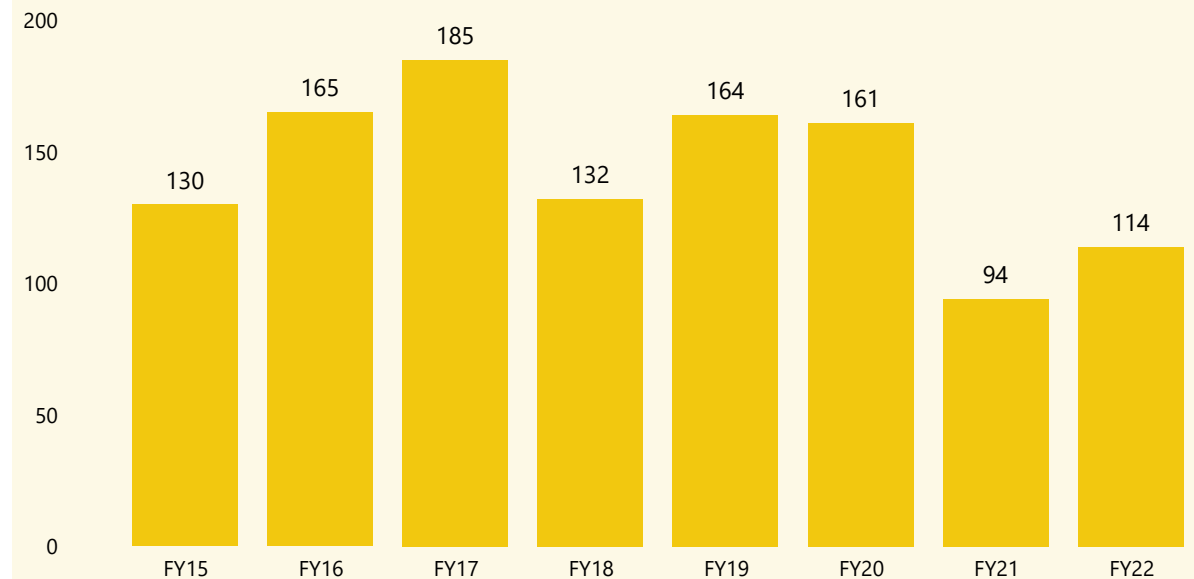

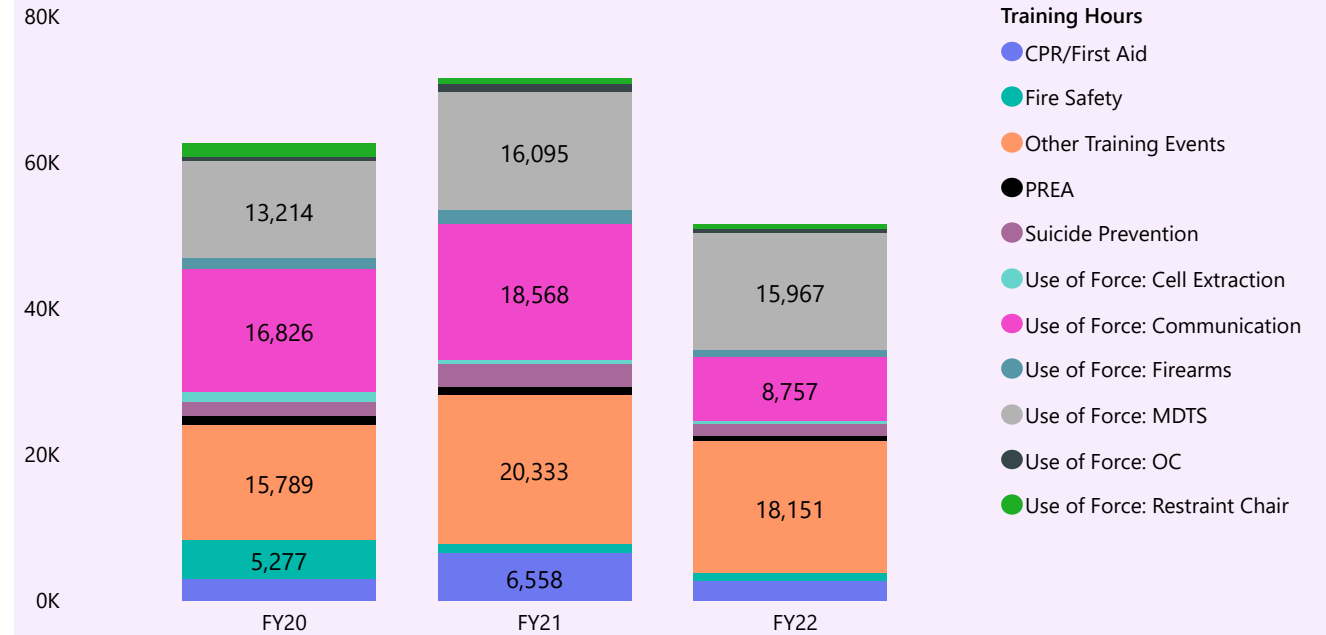

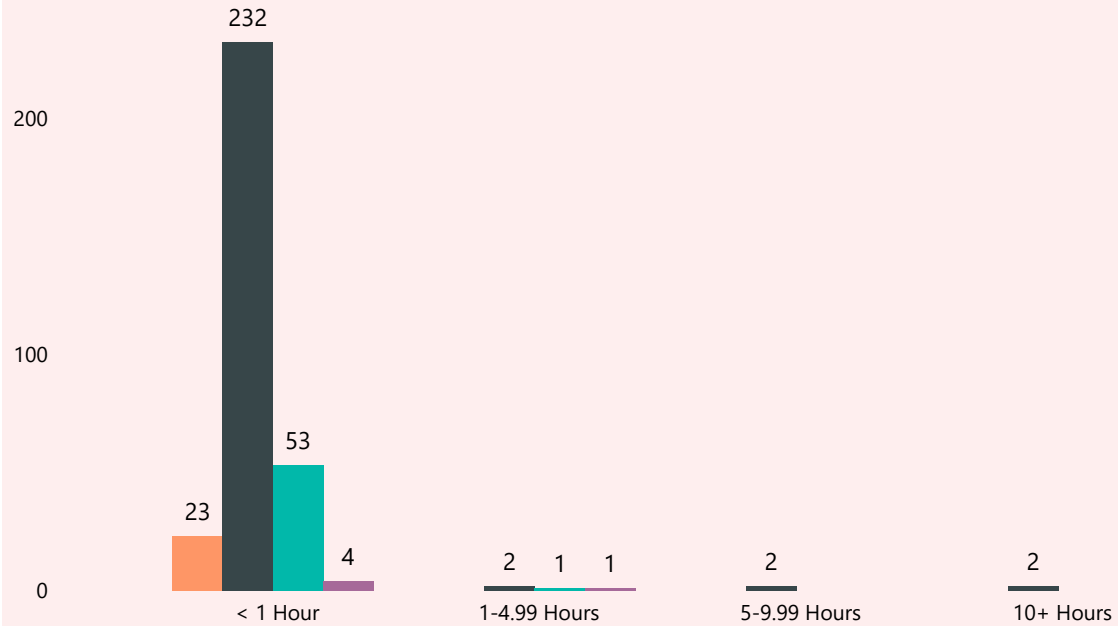

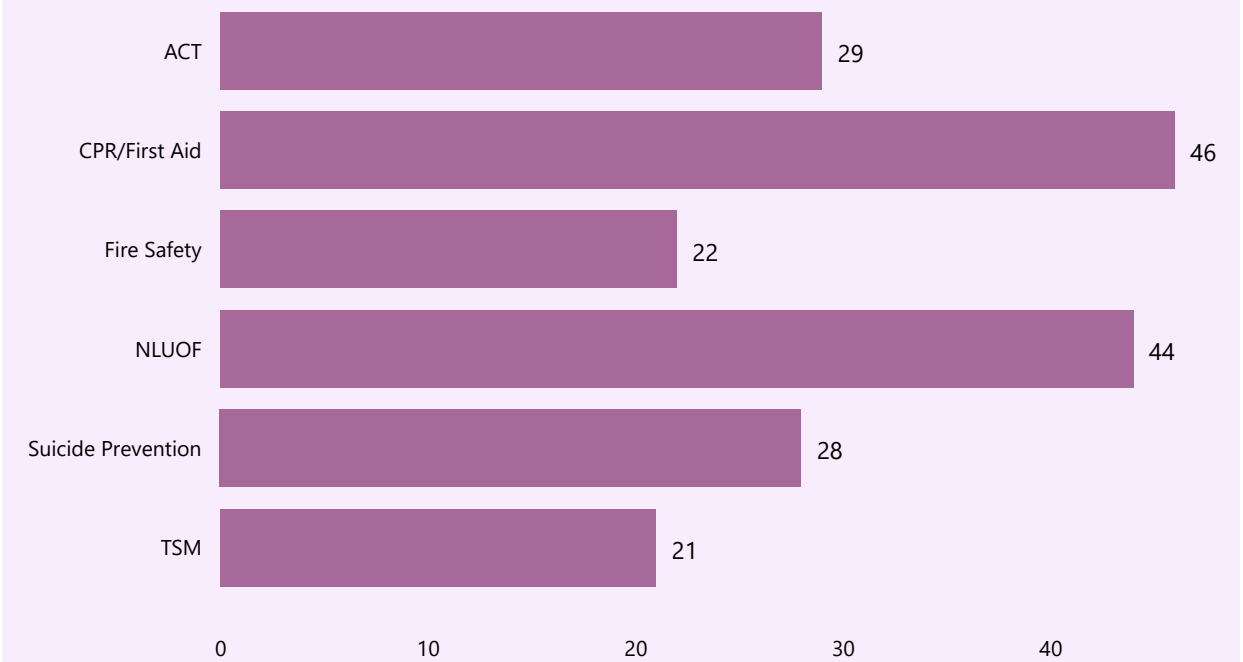
