GMCB Regulation - Scope

 GMCB regulatory decisions impact areas the GMCB does not directly regulate

Financial Scope

- \$3.3B in system wide hospital net patient revenue* (FY23)
- ~\$700M in health insurance premiums (FY23)
- \$49.3M in approved CON applications
- Over \$1B in Total Cost of Care managed by ACOs (FY22)



Vermont State APCD by Onpoint Health Data




Health Resource Allocation Plan
