FY24 ANR Budget Overview

- Governor's FY24 Recommend: \$230.1 million
 - Increase of \$42.5 million (22.64%) above FY23, driven largely by federal Bipartisan Infrastructure Law (BIL) funds
 - Since FY22 ANR has been appropriated over \$160M in ARPA funds which is not reflected in the FY24 budget
- Budget supports 650 full-time employees and ~400 seasonal workers
 - Includes more than 50 limited-service positions to support implementation of BIL and ARPA funds
- Roughly 2/3s of the FY24 budget will be passed thru to municipalities, contractors, and partner organizations




FY24 ANR Budget Overview

- More than 80% (\$193.9 million) of ANR's FY24 budget is special and federal funds
 - Budget fully utilizes projected revenue from special and federal funds, but these sources have not fully kept pace with inflation and growth in expenses
- About 4.5% (\$1.9 million) of the proposed increase in ANR's FY24 budget is General Fund
 - This represents a 5.6% increase in the Agency's GF allocation
 - Funds significant portion of Pay Act and ISF increases

FY24 ANR Budget Key Changes

- Forestry reclassification:
 - Modernize position structure to better respond to ongoing and prepare for the increased staffing demands and emerging needs already impacting the division
- Climate Office "true-up":
 - Adjusts base funding for the Climate Action Office (CAO) that was created with the FY23 budget to meet staffing needs
- Civil Rights and Environmental Justice Unit:
 - Act 154 (S.148) created significant, on-going environmental justice (EJ) responsibilities for the Agency
 - Funding is currently limited to one-time monies



FY24 One-Time Investments

- ANR SO
 - \$900K Climate Action Office Technical Analyses, Tools and Training
 - \$5M to build-on congressionally-directed spending for Clean Heat Homes
 - \$700K to expand VEIC's refrigerant management program and reduce GHGs
 - \$300K to extend Environmental Justice positions
- FWD
 - \$150K to make statutorily-required wildlife crop damage payment
- FPR
 - \$500K to make improvements to Parks staff housing
 - \$1M to provide non-federal outdoor recreation grant match for small communities
 - \$500K for EAB hazard tree removal/Low-Income Heating Fuel Assistance
- DEC
 - \$10M to continue ARPA-funded Healthy Homes Initiative
 - \$2.5M for Brownfields assessments (companion with ACCD funding)
 - \$10M for PFAS remediation needs following private well testing
 - \$1M for vehicle emissions repairs for low-income Vermonters



Capital Bill One-Time GF to Cash Fund Investments

• FPR

 \$3M Replacement Park Maintenance Facilities at Gifford Woods (Killington) and Groton (line 95)

• DEC

- \$27M State match to supplemental federal EPA CW & DW SRF capitalization grants (line 100)
- \$4.5M Waterbury Dam Rehabilitation (line 102)
- \$10M Municipal Pollution Control Grants (line 117)

• FWD

 \$1M Infrastructure Maintenance/Improvement of Fish and Wildlife Buildings including Conservation Camps (line 106)



FY24 ANR Budget – Position Changes

- Since the start of FY22, the Agency sought and received approval to hire just over 50 limited-service positions to support deployment of federal funding under ARPA and IIJA
- The Agency's SFY24 budget establishes four additional IIJA-funded limited-service positions in FPR along with one limited-service position supported by the clean water fund.

Significant and On-going Initiatives

- Successful deployment of ARPA and IIJA funds
- Undertaking PFAS monitoring and response work to ensure Vermonters are protected from the potential effects of PFAS on human health
- Completing PCB testing and remediation in Vermont schools
- On-going implementation of Act 64 (2015) Vermont's Clean Water Act – and Act 76 (2019) related to establishing Clean Water Service Providers
- Expanding Vermont's outdoor recreation offerings, including investments in fishing access areas, wildlife management areas, state parks and forests, and investing in local community recreational assets

FY24 ANR SO Budget Key Changes

- Climate Office True-Up:
 - Right size the Climate Action Office (CAO) that was created with the FY23 budget
- Civil Rights and Environmental Justice Unit:
 - Act 154 (S.148) established an environmental justice (EJ) policy for the State of Vermont which creates significant, new EJ-related responsibilities for the Agency.



One-Time ANR SO Investments

- Climate Action Office Technical Analyses, Tools and Training:
 - \$900,000 for investments in on-going evaluation, implementation support and tracking the impact of programs and policy approaches needed to reduce greenhouse gas emissions and improve landscape-level resilience consistent with the Global Warming Solutions Act.

Clean Heat Homes:

 \$5,000,000 to augment federal funding for a single-point program to help low- and moderate-income Vermonters with "whole home" climate improvements – weatherization, clean heat systems, and electrification ready upgrades – supported by on-bill financing.



One-Time ANR SO Investments

- Refrigerant Management:
 - \$700,000 for incentives to improve commercial and industrial refrigeration systems, focused on reducing the use of highglobal warming potential (GWP) refrigerants and/or replacing, outright, older systems prone to leaks.
- Environmental Justice Positions:
 - \$300,000 for one additional year of funding for the following positions: (1) one fulltime Civil Rights Compliance Director; and (2) two fulltime positions to assist in the implementation of the Environmental Justice State Policy and support the Environmental Justice Advisory Council.
